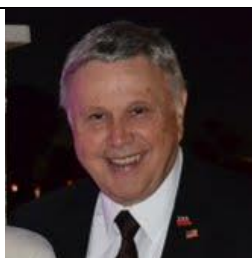

More than 150 members of the Republican Liberty Caucus – most of them from Florida, but also attendees from other states across the nation, gathered in Orlando the weekend of June 26-27 for their biennial national convention, where **Chairman Matt**

Nye was re-elected for another two-year term.

Nye, a telecommunications executive and political activist in Brevard County, Florida, easily defeated a challenger for the position, and said he was excited to continue serving the organization. He first got involved with the RLC – which was founded in 1991 as the Libertarian wing of the Republican Party – 14 years ago, when he founded and chaired the local chapter in Brevard County.



John Dennis of California and **Jeff Larson** of Texas were re-elected by acclamation as Vice Chairman and Secretary, respectively. A three-way race for Treasurer was won by **Ben Beckhart** of Arizona. The three At-large Director positions were won by **Crystal Hamlin** of Florida, **Robert Sutton** of Florida, and **Michelle Graham** of South Carolina.

The Florida delegation, which sponsored the convention, held its own election caucus, where **Chairman Bob White** was re-elected by acclamation, and **Karyn Morton** easily defeated a challenger for the Vice Chair position. The delegates re-elected **Secretary Travis Richardson** and elected **Tracy Venerable** as Treasurer, both by acclamation. **John Weiler, Ted Noftall, and Celeste Ellich** won a six-way race for three At-large Director positions.

Numerous speakers were on the program to address the convention attendees.

Leading off, **Tina Descovich**, a former member of the Brevard School Board and a co-founder of the parents organization "Moms For Liberty," said it is growing by leaps and bounds since it began earlier this year. It started in just a couple of Florida counties, she said, and there are now more than 20,000 members in 19 states. The group is fighting against mandatory masks for children, the Critical Race Theory, and other attempts to indoctrinate our children. Descovich said, "We all need to get involved at the local level, read and study the Constitution, and teach it to our children and grandchildren."

Florida State Legislator Anthony Sabatini urged the attendees to stop the "pat on the back" policy and hold people accountable for their actions in Congress and the state legislatures. Noting that many Republican politicians are RINO's, he said, "We need to primary every single member who voted for bailouts and subsidized bailouts." RINOs, Sabatini added, "are not here to serve you. Don't be afraid to do the right thing."

Heather Wagenhals, an author, tv host and finance expert speaking on how to use persuasion in dealing with the opposition, said communication is the key, and don't tell them what to believe, use their own words to help them see the correct results. In this way, she said, you can turn critics into converts.

During a session on Growing Liberty, FL Chairman White said there are now more than 650 paid members in 23 chapters in 26 counties. Listing just a few of the State Chapter's programs, he mentioned the Liberty Lobby Days with the State Legislature that occurred in the pre-coronavirus days, the Second Amendment Gun Rights Preservation Tour throughout Florida, and the creation of the Oath Breakers Hall of Shame Induction for legislators who fail to follow the Constitution in their votes.

National Treasurer Beckhart said his four steps to success are to 1) utilize social media effectively; 2) build relations with liberty-friendly legislators; 3) register as a lobby organization in order to use the legislative website; and 4) create a legislative voting scorecard.

National Secretary Larson said it was important to create strategic partnerships in Texas because it is such a large state that deals with 3-4,000 bills every six-month session. One example, he said, was an alliance with the Gun Owners of America to get Constitutional Carry passed. He also suggested talking to Democrats, because "sometimes you find allies in strange places."

Kim Klasik, the founder of the Red Renaissance PAC supporting conservative Republican political candidates across the country, said she is going to "help flip the House of Representatives in 2022." A pro-Trump American Firster, Klasik was an unsuccessful – but highly recognizable – candidate for a 2020 congressional seat in Maryland, campaigning by walking the slum area streets of Baltimore in a bright red dress. Hence the term "Red" in her PAC—which stands for freedom of speech, revitalization of urban areas, economic empowerment, family planning, funding our police, and women and minority leadership. "Every area of the country must be fought for," she said. "We have to keep pushing forward. We the People are stronger than the establishment."

Klasik also participated in a panel discussion on Minority Engagement, in which she said a lot of Black Americans don't even realize that they are conservative, and they "need to get the message." It starts, she added, with school choice.

Santiago Avila, Jr., the State Chair at the Republican National Hispanic Assembly of Florida, said that immigration to America should be legal, and that Hispanic immigrants should be taught

in both Spanish and English that “America is a Republic, and not a Democracy.”

Florida Congressman Byron Donalds said that eye contact is important in building political relationships, which are “a lot like a romantic one.” He added that Blacks do not want to be just listened to, “they want to be heard.” Blacks and Whites, men and women, Donalds said, are standing up for liberty. “We are a blessed nation, and more and more people are realizing this,” he added.

At the convention’s installation of officers and awards banquet, a video of **Kentucky Senator Rand Paul** was shown, in which he said we want a constitutional government that “leaves us alone,” and he urged the attendees to “keep fighting for the principles of liberty.”

A Jefferson Cup – symbolizing the Republican Liberty Caucus’ dedication to Thomas Jefferson’s principles of limited government, lower taxes, free and fair markets, personal freedoms and responsibilities, as well as allegiance to the Constitution – was presented to the evening’s main speaker – **Kentucky Congressman Thomas Massie**.

In remarks that were half humorous and half serious, Massie criticized the Floridians in the audience for “taking **Florida Governor Ron DeSantis** away from me.” He said he came to the convention “to rebuild my battery,” and now, 30 years later from MIT, he is in “virtual reality dealing with artificial intelligence.”

Massie said members of the House should “never vote for a bill numbered less than 10,” because these are the ones pushed by the leadership. For example, the current HR-1 is Speaker Pelosi’s pet project to change the way voting is carried out in the country.

Whenever a bill is introduced, he said, his questions are: “Is it Constitutional? Can we afford it? And Is this the role of the Federal Government?”

A 5-time Congressman, Massie said the only endorsement he ever received was from the Republican Liberty Caucus. When it came to creating a diversified staff for his office, he said it was filled with “one-half Ron Paul people and one-half Rand Paul people.”

At a candidates’ breakfast the next morning, Florida Chairman White explained that unlike other organizations, RLC does endorse primary election candidates, choosing the best constitutionalists.

Political Consultant **Rob Feltner**, a candidate for a Brevard County Commission seat, said it is critical to get signatures early, talk even to NPAs, and commit to outwork your opponents.

Cape Canaveral City Council member **Wes Morrison** said there are three Ds: Doors (to knock on), Days (to campaign), and Dollars (to advertise).

State Representative Sabatini said candidates should start early with their message of values and principles.

Vice Chair Dennis said it is critical to put a team together, including door knocking.

At the RLC-Florida caucus, which closed the conference, a second Jefferson Cup was presented – this one to **Andy Dubois**, publisher of the official newsletter “The Liberty Letter.”

SECOND CPAC2021 GATHERING IN TEXAS DRAWS ENTHUSIASTIC CROWDS

Following up on the CPAC2021 event in Orlando this past February, the American Conservative Union did it again – drawing several thousand Conservative activists in Dallas July 9-11, to listen to – and applaud – dozens of speakers on the need to return control of the government in Washington to Conservative Republicans.

President Donald Trump, Florida Senator Rick Scott and **South Dakota Governor Kristi Noem** were only a few of the speakers, and their remarks were similar to what they said in Orlando.



Attendees who participated in CPAC’s traditional straw poll gave an approval rating of 0 – that’s zero – to the Biden Administration, and a rating of 98 percent approval to President Trump’s administration. Looking ahead to the 2024 presidential election, 70 percent of the attendees voting preferred President Trump to run again, **Florida Governor Ron DeSantis** had 21 percent, and no other name on the list went over 1 percent. If Trump were not on the ballot, then in a second poll, DeSantis received 68 percent of the votes cast, former **Secretary of State Mike Pompeo** had 5 percent, **Donald Trump, Jr.** had 4 percent, and no other names received more than 1 percent.

The main take-away from the weekend conference was that Trump remains strong among the Republican base, Once again, he was the star of the show, closing the event with a 90-minute speech in which he said he will use his influence to play the role of Republican kingmaker, doling out endorsements for candidates and campaigning across the country heading into the 2022 midterms, including in some instances against incumbent Republicans he views as insufficiently loyal to him and his agenda. Trump told the audience, including millions watching at home on TV, about a poll that “showed that at least 10 percent of Joe Biden’s voters would have switched their vote if they had known about Joe and Hunter Biden’s scandals.” That poll – commissioned by the Media Research Center just a few days after the 2020 election – surveyed 1,750 Biden voters from key

swing states and found 45 percent of them said they were not aware of the evidence linking Joe Biden to corrupt financial dealings with China through his son Hunter. That information was available on conservative news sites, but it was ignored by the mainstream media.

Noting that the border crisis is helping drive “an unprecedented crime wave,” Trump said the “bloodshed and violence” in Democrat-led cities is reaching epidemic proportions.

Concerning the situation in Afghanistan, he said Biden is turning it into a total disaster. “He is leaving behind billions and billions of dollars of equipment,” Trump said, and “the Taliban is now parading around with our weapons – it is a disgrace.”

Discussing China, Trump said, “We will hold them accountable for the damage and suffering they have caused and make them pay trillions of dollars in reparations to us and to the world.”

He also said that “we will completely defund and bar critical race theory – 1776, not 1619. If government schools are going to teach children to hate their country, we will demand school choice.

He continued his claim that the 2020 election was “stolen” from him, and said, “This must never happen to another party’s presidential candidate again, it can never happen. We are a laughingstock all over the world, a laughingstock.” Taking aim at media outlets that said he has not presented evidence of fraud, Trump said, “No evidence? No evidence? There’s so much evidence.”

Attendees chanted “Four more years. Four more years,” but Trump declined to actually say he would run again.

Looking ahead to 2022, Scott said, “We have amazing grassroots movement, and we need to keep up the momentum to do our part and take back the Senate.” He said the Biden administration is “directly responsible” for problems we have at the Southern border, and “we are going to fight for a secure border.”

Noem, who is a potential presidential contender in 2024, spoke about other states’ restrictions during the coronavirus pandemic. Taking aim at other Republican governors for putting “overly harsh measures” in place, she said, “We need leaders with grit – that their first instinct is the right instinct.”

We had the opportunity to discuss Critical Race Theory, the crisis at our southern border, how to combat the Left’s rising anti-Semitism, and the future of the conservative movement. These are incredibly important topics, and we have a responsibility to hold our local, state, and federal elected officials accountable as we tackle these issues as a nation.”

AUDACITY AND IDIOCY

--President Joe Biden, for declaring in a speech in Philadelphia that America is "facing the most significant test of our democracy since the Civil War" by requiring voters to present "racist and discriminatory" photo IDs.

--Democrat Socialist Congresswoman Alexandria Ocasio-Cortez, for parroting Black Lives Matter in blaming the legacy of the 60-year-old U.S. embargo placed on the Cuban dictatorship plus the additional Trump-era restrictions, for "contributing" to the suffering of the Cuban people.

--Transgender athlete Chelsea Wolfe, a BMX freestyle rider who qualified as an alternate to represent the United States at this year's Summer Olympics, for posting on Facebook that the goal is "to win the Olympics so I can burn a U.S. flag on the podium." Hopefully, JUST an alternate.

--Officials at Great Britain's National Health Service public hospitals, for bowing to Woke culture and following a new "gender-inclusive language policy. Absurdly, in the department for "perinatal services", "birthing parents" now will provide their new babies with "chestmilk" or "human milk." Additionally, the word "woman" is to be replaced with the phrase "woman or person."

--The owners of the woke Minneapolis restaurant Broder's Pasta Bar, for creating a "Benefits & Equity" charge of 15 percent added to all patrons' checks, claiming that "Industry studies have found gender bias in tipping and that Black or Brown servers receive less tip income than their White counterparts." According to Broders, "the funds accumulated from this new racism tax will be redirected toward paying employees' wages, paid time off, insurance and various employee assistance programs."

--Freelance journalist and activist Lauren Rowello, for outrageously writing in the "Washington Post" that children should be exposed to the kinky side of homosexual culture because "Kink embodies the freedom that Pride stands for," and "helps our children to love themselves and others with courage and resilience."

--The snarky educators running the Columbus Academy, an exclusive private school in Ohio, for expelling three students for the “simple reason” that their mothers had campaigned against the school teaching the Critical Race Theory curriculum. The school said the parents’ actions “caused pain, and even fear for physical safety, among students, families, faculty and staff.” But the mothers said the school refused to even have a dialogue with them, and the “educational institution” was punishing children for their “asking questions.”

--Principal Bodie Brizendine of the pricey Spence School in New York City, for his tepid apology to furious parents who learned that their eighth grade students were shown a “satirical” video deriding, humiliating, and ridiculing white women, and was “blatantly racist.” Brizendine said the school was “sorry for the incident and did not condone it,” but did not indicate that any action would be taken against the teacher. Some parents threatened to pull their children from the school.

--Many of the world’s billionaires, who traveled on their own private jets to Sun Valley, Idaho, and whose massive number of flights caused enough airspace congestion to force the Federal Aviation Administration to temporarily ban all other plane traffic on the West Coast, including commercial flights. Ironically, the billionaires went to Idaho to discuss “climate change.”

--Nearly two dozen geology academics, spearheaded by Professor Hendratta Ali at Fort Hayes State University, for absurdly claiming that the study of geology is “racist” because “Black people are afraid if they use hammers – basic geological tools – they will be killed.” These idiotic scientists apparently do not realize that carpenters and construction workers safely use hammers, and that Blacks are in many professions where they hold objects – police with guns, chefs with knives, etc.

THIS AND THAT



U.S. SUPREME COURT. Among the rulings from the U.S. Supreme Court this month prior to the Justices adjourning for the summer were: 1) A 5-4 decision that the developers of the \$1 billion PennEast natural gas pipeline can take New Jersey land to build its 116-mile pipeline to transport as much as 1 billion cubic feet of natural gas per day from northern Pennsylvania to New Jersey, a boon to the East Coast; 2) A 6-3 decision that a California law requiring the disclosure of donor names is unconstitutional, in support of the non-profit Citizen Power Initiatives for China (CPIC0, which is dedicated to advancing a peaceful transition to democracy in China, and whose donor privacy is quite literally a matter of life or death; 2) A 6-3 decision that upheld Arizona’s voting law that cracks down

on ballot harvesting and takes aim at mail-in ballot fraud, despite a challenge from the Democratic National Committee (DNC), and it was called a win for election integrity in Arizona and nationwide; 4) A 9-0 decision that unanimously reversed a Ninth Circuit court opinion concerning the credibility of non-citizens’ testimony in immigration disputes; 5) A 9-0 decision that a tribal police officer does have the authority to detain temporarily and search a non-Native American traveling on a public right-of-way running through a reservation; 6) A 9-0 ruling that Philadelphia cannot exclude a Catholic services organization from providing adoption services because its religious beliefs bar it from arranging adoptions for same-sex couples; and 7) A 7-2 ruling rejecting an attempt by 18 states to get rid of Obamacare, saying they “lack standing” to sue because they suffered no direct harm.



Lance Thate, the long-time chairman of the St. Augustine Tea Party (SATP), announced last month that he would not be seeking another term in office, but that he still would be editing the popular “Town Crier” newsletter. Stating that he felt it was time for a younger person to head the group of patriots, Thate said, “This old soldier will not just fade away like some old soldiers, there’s a war to fight and I’m still in it.” On July 13, the SATP elected by acclamation a new slate of officers: **Shawn Morrison** as chairman and **Sophia Morrison** as recording secretary, and **David Heimbold** was re-elected as treasurer. When the Texas-based organization Christians Engaged routinely applied for tax-exempt status with the Federal Government, the IRS Exempt Organizations Division chief denied the application, claiming the group "engage[s] in prohibited political campaign intervention" and that it "operate[s] for a substantial non-exempt private purpose and for the private interests of the [Republican] party." But after several members of Congress instructed the Treasury Department’s Inspector General to look into the matter, the Texas-based First Liberty Institute, which worked on behalf of Christians Engaged, said the IRS had reversed itself and granted tax-exempt status to the group, which has as its goal to educate and empower Christians "to pray for our nation and elected officials, vote, and be civically engaged." First Liberty attorney Lea Patterson called the move “truly great news for our client, as well as religious organizations and churches across America.” For more information, visit the website: www.firstliberty.org.



The California-based Pacific Justice Institute, a conservative legal defense organization, is representing two educators in Grants Pass, Oregon, who were fired for opposing transgender advocacies in schools. North Middle School assistant principal Rachel Damiano and science teacher Katie

Medart were dismissed on a 4-3 vote of the School Board, even though they had developed, with the knowledge and approval of school officials, a grassroots organization called "I Resolve" to address education policies on gender-identity disputes, and to offer solutions that would let teachers continue teaching without violating their consciences and honoring parental rights. They suggested allowing staff and students to abide by their consciences and refrain from using preferred pronouns for students whose anatomic sex does not match the students' pronoun of choice, requiring parent involvement to change students' pronouns, and that restrooms be restricted to those who anatomically fit the definition of male or female. The two teachers even consulted with school officials in preparing their proposal, and the superintendent even indicated he would bring it up to the board members. But when they created a video to promote their ideas, they were put on leave "pending an investigation," and were told that five other school workers had complained that their Christian beliefs were "anti-transgender" and therefore unacceptable. The Arizona-based conservative Christian nonprofit advocacy group Alliance Defending Freedom is suing the Loudon County, Virginia, School Board on behalf of elementary school teacher Tanner Cross, who was

suspended from job after participating in the public comment section of a school board meeting. He had voiced his Biblically-founded conviction that there are only two sexes, male and female, and that people cannot change from one gender to the other. He was addressing a proposed school policy that would compel teachers to address "gender-expansive or transgender students" with their chosen pronouns. Less than 48 hours after sharing his opinions and speaking out for the well-being of his students, Cross was suspended from his job by the "woke" school board for exercising his Constitutional freedoms of speech and religion. The lawsuit followed the board's denial of ADF's request for his reinstatement. The website is: www.adflegal.org.

IRONY DEFINED. Just days after the Oakland, California, City Council voted to reallocate \$18 million of police funding to community violence prevention programs, a news crew interviewing the city's woke "violence prevention" chief on the steps of City Hall was attacked by a pair of armed robbers intent on stealing their camera equipment. A scuffle ensued, but a City Hall security officer thwarted the attempted robbery by brandishing a firearm and drove the would-be burglars away. The city now intends to use the bulk of the police funding to its Department of Violence Prevention, a group that reportedly aims

to counter violence in the city by sending out "civilian violence interrupters and life coaches."

NEW MILLENNIUM CONSERVATIVE CLUB. Attendees of the July 19 meeting of the New Millennium Conservative Club in Suntree viewed the film "1986 The Act," which takes parents-to-be "down the rabbit hole to learn the truth behind the corruption, lies, deceit, and premeditated harm" that lead up to the policy – still in effect today – that forces children to take 72 vaccine shots by the age of 18. In 1986, pharmaceutical companies extorted the U.S. Congress – and sadly, President Ronald Reagan – to grant them immunity from lawsuits resulting from health issues such as autism, that resulted from injections not properly tested for safety. Vaccines that are currently being rushed-to-market for COVID-19 – and being mandated for college students and pressured for those at grade school levels -- require even less rigorous testing of their capacity to cause harm.... At the club's June 21 meeting,



Florida State Senator Debbie Mayfield, the Senate Majority Leader, told the members that the recent State Legislative Session was fortunate to have **Florida Governor Ron DeSantis**, **Senate President Willard Simpson**, and **House Speaker Chris Sprowls** "united in their message, which allowed us to be very successful." The session proved to be unique, she said, due to coronavirus restrictions that resulted in many unique challenges with the building being empty while forcing meetings to take place by Zoom. Discussing the budget, Mayfield said that while the economic impact of the virus on Florida was predicted to be "a multi-billion dollar shortfall," the legislature passed a \$101.5 billion budget for the upcoming fiscal year (DeSantis line-item vetoed \$1.5 billion of it) while preserving \$9.5 billion in reserves. She also noted that the budget "makes strategic use of the Federal Coronavirus State Fiscal Recovery Fund by directing nonrecurring funds toward key infrastructural priorities that will create jobs and further support Florida's booming economy."

Mentioning just a few of the bills passed by the Legislature, Mayfield said Senate Bill 7072 will prevent Social Media platforms from willfully restricting free speech; House Bill 1 will protect the principles of law and order; Senate Bill 90 will ensure protection for election ballot drop boxes; and she said the "Fairness in Women's Sports Act" was passed "to ensure that women can compete and demonstrate their skill on an equal playing field, separating biological males and females in athletic competitions." Mayfield added that the legislature also passed a bill to regulate the collection of online sales taxes and created a new revenue-sharing gaming compact with the Seminole Tribe. Noting that the Legislature's 2021 session was impacted by the coronavirus, Mayfield said the building was shut down to visitors, the staff and members were tested weekly, and all meetings took place via Zoom. While Senate elections normally are for a four-year term, she said, because of the ten year-census and re-districting, all Senators will be up for re-election in 2022. Mayfield added that the 60-day legislative session next year will begin in January...Following her visit to the New Millennium Conservative Club – with a late rash of signings taking place –

Mayfield reported that DeSantis signed into law 267 of the 275 bills that passed both the House and Senate this term.



SPACE COAST CHAPTER. Two of America's Frontline Doctors – **Jana Schmidt** and **Sal Martingano** – met with members of the Space Coast Chapter of Act! For America in Viera on July 7, to discuss “Making Sense of Covid Injections and the Future.” Their presentation began

by noting the damaging effects Covid can have on the body, but also cited the worst case statistics on survivability. Donald Trump, the 45th President of the United States, writing on his law suit against Big Tech corporations, at “The Wall Street Journal”:

“One of the gravest threats to our democracy today is a powerful group of Big Tech corporations that have teamed up with government to censor the free speech of the American

people. This is not only wrong – it is unconstitutional. To restore free speech for myself and for every American, I am suing Big Tech to stop it. Social media has become as central to free speech as town meeting halls, newspapers and television networks were in prior generations. The internet is the new public square. In recent years, however, Big Tech platforms have become increasingly brazen and shameless in censoring and discriminating against ideas, information and people on social media -- banning users, deplatforming organizations, and aggressively blocking the free flow of information on which our democracy depends. No longer are Big Tech giants simply removing specific threats of violence. They are manipulating and controlling the political debate itself. Consider content that was censored in the past year. Big Tech companies banned users from their platforms for publishing evidence that showed the coronavirus emerged from a Chinese lab, which even the corporate media now admits may be true. In the middle of a pandemic, Big Tech censored physicians from discussing potential treatments such as hydroxychloroquine, which studies have now shown does work to relieve symptoms of Covid-19. In the weeks before a presidential election, the platforms banned the New York Post – America's oldest newspaper – for publishing a

story critical of Joe Biden's family, a story the Biden campaign did not even dispute. Perhaps most egregious, in the weeks after the election, Big Tech blocked the social-media accounts of the sitting president. If they can do it to me, they can do it to you – and believe me, they are.... Meanwhile, Chinese propagandists and the Iranian dictator spew threats and hateful lies on these platforms with impunity. This flagrant attack on free speech is doing terrible damage to our country. That is why in conjunction with the America First Policy Institute, I filed class-action lawsuits to force Big Tech to stop censoring the American people. The suits seek damages to deter such behavior in the future and injunctions restoring my accounts. Our lawsuits argue that Big Tech companies are being used to impose illegal and unconstitutional government censorship. In 1996 Congress sought to promote the growth of the internet by extending liability protections to internet platforms, recognizing that they were exactly that – platforms, not publishers. Unlike publishers, companies such as Facebook and Twitter can't be held legally liable for the content posted to their sites. Without this immunity, social media companies could not exist. Democrats in Congress are exploiting this leverage to coerce platforms into censoring their political opponents.... Further, Big Tech and government agencies are actively coordinating to remove content from the platforms according to the guidance of agencies such as the Centers for Disease Control and Prevention. Big Tech and traditional media entities formed the Trusted News Initiative, which essentially takes instructions from the CDC about what information they need to ‘combat.’ The tech companies are doing the government's bidding, colluding to censor unapproved ideas. This coercion and coordination is unconstitutional.... Through these lawsuits, I intend to restore free speech for all Americans – Democrats, Republicans and independents. I will never stop fighting to defend the constitutional rights and sacred liberties of the American people.”

“Too many people in Washington forget who sent them there. They forget who they represent. I have always believed that my work in Congress is first and foremost about serving the public – not just any public, but the folks who call the Space and Treasure coasts home. While there are a few good folks serving in Congress, I am very concerned about a culture that revolves around influence peddling and personal gain. I have introduced a half dozen bills making Congress more accountable and transparent – I call it my Anti-Swamp agenda. These bills are in committee now and we are working to build support. It's commonsense things like: Requiring Members of Congress to publicly disclose foreign business ties, and a related bill that requires them to disclose any close relationships their family members may have with foreign entities. This type of transparency is missing but it is sorely needed to ensure that the folks back home know if their Congressman has any conflicts of interest that may be clouding their judgement. Expanding from

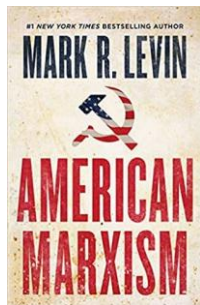
two-years to five-years, the moratorium on former Members of Congress lobbying Congress. We also have a bill banning former Members of Congress and senior staff from cashing in on their public service by becoming lobbyists for foreign countries and state-owned enterprises (i.e., many Chinese companies). My legislation to cut off government pensions for former Members of Congress and senior staff will discourage this.... You may recall right before Obamacare passed – back before I came to Congress – when Speaker Pelosi was asked what was in the bill, she said Congress would have to pass it before they could find out what was in it. That is just fundamentally wrong in so many ways.... One of my first initiatives in Congress was to make sure no one did that again – Democrats or Republicans – so I introduced a House rule change to require a bill to be available to Congress and the public for at least 72 hours. That is now a House rule. Sadly, it has been waived a few times, but another of my bills to bring transparency and accountability to Congress was approved as a new House Rule in 2015, which requires legislation to use clear markings to show changes in the text. This enables Congress and the public to quickly see any recent changes in legislation. I was told once by a senior Member of Congress that if Congress did that, then the public would be able to see what Congress was up to. He seemed a bit disappointed that this was my purpose in introducing the bill, and it is that attitude that Washington needs to be purged of. We are here to do the people’s business and we know that transparency and sunshine is the greatest disinfectant. When you have transparency, you have accountability. The highest calling of Members of Congress should be to uphold the constitution and represent those in their home districts. What my accountability bills do is try to remove ulterior motives that cloud the judgment of some Members of Congress – on both sides of the aisle. By removing these conflicts and exposing them, along with giving the American people greater insight into the legislative process the American people are better able to hold their Member of Congress and other Members of Congress accountable for the decisions they make and the votes they cast.”

“Critical Race Theory (CRT) is likely to stay until conservatives create a backlash in the form of a new competing study that I propose here. Conservatives are done with only standing ‘athwart history, yelling Stop’ (from William F. Buckley, Jr.). It will not be enough for conservative states like Florida to ban the teaching of CRT in the public high schools (or even in its public universities). Conservatives cannot just rely on highlighting the dangerous



absurdities of much of it. Do all that, but some of us need to take a second prong approach and hoist these ideologies on their own petard. The news on CRT has focused on the racial animosity that CRT stokes in high schools. But CRT at the post-graduate university level has also been part of an academic fixation for a number of decades to find new methods by which knowledge and truth are obtained (epistemology). The old mainstays of method prevalent in the social sciences in the 20th Century were called ‘positivism’ and ‘materialism’ that rejected intuitive or spiritual knowledge in favor of empiricism based on natural phenomena from what we experience in our 5 senses. This approach actually got started in the 1600s and Marxism later relied on it. Then, in the 1960s, disillusioned Marxists started to attack old Enlightenment Age principles of reason that they felt hadn’t served them well. What became of that was postmodernism and its progeny Critical Race Theory, and other studies. What I don’t hear in the news or in any writings about CRT is that the deepest motivating factor in these studies is an insatiable desire on the post-graduate academic left, to destroy positivism and materialism. For academia to get at the spiritual matters is the unconscious subtext of the movement, more than even ‘social justice’, whether the post-graduate proponents of CRT realize that or not. There is a devil in it for sure. And it threatens to blow up classical liberalism that gives protection to these crazy theories. So, deeply spiritual conservatives have their moment like never before. This is the great irony here. The epistemologies of the left are no match for the spiritual gifts of discernment grounded in Judeo-Christian scriptural truth (1 Corinthians 12:8). Since academia is ready to do away with its centuries old huge blind spot as it comes to spiritual matters, let us oblige. Before the devil can do anymore damage, let the light of God’s truth, that is supernatural revelation and its workings ruled by scripture, remake the liberal arts and sciences.”
