--Reporting on the 4<sup>th</sup> of July on Fox News, comedian Jimmy Failla noted: "We are celebrating America's 246<sup>th</sup> birthday. That is right – America is now the same age as Joe Biden."

--Former U.S. Navy SEAL Rob O'Neill – a member of the team that killed arch-terrorist Osama bin Laden, and whom I had the pleasure of meeting at a Media Research Center event several years ago – has a blistering message for the Navy, which created an instructional video about using proper "gender pronouns." The video, according to the Navy, is meant to emphasize "the importance of using correct pronouns as well as polite etiquette when you may not be sure of someone's pronoun." The late CBS journalist Walter Cronkite used to say, "it was a day like all days, filled with those events that alter and illuminate our times." June 24, 2022, was such a day – one in which we win some but also lose some. And "we were there."



The win – and it was an exciting win – came on that date from the U.S. Supreme Court, with its 6-3 decision to abolish Roe v. Wade. The loss, unfortunately, came six days later, with the court ruling 5-4 to allow President Biden to end former President Trump's "remain in Mexico" immigration policy for asylum seekers.

Still, during the final month of Supreme Court decisions for the just-ended term, many more decisions favored the conservative point of view. Among them are:

--In reversing the 1973 Roe v. Wade case, the justices supported Mississippi's restrictions on abortions by determining that the Constitution does not confer a right to abortion, and the authority to do so must be returned to the people and their elected representatives. The new case was Dobbs v. Jackson Women's Health Organization. Thomas Dobbs is the State Health Officer of the Mississippi Department of Health.

--Even though the Leftist New York City Council passed a bill last December allowing green card-holding non-citizens to vote in local elections starting next year, on June 27, the New York Supreme Court struck down that measure as illegal. It could have allowed as many as 800,000 extra votes in the Big Apple.

--And even though the Supreme Court overturned *Roe v. Wade*, and the Florida Legislature passed, and Governor Ron DeSantis signed, legislation banning abortions in the state after 15 weeks, Leon County Circuit Judge John Cooper blocked Florida's abortion law – that was set to go into effect on July 1 – saying it “violates the state's constitutional right to privacy.” But the ban is now back in place, following a successful appeal from attorneys representing the state. What's next? If a jury in a capital murder case determines a suspect's guilt, and the media reports on the case, will Judge Cooper release the prisoner, saying his “Florida constitutional right to privacy has been violated”?

--What is it with these Florida judges? Another one – Seminole County Circuit Judge Wayne Culver – has been suspended from the bench for 60 days, received a public reprimand, and will be required to complete anger management counseling – all because during a court hearing in February, he lost his temper with a man and directed a profane verbal tirade toward him.

--Some liberal women are reportedly so upset about the Supreme Court's *Roe v. Wade* decision, they have decided to strike back – by going on a “sex strike.” Brilliant! Don't they realize that abstaining prevents the need for an abortion?

--After poking fun at First Lady Jill Biden's comment comparing Latinos to “breakfast tacos,” for which she soon apologized – Florida Senator Marco Rubio announced that “Personally, I identify as a Cuban sandwich.”

--It is bad enough that National Public Radio spreads its bias on the airwaves. But to do so with our taxpayer funding? NPR. Perhaps we should call it Not Properly Reported.

More Two Cents next month.

--The Court allowed by a 6-3 margin the state of Louisiana to keep the State Legislature's redistricting maps in place through the midterm elections, even though the Democrat Governor had vetoed the measure. But it may be 2023 before the Court resolves the issue, and the 2024 elections before the State Legislature redraws districts if that is what the court orders.

--Ending a seven-year legal battle, the Court by another 6-3 margin, affirmed the right of former Seattle high school football coach Joe Kennedy to take a knee in silent prayer in public view



following football games. In their majority opinion, the court wrote that “The Free Exercise and Free Speech Clauses of the First Amendment protect an individual engaging in a personal religious observance from government reprisal,” and the Constitution “neither mandates nor permits the government to suppress such religious expression.” Kennedy had been fired by the Bremerton, Washington, School District, and Kelly Shackelford, President of First Liberty Institute, called the decision “a tremendous victory for Coach Kennedy and religious liberty for all Americans.”

--Determining that the Environmental Protection Agency cannot induce a shift toward cleaner energy sources using the approach that an Obama-era regulation sought to do, the Court issued another 6-3 ruling setting limits on how the agency can deal with power plants to regulate climate change.

--In a 5-4 decision, the Court cut back part of a 2020 decision recognizing nearly half of the state of Oklahoma as a native American reservation and ruled that it can prosecute non-Native-Americans in Indian country.

--In a unanimous 9-0 decision, the court sided with doctors who had been accused of over-prescribing medications, but challenged their convictions on drug distribution charges, saying that prosecutors must prove “beyond a reasonable doubt that the defendant knowingly or intentionally acted in an unauthorized manner.”

--The Court also ruled 6-3 that police will no longer have to pay money damages if they fail to advise suspects on their rights prior to obtaining incriminating statements that could be used in the future to prosecute. Los Angeles County Sheriff Carlos Vega won his case after appealing a lower court decision that revived a lawsuit that had been lodged by a suspect who had been accused of sexual assault while working in a hospital. The hospital employee, Terence Tekoh, accused Vega of not advising him of his rights before he had given the officer a full written confession, saying Vega violated his Fifth Amendment rights, which protects against self-incrimination.

--With Conservative and Liberal justices coming together, the Court unanimously ruled that the Biden Administration's Department of Health and Human Services (HHS) illegally reduced prescription drug reimbursements to hospitals by \$1.6 billion per year in a program aimed at helping poor patients. This win for the hospitals serving low-income patients allows

them to seek the improperly withheld funding from the federal government.

--The Court ruled 8-1 that Republican lawmakers in North Carolina can intervene to defend the state's voter ID law against legal challenges.

--Striking down New York State's restrictive Second Amendment law, the Court ruled 6-3 that the law, which required people to show a "special need" in order to obtain a license to carry a concealed handgun outside the home, was unconstitutional.

--In a huge win for parochial education in a case brought by the Institute for Justice, the Court struck down a Maine education policy that made K-12 schools with religious instruction ineligible for taxpayer-backed tuition aid. It ruled 6-3 that educational choice programs must be neutral regarding religion. This means it will be easier to bring these programs to hundreds of thousands more families across America who need a free and genuine choice to send their children to whichever school – religious or secular, public or private – suits them best, and Maine's so-called sectarian exclusion violated constitutional religious protections.

--Addressing what rights criminals have in seeking appeals, the Court ruled 5-4 against inmates, holding that a transportation order requiring the state to take them to a medical facility is not appropriate in aid of a federal court's adjudication of a habeas corpus action when the prisoner has not shown that the desired evidence would be admissible in connection with a particular claim for relief. It appears prisoners were seeking opportunity to appeal their sentences by claiming they are wrongfully imprisoned.

--The Court in a 5-4 vote sided with the technology industry and blocked a Texas law that barred large social media platforms like Facebook and Twitter from removing posts based on the viewpoints they express.

### **THE DISMANTLING ON AMERICA**

The devolving history of our Nation starts with a country that was prospering, had a government that was responsive to its citizens, low mortality rates and, in general the envy of other nations.

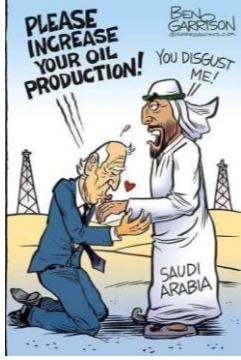
We are in a state of anarchy. As stated in one publication, "the term anarchy comes from the ancient Greek word anarchos, meaning "without rulers." As used today in political science and the area of international relations, anarchy can refer to the reduction or total absence of conventional government rule. It also can refer to any country or community that is temporarily or permanently under no system of governmental control.

Criminals have taken control of many cities due to the fact that attorneys general are not prosecuting violators. Seeing no consequence for their illegal actions the criminals are ruling the streets. According to National Library of Medicine, "The homicide rate in the U.S. was 7.5% higher than the homicide rate in other high-income countries combined."

Our own Attorney General, who once aspired to being a Supreme Court Justice, refuses to prosecute or even investigate lawlessness in front of Justices' homes, which is a clear violation of Federal Code 1507. The law states that anyone "with the intent of interfering with, obstructing or impeding the administration of justice or with the intent of influencing any judge, in the discharge of his duty" cannot picket near a judge's residence.

Republicans on the House Homeland Security Committee want answers about a new Department of Homeland Security policy that lawmakers say requires them to get privacy release waivers from criminal non-citizens accused of terror and assassination plots, in order for DHS to give them information about the threats. In a letter to DHS Secretary Alejandro Mayorkas, obtained by Fox News Digital, Republicans on the committee say the agency "has implemented a new policy requiring Members of Congress to obtain signed privacy release waivers from criminal non-U.S. citizens, including those illegally in the United States, and submit that waiver to the Department before the Department will provide the Committee with general information about the threats posed by such individuals." I'm not sure whether to characterize these reports under lawlessness, anarchy or under a dysfunctional government.

A new report by the Council on Criminal Justice tracks that in 2021, the homicide rate rose by 5 percent, an increase, but by a much smaller margin than in 2020, when homicides rose by 29 percent.



Third world nations are often short on natural resources and rely on other nations to provide the resources needed for a good economy. While we are rich in these resources this administration has put a stranglehold on our energy resources. We, at one time, were net energy exporters. We have been reduced to begging Middle East Countries and Venezuela to increase their production of oil to sell to us.

As of June 23, 2022, the total U.S. national debt was \$30.4 trillion, after crossing the \$30 trillion mark for the first time in February. At the end of 2019, prior to the COVID-19 pandemic, the national debt was \$23 trillion. One year later, it had risen to \$27.7 trillion. Since then, it has increased by more than \$2 trillion.

Third World Countries also have an unstable and inconsistent economy, 9.1% inflation rates, and high gas prices which aids in the increase of products from lipstick and tires to almost any item found in your grocery store that depends on trucks to deliver virtually everything on the shelves. ### RENDEZVOUS WITH REPUBLICAN WOMEN By BFRW President Jill Gentis



The Brevard Federated Republican Women on July 6 held a forum featuring Republican candidates running for the two open seats on the Brevard County Board of Commissioners in the August 23, 2022, primary.

Participating in the forum were three competing for District 2: **Tom Goodson**, **Dave Netterstrom**, and **Chris Hattaway**; and four competing for District 4: **David Armstrong**, **Rob Feltner**, **Sandra Sullivan** and **Margaret Mary Steciuk**.

BFRW member **Peggy Duffy** presented four relevant questions prepared by the BFRW Executive Committee. Each candidate, in turn, had one minute to respond. The questions were: 1. Why do you wish to become a County Commissioner for your District? 2. What do you think are the most significant issues facing Brevard County today and how does your experience uniquely qualify you to solve these issues? 3. What is your position regarding the Referendum eliminating the 3% charter cap on property taxes? 4. What is your position regarding Impact Fees?

Although there was no clear winner, candidates did provide insight into their campaign positions. Government and politics reporter **Ralph Chapoco** covered the forum and published a summary in "Florida Today."

### AN UPDATE FROM MY OFFICE

Following the end of the 2022 Legislative Session in March, I

have been busy meeting with constituents and fellow elected leaders in both my Volusia and Brevard offices. I have also had a great time attending various legislative updates, open houses, tours, ribbon cuttings and much more.



My office has also stayed hard at work addressing various constituent issues dealing with the different state agencies that we have. I would also like to share with you a major accomplishment from this past Legislative Session – passage of SB 1954/HB 1435: Code and Traffic Enforcement. This bill was aimed at putting a stop to disruptive and dangerous unpermitted “pop-up events” that were being organized on social media at locations around our state. One example of these events was an unpermitted truck week in Daytona that resulted in reckless driving, physical altercations, public indecency, shootouts and more.

Following these events, **Representative Tom Leek** and I met with 21 law enforcement agencies which detailed the desperate need for this bill. With its introduction, Sheriffs or Chief Law Enforcement Officers can now enact special events zones to address the concerns of previous events. Within these special event zones, traffic infractions will be doubled, a vehicle may be towed for any criminal traffic violation or noncriminal traffic infraction, cities may recover the costs of a special event zone from the event organizers, and designated law enforcement officers may enforce occupancy limits.

At least one special event zone has already been utilized to stop the mayhem seen from past events and I have heard incredible feedback on the results. Within that first special event zone, law enforcement officers had to write over 900 citations and tow away 70 vehicles. This new law is a tangible resource for our local city leaders and law enforcement agencies to protect our citizens and the beautiful communities we call home.

### AUDACITY AND IDIOCY

“Winners” for the month include:



--Far-leftist former MSNBC host Keith Olbermann, for outrageously calling for the dissolution of the U.S. Supreme Court because it dared to overturn New York’s restrictive concealed carry regulations, tweeting to his followers to “ignore the court” and obscenely suggesting what should happen to those members who supported the move.

--RINO Utah Senator Willard “Mittens” Romney, for his divisive Independence Day op-ed titled “America is in Denial,” in which he suggested that President Joe Biden “is a genuinely good man,” and that “a return of Donald Trump would feed the sickness, probably rendering it insurable.” Romney, who can’t

seem to figure out which side of the aisle he truly stands on, also wrote that Americans are dismissing threats to the country and wasting water supplies, and he called for leadership “from everyone except the political class.”

--The Harris Teeter and Kroger grocery store chains, for stopping the sale of pro-American and pro-Second Amendment merchandise in their stores because a few woke, fragile snowflakes complained. In response, online users reminded the chains’ executives that when you “go woke, you often go broke.”

--The Escondido, California, City Council – which owns and subsidizes the California Center for the Arts in Escondido – for standing behind a decision to display a “work of art” deemed anti-police. Titled “Three Slick Pigs,” it features a sculpture of three pigs in police uniforms, dancing and cross-eyed, as they stand in front of an image of officers in riot gear. The piece reportedly has been criticized or denounced by the city’s Mayor, City Manager, and Chief of Police. In response, the center argued that it operates as an “independent, not-for-profit foundation,” and that the city does not review or approve its artistic choices.

--A number of media outlets – including, but not limited to, the Washington (Com)Post, Salon, the Huffington Post, Jezebel and the U.K. Independent – for absurdly claiming that Missouri Senator Josh Hawley is “transphobic,” because “he thinks men can’t get pregnant.”

--“The New York Slimes,” for referring to newly elected Texas Congresswoman Mayra Flores as a “far-right Latina...a new brand of Texas Republicans walking the halls of Congress.” In a classy response, Flores said, “I feel that nobody really cares about the New York Times, especially in my district, where we’re worried about health care. We’re worried about the cost of gas, the cost of food. That’s what we’re worried about, not the New York Times.” She also made it clear she does not consider the paper to be “a legitimate news organization” and said she refuses to “give them any attention.”

--Ohio’s liberal Oberlin College, for refusing to pay a judgment of more than \$31 million to Gibson’s Bakery for falsely accusing it of being racist, and then racking up more than \$4 million in additional fines. The school wants the Ohio Supreme Court to cancel the debt, which the lawyers for the bakery are opposing, and no date has been announced for the court to hear the case. In 2019, a jury found that Oberlin and former Dean of Students Meredith Raimondo were culpable for claiming “racism,” when the bakery confronted three black Oberlin College students who were caught stealing wine from the store in 2016. The suspects were arrested and admitted they were shoplifting, but the school responded with sanctions against the 135-year-old family business, crippling it.

--Alleged “centrist” political scientist Norman Ornstein at the American Enterprise Institute, for absurdly tweeting: “The only surprise in the Texas GOP Platform is that it doesn’t call for a reinstatement of slavery.”

## YOU CAN’T MAKE THIS UP

--Speaking at the White House about a new executive order on abortion, Gaffer Joe Biden repeatedly lied about the Supreme Court decision overturning Roe v. Wade.

He said the justices were “playing fast and loose with the fact,” that the decision “wasn’t about the Constitution or the law,” and that the decision to overturn Roe “was an exercise in raw political power.” But then came the gaffes. He read a quote from the majority opinion in Dobbs v. Jackson Women’s Health Organization, in which the majority noted the American electorate is comprised of a majority of women. But after reading the quote, Biden said “repeat the line,” a cue apparently on the teleprompter from which he was reading. Video of the speech even shows Biden leaning into the camera to seemingly get a clearer view of the teleprompter. Throughout his speech, Biden also said “end of quote” – three times, in fact – after he recited a quote. “End of quote” is a normal cue that appears on teleprompters to inform whoever is reading that the quote is over.

-- Biden also has released more than five million barrels of oil from our historic emergency oil reserves release that is aimed at lowering Americans’ domestic fuel prices. Did it help with our rapidly rising prices? Of course not! The oil barrels were sent instead to China, India, Italy and the Netherlands. fought and continue to fight for those. We take pride in celebrating the 4<sup>th</sup> of July to express our gratitude to those men and women and honor the country we live in.” What, then, was the purpose of the first statement?

**A NIGHT AT THE MUSEUM.** More than a hundred supporters of **Florida 8<sup>th</sup> District Congressman Bill Posey** attended a benefit in his honor at the Institute of Military Technology in Titusville on June 29, touring the massive museum and enjoying a dinner prepared by Orlando's 4 Rivers BBQ. Guides explained to small groups on tour

that they were viewing many thousands of rifles, pistols, machine guns and bayonets – each identified by year of creation and country of origin around the world – as well as dozens of cannons, tanks, trucks, and personnel carriers that were used in several wars over the years. The massive collection is owned by **C. Reed Knight, Jr.**, of Knight Armament Company, who continues to add to his collection as items become available. At dinner, when Posey thanked his supporters, he said that in Congress, he is part of "the spiritual battle taking place for the heart and soul of America." Seeking another term in office, he has no Republican primary opposition, but he pointed out there are two women competing to be his Democrat opponent in November. Two of the biggest problems America is facing today, he said, are the teaching of Critical Race Theory in our schools, and the massive amount of deadly fentanyl that is being brought across our border. Posey pointed out that the Leftists' "Bible" is "Rules for Radicals," which author Saul Alinsky dedicated "to Satan." The Congressman also reminded his



audience that the last time he spoke to the House of Representatives, the only thing that people remembered was his closing phrase – “Let’s Go, Brandon.”

**FLORIDA BILL SIGNINGS.** Among the latest group of bills passed by the Florida State Legislature that **Governor Ron DeSantis** signed into law include: Making it a third-degree felony to steal 10 or more items across five separate thefts within 30 days, and upgrading it to a second-degree felony if the number of items stolen tops 20; Expanding eligibility requirements for the Bright Future Scholarship Program to include paid work experience as a substitute for service hours; Strengthen renter safety with Miya’s Law, named for Miya Marcano, a young woman and Orlando student who was killed in her apartment by a maintenance worker who entered with an apartment key fob; Support for Religious Institutions; Enhancement of two-way radio communication systems; Regulation of smoking by counties and municipalities; Grandparent visitation rights; Transparency of guardianship data; Homestead property tax exemptions for classroom teachers, law enforcement officers, firefighters, emergency medical technicians, paramedics, child welfare professionals and service members; Boating safety; and Certification of best management practices on golf courses.



**RINOS AND THE 2nd AMENDMENT (CONTINUED).**



The 11 RINOs mentioned in last month’s newsletter as joining with their Democrat Senate colleagues to vote in favor of funding for states to implement anti-Second Amendment red flag laws, were added to by three more just prior to the Senate vote that occurred after the June Space Coast Tusk went to

press. The three extra Senators were Joni Ernst of Iowa, Todd Young of Indiana, and Shelley Moore Capito of West Virginia. There was not enough time for Senators to actually read the 80-page bill – which could lead to efforts by the government to confiscate firearms from law-abiding gun owners – and the Senate forwarded the measure to the House by a 64-34 vote. That action was quickly followed by the House of Representatives – which was aided by 14 more RINOs in that branch (far too many) to give Speaker Nancy Pelosi a 234-193 victory. The House RINOs included Liz Cheney of Wyoming; Adam Kinzinger of Illinois; Fred Upton and Peter Meijer of Michigan; Mike Turner, Steve Chabot, Anthony Gonzalez and David Joyce of Ohio; Chris Jacobs and John Katko of New York; Brian Fitzpatrick of Pennsylvania; Maria Salazar of Florida; Tony Gonzales of Texas; and Tom Rice of South Carolina. President Biden was then quick to sign the unconstitutional measure into law. The two most glaring violations of Second Amendment rights are the expanded background checks on would-be purchasers between the ages of 18 and 21 and the millions of dollars in funding that states would be provided with to enforce “red flag laws.” Strongly condemning the legislation, the National Rifle Association said

in a statement: “This legislation can be abused to restrict lawful gun purchases, infringe upon the rights of law-abiding Americans, and use federal dollars to fund gun control measures being adopted by state and local politicians.”

**NANCY PELOSI’S JANUARY 6 COMMITTEE’S LIST OF TOP 7 WHOPPERS.** According to WND.com, seven whoppers top the list of false allegations about the Democrats’ January 6 Committee: First on the list was the claim that President Trump incited the January 6 riot at the U.S. Capitol. But protesters entered there before Trump finished speaking at a rally away from the site. Second was the claim the deployment of the National Guard was delayed, but in fact, Democrat officials rebuffed attempts to dispatch the military, even though Trump signed an order to deploy 20,000 troops if they are requested. Third, there was a claim that former New York Police Commissioner Bernie Kerik was in Washington to talk about overturning the November 2020 election results, but he was in New York that day. **CONGRESSIONAL MEDAL OF HONOR.** Just days after the passing of the last living World War II recipient of the Congressional Medal of Honor – **Hershel “Woody” Williams** – President Biden presented medals to three U.S. Army Vietnam veterans and one posthumously on July 5. During a somber White House ceremony, he recounted the acts of bravery of the four men, one of whom was killed in action three months after he helped evacuate his platoon from a village while under heavy enemy fire.. The living World War II recipients are **Major John Duffy**, **Specialist Five Dwight Birdwell**, and **Specialist 5 Dennis Fujii**. The posthumous addition was to the late **Staff Sergeant Edward Kaneshiro**. There are now 66 living medal recipients.



Since traditional leftist journalism awards organizations never honor conservative journalists, the Media Research Center decided to create their own award program – the MRC Bulldog Awards. **MRC Founder and President Brent Bozell** announced that “As the liberal media celebrate themselves with

Pulitzers, we wanted to shine a light on the real truth-tellers who are greatly dedicated to informing the American public on stories the legacy media ignores.” This year, the first six Bulldog Award winners are: 1) Author, TV host and radio host **Mark Levin**, for the “Outstanding Radio Talk Show Host Award”; 2) Former Secret Service agent and current TV host **Dan Bongino**, for the “Outstanding Podcast Award”; 3) “New York Post” writer **Miranda Devine**, for the “Outstanding Columnist Award”; 4) “The Daily Wire” writer **Luke Rosiak**, for the “Outstanding Investigative Journalism Award”; 5) “Reload” blog writer **Stephen Gutowski**, for the “Outstanding Blogger Award;” and 6) “Washington Free Beacon reporter **Drew Holden**, for the “Outstanding Social Media Personality Award.” So, who needs Pulitzers when there are Bulldogs?

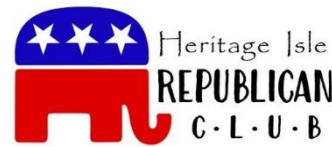
**EIGHT THINGS MORE POPULAR THAN EPIC FAILURE CNN+.** The spectacularly unpopular CNN+ news channel did not even survive its first month on cable TV. CNN’s wacky leftist opinion panels rather than hard news didn’t help the network; neither did its plan for a monthly fee for the Plus service. The Media Research Center’s “Watchdog” points out that less than 10,000 viewers signed up for the service and compares it to New Coke and the Edsel. So the plug was quickly pulled. **Kevin Tober** and **Curtis Houck** of MRC’s NewsBusters team tongue-in-cheek put together an impressive list of “Eight Things More Popular Than Epic Failure CNN+.” They are: 1) A Kickstarter campaign for potato salad made more money – more than \$55,000 – in its first month than did CNN+, which offered the service for just \$2.99 at the start. 2) More people died falling out of bed between 1999 and 2014 than ponied up for CNN+. 3) An Instagram account called @daily\_otis that posts a picture of the same cow every day has five times the audience of CNN+. 4) Tuvalu, a 10-square-mile island halfway between Hawaii and Australia in the Pacific Ocean, has more people than CNN+ has subscribers. 5) There’s a YouTube video of paint drying – and nothing else – that has nearly twice as many viewers as the entire CNN network – 1.1 million. 6) The number of kids who call NORAD wanting to know the whereabouts of Santa Claus on Christmas Eve is 13 times the number of people who signed up for CNN+. 7) Australia’s Bureau of Statistics says there are “close to 48,000” Jedi in the country. That’s close to five times the number of people who subscribe to CNN+. And 8) Over 118 million people – far more than the number of CNN viewers – are estimated to be subscribed to Play World of Warcraft, a popular video game.

**GASOLINE SAVINGS SCAMS. State Attorney Phil Archer** of Florida’s 18<sup>TH</sup> Judicial Circuit, reports in his July “Monthly Brief” that readers should beware scammers who follow the headlines with the high cost of fuel dominating the news. It should be “no surprise,” Archer said, that discount fuel scams are everywhere, especially on social media. These scammers, he said, are calling residents and inviting them to sign-up for a government fuel cost assistance program using their checking accounts. But instead of filling their tanks, these crooks are draining their bank accounts. Gas card offers are also being used to target victims, Archer said,



and both Shell Oil and Speedway are warning consumers about fake fuel card offers and sweepstakes entries that are circulating on social media. Fake apps that mimic actual fuel rewards programs, he noted, are being offered via unsolicited links in texts, emails and other platforms.

**KUDOS DEPARTMENT.** A Liberty Station bathroom stall in San Diego, California – site of a charity 5K race – is not the safest, most sanitary location in which to deliver a baby. But that is where **Border Patrol Agent George Huertas**, an emergency medical technician, quickly went. He located the woman, borrowed rubber gloves from a janitor, delivered and cleaned up a baby boy, stimulated his breathing, and waited for the arrival of medical personnel to take over care of the mother and child. Afterward, Huertas only told a few of his colleagues about the birth and downplayed the incident. Michael McEwan, his commanding officer, said he “responds to those in need on and off duty, and is a strong advocate for those under his care.”



Discussing at the July 6 meeting of the Heritage Isle Republican Club the major issues that were before the Florida State Legislature this year, **State**

**Senate Majority Leader Debbie Mayfield**, who represents Brevard County, said education was the “huge issue” before the legislators. This was true, she said, especially with passage of the Parents’ Bill of Rights – which **Governor Ron DeSantis** signed – prohibiting sex orientation teaching through the third grade. If parents learn that any school is not following this procedure, and a school board doesn’t listen to a complaint, Mayfield said, the matter can be brought to the attention of the Florida Board of Education. Adding that the teaching of Critical Race Theory is prohibited in Florida schools, she said parents have to watch out for what is actually in the curriculum. A topic still to be discussed in the legislature is that “parents should be able to get vouchers to send their children to any school they want,” Mayfield said. She also noted that if any big storm hits the state during the upcoming hurricane season, “there is plenty of money in our reserves fund to cover expenses.” Improvements in the area of election integrity, she said, include requiring counties now to clean up their voter rolls annually, and that requested mail-in ballots be sent back with copies of a valid Florida driver license. On the Second Amendment subject of Constitutional Carry, she said that for the next session, the Governor” will work with us to get it right.” The difference between just passing a bill and getting something inserted into the Florida Constitution, she pointed out, is that if the other political party assumes power in the future, a bill can be repealed, but “it is harder to change an item in the Constitution.” Mayfield, who said she “loves representing people” in Tallahassee, added that in addition to passing a state budget for the year, the Legislature was required to draw maps of new districts following the ten-year census. With that drawing, she said, she hopes the 40-member Senate will be able to increase its number of Republicans from 24 to 27....Brevard County





School Board member **Matt Susin**, a second speaker on the meeting agenda, agreed with Mayfield that parents should have the choice about what type of school to send their children to. He said that after he learned about the home schooling process, he became proud of this community's practices. Another thing that made him proud, Susin said, was that when he was a teacher, it was his students who successfully fought for the State Legislature's passage of the "All American Flag Act" in reaction to Florida schools having Stars and Stripes flags that were made in China. Today, he stressed, ALL flags in all Florida schools are made in the USA. Expressing criticism of liberal projects that had been appearing in Florida classrooms, he said the Democrat 1619 Project stating that the United States only began with the introduction of slavery, is "the biggest hoax I've ever seen." And speaking of the liberal teachers and principals who are willing to bring Critical Race Theory to our schools, he said, "We make laws to reprimand and remove them." He also expressed opposition to schools having coronavirus mask mandates and support for LGBTQ programs. Currently part of the 2-3 Republican minority on the Brevard School Board, Susin called for voters to elect a Republican candidate in at least one of the non-partisan districts that will be on the August 23 primary election ballot, as well as re-elect **Katy Campbell** in District 5. He pointed out that there is some overlap between the five County Commission districts and the five School Board districts in Brevard County, and said not only that he wished they would mirror each other, but also that the School Board should be increased in size, with all voters electing two more at-large members....Newly elected **HIRC President Mike Hoagland** had an interesting take on the "China Coronavirus" situation – praise – because without it, and with schools being shut down, "we would not have learned about what had been going on there."

Noting that Palm Bay has a huge budget of \$232 million, but of that amount only \$750,000 per year has gone toward road maintenance, he said that "money is not the issue, PRIORITY is" ...The Club also presented Military Tribute banners – that had been on display at the Palm Bay City Hall from Veterans Day in 2012 until Memorial Day 2022 – to two recipients: retired **U.S. Air Force Master Sergeant Mary Shaffer** and current **U.S. Navy Petty Officer Alex Rodriguez**. We deeply thank them for their service.... "The Supreme Court this term seemed to embody William F. Buckley's adage that 'a conservative is someone who stands athwart history, yelling Stop.' In a country of 330 million people and 390 million guns, the conservative supermajority returned America to a historical moment of looser firearm laws. It delivered the country to an era where religious schools, even those which openly discriminate



against LGBT students, must be eligible for state funding that is available to nonreligious schools. And at a time when an unwanted pregnancy can be medically terminated at home, the court has allowed states to make swallowing an abortion pill a crime. The court's monumental decisions this term shook the country and moved it sharply in a conservative direction, say observers from across the spectrum.... Before a historic series of rulings it was clear the Supreme Court, in its first full term with six conservative justices, was going to move to the right. It just wasn't clear how far it would go or how fast. That picture came into focus quickly over the last two weeks, as the high court's supermajority issued a landmark decision erasing the nearly 50-year-old 'constitutional right to abortion' by overturning *Roe v. Wade*. The decision to strike down *Roe* was the most earth-shaking, but it was hardly alone. The court also enshrined a right to carry a handgun in a ruling striking down New York's concealed carry permit law. It curbed the authority of the Environmental Protection Agency and executive agencies more broadly. It issued rulings expanding religious liberty. The decisions sent chills through progressives and Democrats, as they were welcomed by conservatives. More broadly, they raised questions about the degree to which the court is in touch with the broader populace, and whether most of the electorate thinks the founding era is the best source of wisdom to guide a modern pluralistic democracy.... This court term marked a breakthrough moment for the conservative legal movement's well-funded and norm-shattering effort to groom a generation of conservative lawyers, elevate reliable allies to the Supreme Court and reshape American life in fundamental ways. Yet the 6-3 conservative supermajority Supreme Court at various points sought to downplay the transformational nature of their actions, as well as an internal dissension among the justices that was clear from their own written opinions. Writing for the majority in overturning *Roe v. Wade*, Justice Samuel Alito emphasized that his ruling was narrowly aimed at abortion. He insisted the decision would not threaten protections for same-sex marriage (*Obergefell v. Hodges*), sex between gay couples (*Lawrence v. Texas*) or the right to contraception (*Griswold v. Connecticut*). But Justice Clarence Thomas, in a concurring opinion, wrote that the reasoning underlying the opinion should call those other decisions into question. Thomas has long rejected the well-established principle that the Due Process Clause of the 14th Amendment protects not only procedural safeguards but also substantive rights. Legal experts said the court's approach to law this term raised legitimate questions about whether rights that are seen as having a thin historical record and which are not explicitly referenced in the Constitution – so called unenumerated rights – remained on firm footing after the decision.”

**Heritage Foundation senior legal fellow Hans Von Spakovsky**, writing on requiring election audits at “The Patriot Post”:

“Financial audits are standard practice in the business world. Election audits also should be standard practice in every state after every election. Audits would



determine whether the election was administered honestly, fairly, accurately and in compliance with all applicable laws and regulations. Yet audits of election agencies, procedures and systems are almost nonexistent in America. The very concept of comprehensive election audits has been criticized and opposed by some election officials and even by the current U.S. Department of Justice. Why would officials oppose such audits, unless they fear they will turn up embarrassing mistakes, incompetence, or malfeasance? The Justice Department's opposition to the Arizona state Senate's audit of Maricopa County was a purely partisan action that had no legal merit. Election audits are well within the constitutional authority of states. It should be understood that what some election officials refer to as audits are not, in fact, audits. Simply recounting, by hand, ballots that were counted by a computer scanner on Election Day is not a comprehensive audit. Yes, that can ensure that the scanners were operating and tabulating the vote correctly. However, it cannot tell whether the ballots were cast by eligible, qualified voters. If noncitizens or people living outside a jurisdiction are able to register and vote without being detected by election officials, a simple recount will not alert authorities that illegal ballots were cast. Election audits should be conducted by independent, experienced experts. Obviously, you cannot have election officials audit their own performance.... To ensure the integrity of our elections, it would be best for every election jurisdiction, from counties to townships, to be audited after every election. That may not be possible due to cost and a lack of experienced auditors. But states could implement a system that audits a number of different jurisdictions within the state on a rotating and random basis, guaranteeing that every election jurisdiction would be audited at least once every few years. A mandatory audit system like this should also require election officials, as well as third parties who provide election services and equipment, to cooperate fully with auditors or risk being fired. Comprehensive election audits would make sure election officials took all steps necessary before the election to ensure only eligible individuals cast ballots, which entails checking legal residence, age, citizenship and other requirements. Auditors would check that all voting equipment was subjected to testing both before and after the election, was not connected to the internet at any time during the voting and tabulation period, and that no unapproved software or malware was added before or after the election. Auditors would make sure all election observers were given complete access to the entire voting and tabulation process, including the handling of absentee ballots, to ensure compliance with all voter ID, signature-matching and other legal requirements.... Comprehensive election audits should become a routine occurrence in our elections. They are necessary to ensure the proper conduct of the entire election process and to assure the public, candidates, political parties and the media of the honesty and integrity of our elections.”

Q: 'And do you have a lock on your locker?'

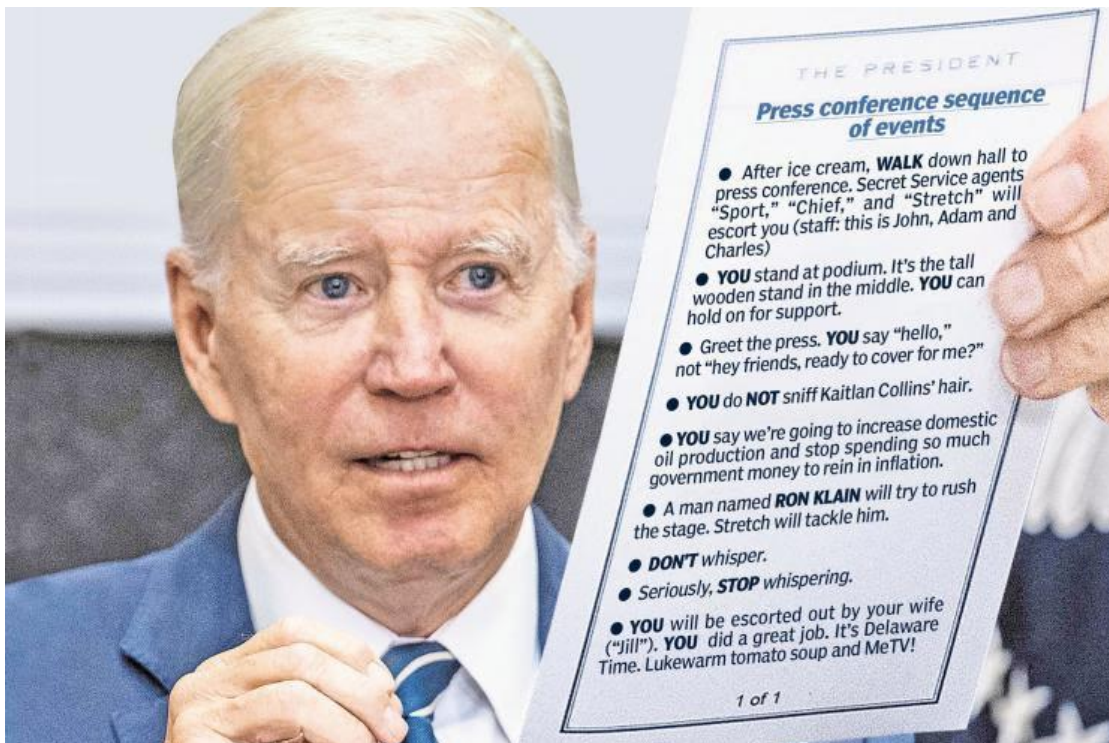
