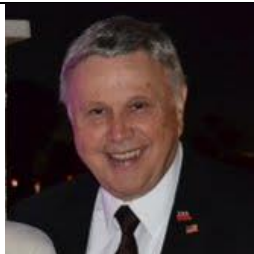
GOVERNOR DESANTIS SIGNS FLORIDA STATE BUDGET FOR FISCAL YEAR 2022-23

--Yes, there IS a God. The latest person to test positive for COVID-19, despite being fully vaccinated and double-boosted, is -- drum roll, please -- Dr. Anthony Fauci.

--In a blow to the progressive prosecutors movement, voters in San Francisco on June 7 indicated by a 60-40 vote they had had enough violent crime in the city during the past two years. They recalled District Attorney Chesa Boudin, who sent nonviolent drug offenders to treatment instead of jail, spared juveniles from being prosecuted as adults, and scrutinized police "misconduct." Burglaries had risen 45 percent and homicides increased 37 percent during Boudin's time in office. To quote the phrase made famous on **Donald Trump's** old "The Apprentice" show on TV: "You're fired!"

Meanwhile, in Los Angeles, the campaign to recall District Attorney George Gascon, another progressive DA, needs to collect 67,000 more signatures over the next month to qualify placing his recall effort on the ballot. Recall campaign spokesperson Tim Lineberger said the news out of the Bay Area would embolden volunteers, and Gascon and Boudin's failed social experiments "have destroyed communities while doing nothing to meaningfully reform the system. If L.A. County voters sign and return their recall petitions, Gascon will be walking the same plank in the near future."

--The Virginia-based website patriotpolitical.com reports that in covering the Democrats' January 6 Pelosi committee hearing, the "New York Times" slipped up and admitted that when polls show voters' attention is focused elsewhere, the

Addressing government officials and supporters at a news conference in The Villages on June 2, **Florida Governor Ron DeSantis** signed the Florida State budget for fiscal year 2022-2023, which begins this July 1.



The budget – which is 8 percent larger than the current one – totals \$109.9 billion, which allows for \$1.24 billion in tax relief to Florida families and sets aside \$16 billion in state reserves.

"Our state budget continues our commitment to allocating historic funding for education, infrastructure, public health, public safety, and our environment," DeSantis said, adding that "Florida has preserved freedom and kept the economy open, which has enabled the state to outperform the nation in jobs,

hearing will give Democrats “a platform for making a broader case about why they deserve to stay in power,” and to try to convince voters that “Republicans are dangerous, and also to stop Trump from running for President again in 2024.”

--Double Standards Rule. After former **Trump Administration Assistant to the President Peter Navarro** was arrested by the FBI, handcuffed, leg shackled, strip searched and jailed for the “Contempt of Congress” crime of failing to comply with the January 6 Committee’s witch hunt subpoena, former **Arkansas Governor Mike Huckabee** wondered why, during the Obama administration, Attorney General Eric Holder – who had the same “Contempt of Congress” charges brought against him for failing to respond to a Congressional subpoena of documents relating to Operation Fast and Furious Gun Trafficking events – wasn’t treated the same way. Nothing happened in his case, Huckabee said, adding that “Republicans have got to stand up for “Constitutional standards.”

--More than 5,000 special needs athletes participated in the Special Olympics USA Olympic Games in Orlando, Florida, June 5-12 – after Special Olympics International (SOI) dropped its requirement that they needed to show proof of COVID-19 vaccinations in order to compete. **Florida Governor Ron DeSantis** had threatened to slap SOI with \$27.5 million in fines for violating the state’s anti-mandate law. “Your rights or your freedom should not be circumscribed by your decision to take or not take the vaccine,” DeSantis said at news conference. “You should be able to go to a movie theater, you should be able to go to a restaurant and be able to do what you want to do, without having to produce medical papers, and certainly without being excluded from participating in society.”

--When it comes to cycling, weightlifting, volleyball, swimming, and track and field, a growing number of female athletes are voicing their concerns about letting biological males compete in women’s events. In the last 19 years, according to washingtonstand.com, there have been at least 28 separate girls’ and women’s sports titles that have been won by or included biological male athletes who identify as transgender.

--After the restaurant chain Pizza Hut recommended a book about a child drag queen in its BOOK IT reading program for children – calling for exploring the “uniqueness” of every person and celebrating “individuality,” the backlash began. Foundation for Liberty and American Greatness President Nick Adams slammed the betrayal and asked “every single American” to boycott “woke pizza.” Syndicated talk show host Joe “Pags” Pagliarulo asked whether the company is “looking to lose millions of customers.” And ACT! For America Founder and Chair Brigitte Gabriel called on making “full woke” Pizza Hut “full broke.”

growth, and business formations. Our commitment to freedom has paid off. Our responsible fiscal policies have put the state in a strong position to make the record investments needed to support growth and opportunity in spite of the reckless fiscal and monetary policies of the Biden administration.”

The legislation prioritizes the freedoms of Floridians to live, work, and have successful businesses in the state. Florida has record levels of reserves while continuing to make historic investments in education, infrastructure, and other programs.

But utilizing his authorized “veto pen,” DeSantis eliminated \$3.1 billion in spending on “pet projects” that state legislators had added to the bill when it passed in March at the end of their initial session.

Among the vetoed measures were a \$1 billion proposed reserve account intended to help state agencies meet rising costs for services; \$850 million for new prison and hospital construction projects; dozens of hometown water and sewer projects, renovations for city halls, court houses and police and fire stations; construction of the University of South Florida’s Environmental and Oceanographic Sciences Research and Teaching Facility; aid to local governments; purchase of two new state aircraft; funds for university scholarships; building deficiencies at public broadcasting stations; and a new spring training facility for the Tampa Bay Rays baseball team.

Another veto was for the construction and funding of a Moffitt health center in Pasco County, which DeSantis said he did not support because it would “tie the state to a long-term, 30 year-commitment that inhibits budget flexibility. Instead, he said, Moffitt and two other hospitals will be receiving an additional \$37 million in cancer funding.

With his vetoes, DeSantis said his message was clear: “We’re making sure we’re protecting your money.” But he did endorse most of the State Legislators’ spending measures, including across-the-board pay raises for state employees and school teachers, sales tax holidays for back-to-school purchases and hurricane preparation, federal coronavirus aid from Congress that will be used for a gas-tax break.

In addition to the budget bill, DeSantis signed a number of other measures through the current month, covering such topics as IRAs, property rights and insurance, building safety, the Florida Gaming Control Commission, aircraft, the electronic filing of taxes, the Office of the Judges of Compensation Claims, information technology, health, motor vehicle title fees,

collective bargaining, the state-administered retirement systems, the state group insurance program, the inflation fund, the trust fund, the Capitol complex, the Judicial Branch, Soil and Water Conservation Districts, specialty licenses plates, and immigration enforcement.

And on the same day that Democrats began pushing for a special session on gun violence, he signed a bill adding to the state's long list of school safety reforms enacted since the Valentine's Day mass shooting at Marjory Stoneman Douglas High School. The bipartisan-supported measure adopts a number of additional recommendations by the task force created in the wake of the shooting deaths of 17 students and faculty at the Parkland high school on February 14, 2018. The new bill will improve safety in Florida schools as well as improve student mental health programs. It extends through 2026 the Parkland school's Public Safety Commission, requiring all safe school officers to complete crisis intervention and training to improve knowledge and skills for response and de-escalate incidents on school premises, and requiring that school districts annually certify that at least 80 percent of school personnel received mandatory youth mental health awareness training.

Other bills the Governor signed in June covered the Florida Seaport Transportation and Economic Development Council; time limitations for juvenile detention cases; the Florida Gaming Control Commission; pro-consumer measures to help alleviate rising insurance costs and crack down on frivolous lawsuits; grants through the My Safe Florida Home Program to provide homeowners with relief for hurricane retrofitting; increasing the safety of condominiums; increasing transparency by requiring all structural inspections reports and reserve studies be part of an association's official record; establishing a felony for touching a 16- or 17-year old in a lascivious way; a measure to increase access to higher education and employment for military veterans; and a push to re-establish the Florida State Guard to help respond to natural disasters.

The property insurance costs in Florida that were the subject of a second special session of the State Legislature resulted in three days of meetings that led to bills signed by Governor DeSantis that included measures related to reinsurance, roof solicitation, roof underwriting, bad faith, attorneys' fees, insurer regulation and transparency, and building safety codes.



LET ME BE FRANK

You're traveling through another dimension – one not only of sight and sound but of mind. It's a journey into a wondrous land whose boundaries are that of imagination. That's a signpost up ahead: your next stop: the Biden Zone!

For those who are familiar with the Twilight Zone, you recognize the introduction. Or more recently, the Netflix' series, "Stranger Things," where the premise is that we are in

the "Upside Down" fighting Vecna, who has been named as one of the greatest villains in Dungeons & Dragons.

Inflation, gas prices at all-time highs, shortage of baby formula, open borders, death threats against sitting Supreme Court Justices, leaked drafts of Supreme Court decisions, crime out of control, the 2020 summer of riots, and what is this administration focusing on – Donald Trump and the January 6 riots.

Make no mistake about the January 6 hearings. It is not about the mob, it's about what part Donald Trump had to do with it. This is a Committee where the Republicans chosen by the Minority Leader, Kevin McCarthy, were not allowed to sit.



Instead, the defenders of this Committee point to the two "Republicans" (read that as RINOs) that are seated – Liz Chaney, an avowed Trump hater, and Adam Kinzinger. The Speaker touts a "bi-partisan committee" with 7 Democrats and 2 Republicans who have been critical of President Trump and voted to impeach him. Hardly bipartisan in any way, shape or form.

What you don't see is that the basic methods of hearings are not being followed here. There was no rebuttal witness allowed. There was no evidence allowed to refute any of the Committee's charges. There is only a guilty until proven innocent mentality on the sham Committee.

Lost in all this is the fact that at least 543 defendants have been charged and more than 200 have been indicted by Grand Juries plus 300 who have pleaded guilty to charges relating to the January 6 "insurrection." Questions about what Nancy Pelosi knew, why the Capitol Police were not prepared given that information was transmitted about the possibility of the events was known in advance, why wasn't the National Guard deployed even when it was offered, will all go unanswered.

Americans notoriously suffer from "short term memory disorder." Fatigue is a major factor in this. So how do you keep their interest in these hearings? Hire a professional TV Executive to build an event that might bring attention back to January 6. So enter James Goldston, former president of ABC News. He was to frame the public hearings as a blockbuster investigative special. I don't know how much he was paid, but he failed miserably.

As reported in "The Federalist," CBS, NBC, and ABC, which switched their regular prime-time programming to air the House Select Committee on January 6's first public hearing,

saw huge ratings decline, according to Nielsen figures. ABC, whose fall schedule normally includes Grey's Anatomy at 8 p.m., took in the largest haul of viewers with 4.8 million, while NBC and CBS carried 3.5 million and 3.3 million, respectively.

What is the true goal of the hearings? Mark this as evidence – a candidate for Governor in Michigan, Ryan Kelly, was arrested and charged with 4 misdemeanor counts for simply being present on the Capitol steps on January 6. Now add to the evidence the call for stacking the Supreme Court by increasing the number of Justices on the Court. There is evidence that some Democrats would do away with the Electoral College. And the obvious attempt of possible criminal indictments against Donald Trump and keeping him from ever running for public office again.

A note on the Electoral College. The Founding Fathers compromised on the election to National Office as to whether the Congress should elect the President and Vice President and the popular election of said offices. They feared that low population states would not have a voice in these elections and were concerned about the possibility of "mob rule." Over the years, at least 700 attempts were made to either alter the College or do away with it. Recently there have been two elections where the candidate who won the popular vote and lost the Electoral College. Both saw Republicans succeed. The list of Democrats who have called for the abolishment grows by the year. The list includes Hilary Clinton, Elizabeth Warren, Pete Buttigieg, Cory Booker, Kirsten Gillibrand, and Bernie Sanders.

Imagine that without the Electoral College, we would be subject to being led by a government chosen by only the most populist of states, such as California, New York and Colorado. Add to that list Connecticut and Massachusetts plus cities like Chicago. That is a frightening vision.

As for the subject at hand, the January 6 Committee, if we had abolished the Electoral College, Donald Trump would never have been president. Their remedy? The Popular Vote, where we would perpetually be ruled by Democrats selected by the popular vote of a few Blue States.

The hearings are a colossal waste of taxpayer money. Rather than holding public hearings about things that directly impact us every day, such as inflation and gas prices, the Democrat-led Congress focuses on an event almost a year-and-a-half old – an "insurrection" that changed nothing. America is behind the rest of the world, not because of the January 6 events, but because of the failures of the Biden Administration. RENDEZVOUS WITH REPUBLICAN WOMEN By BFRW President Jill Gentis

The Brevard Federated Republican Women, at their June 1 meeting, held another "Candidates Day" forum featuring the School Board candidates running in the non-partisan August 23 primary. Participating in the forum were: **Megan Wright**, District 1; **Courtney Lewis**, **Shawn Overdorf** and **Gene Trent**, all in contention for the seat in District 2; and **Katy Campbell**, a current School Board member and candidate for re-election in District 5.

BFRW member **Peggy Duffy** presented six relevant questions, and each candidate in turn had two minutes to respond. The questions were: 1) What makes you the best candidate for School Board? 2) How do you feel about raising property taxes to provide raises for School teachers and staff? 3) Can you identify two wasteful spending items that should be immediately cut? 4) What would you do to remove CRT curriculum from our schools? 5) As a School Board member, how will you ensure that parent's rights are protected and

recent changes in the law are implemented at the classroom level and that compliance is verified including instruction? 6) If you do not win a seat on School Board, will you support the candidate who does for the sake of the children? Each of the candidates articulated an informative response designed to help attendees determine which were the better possible candidates to be chosen on August 23.

We also had the opportunity to hear **Robyn Hattaway**, a Republican candidate for Florida House District 30, speak about her platform.



In Florida, June is now the “Month of the Father.” We were very honored to have **State Representative Thad Altman**, the committee chair that developed the bill, speak about HB 7065. This HB will provide nearly \$70 million in grants to assist fathers to find a job, to transition from being in jail and to get parenting

AUDACITY AND IDIOCY

Here are June’s “winners”:

--House Speaker Nancy Pelosi, for appearing on the “RuPaul’s Drag Race All Stars 7” television program and heaping high praise on the contestants – who gushed with adoration for her speaking of “the joy and beauty drag queens bring to the world.” Pelosi added, “It is my honor to be here, to say to all of you how proud we all are of you. Your freedom of expression of yourselves in drag is what America is all about. I say that all the time to my friends in drag.” Does that include any of her fellow representatives?

--Stefany Guido, the librarian at Sterling Middle School in Loudon County, Virginia, for defending making the book “Seeing Gender” available for students. One chapter in the book, “Sex Work is Not a Bad Term,” says that “prostitution is a job like being a store clerk, an architect or a freelance writer.” One appalled teacher told police that the librarian “started talking about how there’s kids who come to the library who do sex work, and this makes them feel validated.” These are middle school students, and the investigation continues.

--The University of Florida School Library, for naming one of their study rooms after Karl Marx, the father of Communism, honoring him as a “philosopher, radical economist, and revolutionary critic.” Fortunately, the Leadership Institute’s Campus Reform was on the scene, even in great conservative states like Florida, to fight the radical Left’s rampant run on campuses, and citizen outrage generated so much pressure that the school backed off and removed Marx’s name from the study room.

--The unnamed forewoman of the jury that found former Hillary Clinton campaign lawyer Michael Sussmann not guilty of lying to the FBI, for telling the media at the conclusion of the trial that she believed the case “was essentially a waste of time,” and should not have been prosecuted. “There are bigger things that affect the nation than a possible lie to the FBI,” she added. Confusingly, the forewoman also claimed the government “succeeded in some ways and not in others” in proving its case, although she did not elaborate on what she meant, and it is unclear how the government could have both succeeded and failed to do so in this case. It was also determined that three of the jurors in the Washington, D.C. trial were financial Clinton supporters, and one has a daughter who played on the same school sports team as Sussmann’s daughter.

--Officials of Granada Hills Charter High School in Los Angeles, California, for not only barring students not vaccinated against the coronavirus from attending class on campus, but those who were seniors were blocked from the senior prom, senior awards day, and other school events. Then, at the time of graduation, the 70 unvaccinated seniors – out of a graduating class of about 1,100 – were banned from walking in their outside graduation ceremony. And the school officials didn’t even care that eight of these students are not vaccinated because they have special needs and the vaccines pose specific dangers to them.

--Officials at Oakland University in Rochester, Michigan, for wrongfully evicting from campus housing student Inara Ramazanova, forcing her to spend her final semester at home, for the “crime” of sharing information on social media about how to request a COVID-19 vaccine religious

accommodation. The university accused her of “conspiracy or collusion” under its code of conduct, and placed a disciplinary record in her student file, which could potentially affect her future academic or professional pursuits. First Liberty Institute, which is representing her, told the school in a demand letter that it violated her rights under the First Amendment, which protects free speech and religious exercise, and under the federal Fair Housing Act, which prohibits both religious discrimination in housing, and taking actions against a person for aiding others in having their religious rights in housing respected.

--Former 911 dispatcher Sheila Ayers has been fired for failing to assist an employee of the Tops Friendly Market in Buffalo, New York, who whispered a frantic call for help during a mass fatal shooting there last month. Even though the employee said, “He’s still in the store, he’s still shooting! I’m scared for my life, please send help,” Ayers asked in a nasty tone, “Why are you whispering, you don’t have to whisper,” and then hung up the phone. Following an investigation, Erie County Executive Mark Poloncarz said local dispatchers are trained to treat whispering callers as if they are in immediate danger, and “The 911 operator was inappropriate.”

--Caroline Pennington, the CEO of GROWL, an animal rescue organization, was arrested after police searched her Richland County, South Carolina, home and uncovered 30 dead animals left alone in cages for months. A neighbor told authorities there was a “smell of death” coming from her home, and Sheriff Leon Lott called the situation appalling and heartbreaking, saying Pennington “betrayed the trust of [the] innocent animals [that] relied on her.”

--Police in Coeur d’Alene, Idaho – based on a telephone tip - for arresting a large group of right-wing men and charging them with suspicion of “wanting to riot” at a gay pride event, even though nothing was actually carried out, and though nationwide, police frequently allow left-wing extremists to get away with actual rioting.

--Palestinian Authority TV, for creating special television quizzes in which contestants were given the equivalent of \$28 in Jordanian currency if they gave the “correct” answer to questions as “Palestine” instead of “Israel,” because they say that “Israel does not exist.” Questions covered such topics as the borders of the country involved, the highest mountain in the country, the size of the country, and its four seas.

YOU CAN’T MAKE THIS UP

--As a massive caravan of 15,000 COVID-infested illegal aliens headed through Mexico to our southern border – with no requirement to get vaxed before entering our country – the White House occupant announced his plan to “keep America safe” – before



the caravan arrived, to fire 4,000 of the U.S. Border Patrol’s 21,000 agents because they elected not to get vaccinated.

And on our nation’s highest court, a Republican-appointed majority is poised to severely weaken the right to privacy, which poses a direct threat to marriage equality.” Pelosi added, “Democrats have long been proud to march and fight alongside tireless LGBTQ advocates, whether combating the HIV/AIDS crisis, repealing ‘Don’t Ask, Don’t Tell’ or enacting landmark hate crime legislation.”

--Despite taking an oath of office to protect the law and punish those who break it, Virginia prosecutor Steve Descano – a radical financially supported by left-wing extremist and billionaire George Soros – said he will “never prosecute a woman” for aborting a child. While the job of a prosecutor is to protect the law and punish those who break it, apparently that duty doesn’t apply when the law is broken to kill an innocent child. Gender identity refers to a person’s subjective convictions, and to persecute women for refusing to accept subjective convictions they do not agree to, is a human rights violation.”

--Texas Democrat State Representative Terry Meza has introduced a bill to repeal the Lone Star State's "Castle Doctrine," which allows a homeowner to use deadly force against an armed intruder who breaks into his home. FLORIDA REPUBLICAN CONGRESSIONAL DEBATES. With 21 candidates qualified for the Republican Primary Ballot on August 23 for open seats in Florida's 4th, 7th, 13th, and 15th Congressional Districts, the Republican Party of Florida will host several debates. Television host **Mark Levin** will moderate the first two on July 23 at the Seminole Hard Rock Hotel & Casino in Hollywood, Florida. To participate, a candidate must poll at five percent or greater in a poll to be conducted on July 13 or alternatively, raised and publically reported at least \$100,000 in campaign contributions by that date. **Florida Governor Ron DeSantis** said the debates will be a good opportunity for "credible" candidates in those primary races to make their case to Republican voters.



U.S. SUPREME COURT. In a June 13 announcement by the U.S. Supreme Court, the Justices ruled 9-0 against immigrants who are seeking their release from long periods of detention while they fight deportation orders, and 6-3 that the immigrants have no right under federal law to band together to argue for their freedom.... In another 6-3 ruling, the Court determined a criminal defendant's double-jeopardy claim was rejected. He had been prosecuted first in a Court of Indian Offenses and then later in federal court... On June 8, the Court ruled 6-3 to reject a lawsuit against a Border Patrol agent who confronted a man complaining about the use of excessive force.... On June 6, the Court affirmed 7-2 that the Medicaid Act permits a state to seek reimbursement from settlement payments allocated for future medical care; affirmed 8-0 that Congressional enactment of a significant fee increase that exempted debtors in two states violated the uniformity requirement of the bankruptcy clause; and by a 9-0 ruling it reversed and remanded the death sentence of a Texas inmate, rejecting his arguments that Texas state courts had failed to determine whether he had received ineffective assistance of counsel at his trial and sentencing. He had been charged with capital murder during an attempted carjacking while under the influence of PCP-laced marijuana.

RINOS AND THE SECOND AMENDMENT. Republicans In Name Only? Rebbrates Involving Nefarious Operations? Which is it really? The Democrats got their opportunity in Congress to whittle away the Second Amendment when 11 RINOS in the Senate agreed to support gun control legislation – to institute red flag laws and invest in mental health and school security in hopes of preventing future gun violence. Once 10 RINOS join all 50 Dems, any bill will automatically have the 60-vote threshold needed for passage. And they will not care that the Supreme Court has already declared red flag

laws to be unconstitutional, since authorities confiscate weapons even if a crime has not been committed. Texas Senator John Cornyn – who falsely claims to support the Second Amendment – led the effort to hash out an agreement with anti-gunners on the other side on restricting the Second Amendment rights of law-abiding American citizens. The other RINO Senators – Fox News’ Tucker Carlson calls them “pompous buffoons” – are Minority Leader Mitch McConnell of Kentucky, Thom Tillis of North Carolina, Susan Collins of Maine, Bill Cassidy of Louisiana, Lindsey Graham of South Carolina, Pat Toomey of Pennsylvania, Roy Blunt of Missouri, Richard Burr of North Carolina, Rob Portman of Ohio, and Willard “Mittens” Romney of Utah. Five of them will avoid the wrath of their constituents, having already announced their retirement. The others, who haven’t, should be primaried the next time they run. The Patriot Pulse website points out that the RINOs supporting this legislation “are waving the white flag on a fundamental issue to their voters, and Joe Biden is more than happy to sign this gun grab into law.”



COVID VACCINES FOR BABIES AND TODDLERS. Florida Congressman Bill Posey

joined a group of his colleagues in the House and Senate in signing a letter to the Food and Drug Administration calling for answers regarding Emergency Use Authorization approval for use of the COVID-19 vaccines in children ages five and under. The legislators want to

know why the FDA has lowered the efficacy bar for youngest children, how many lives are estimated to be saved in this age group over the next year, how will the FDA evaluate potential tradeoffs of serious vaccine injuries versus serious COVID outcomes, how many healthy children in this age group without pre-existing medical conditions have died or been hospitalized from COVID or its variants, and why has the FDA been so slow to release the hundreds of thousands of pages of data from pre-approval manufacturer studies and post-approval adverse events data. Posey said he is “concerned that in a rush to mandate a one-size-fits-all policy, the FDA is failing to consider that this age group is least at risk for complications from COVID and that the CDC estimates 68 percent of those under five have already had COVID.” He added that “If we don’t receive answers, it is right to assume they haven’t asked basic benefit and risk questions about using this vaccine for millions of children who are at very little risk from COVID.”



Judicial Watch
Because no one is above the law!

Determining that California’s gender quota law for corporate boards is unconstitutional, a California court ruled last month in favor of a Judicial Watch filing in the case of Robin Crest et al. v. Alex Padilla. The challenge was to a 2018 law known as Senate Bill 826, which required every publicly held corporation headquartered in California to have at least one director “who self-identifies

her gender as a woman” on its board of directors. The law also required corporations to have up to three such persons on their board, depending on the size of the board. Judicial Watch had argued that the quota for women on corporate boards violates the Equal Protection Clause of the California Constitution...and California Superior Court Judge Maureen Duffy-Lewis agreed. The Court found that “putting more women on boards demonstrated that the Legislature’s actual purpose was gender-balancing, not remedying discrimination.” Judicial Watch is a Washington, D.C.-based organization that files Freedom of Information Act lawsuits to investigate government misconduct.



Campus Reform, which is part of the Virginia-based Leadership Institute, reports that a private school in St. Augustine, Florida – Flagler College – is creating the Institute for Classical Education, to teach “quantitative reasoning, writing, and historical

literacy,” and the \$5 million funding for it comes from the Freedom First Budget, which **Florida Governor Ron DeSantis** signed on June 2. As expected, Leftist academics are opposed to the move, calling it “the use of taxpayer dollars to implant conservative ideology in public institutions.” A better way to look at it is that the program is committed to helping students think for themselves.... On June 1, during LI’s Wake Up Club Breakfast, **Mark Mix**, president of the



National Right to Work Legal Defense Foundation (NRTWLDF), gave attendees an overview of 20th century actions in the labor movement. Mix said that during the Franklin Roosevelt administration first term, the National Industrial Recovery Act passed Congress, but the U.S. Supreme Court found it to be unconstitutional. Union power existed in the United States from 1935 to 1945, he said, but during the next year, five million workers went on strike. The landmark Wagner Act (introduced by New York Senator Robert Wagner) was passed in 1935 as the National Labor Relation Act, and it obligated employers to bargain collectively with unions selected by a majority of employees. But that was followed, Mix said, by the Labor Management Relations Act of 1947, better known as the Taft–Hartley Act, which is a federal law that restricts the activities and power of labor unions. Since then, he added, Right to Work Laws have been established in 27 states. “Right to Work,” Mix said, is an important part of the dialogue. In 1955, he said, the National Right to Work Committee was formed, and today it is a coalition of 2.5 million workers and concerned Americans fighting to break the chains of forced unionism. The NRTWLDF, Mix said, provides legal assistance against forced union activities. That support was given to Mark Janus, a State of Illinois employee who disagreed with statements his union was making with his dues, and he wanted his money back. The case went all the way to the U.S. Supreme Court, which ruled 5-4 in 2018 that the application of public sector union fees for non-members to cover the cost of non-political

union activities is a violation of the First Amendment right to free speech. Mix said that “freedom works when there are jobs and opportunities for all.” For more information, visit the website: www.nrtw.org.



After more than two decades as the premier defender of free speech, due process, and academic freedom in higher education, the Foundation for Individual Rights in Education (FIRE) is expanding its free speech mission beyond campus and is now the Foundation for Individual Rights and Expression. The \$75 million expansion initiative will focus on three main areas of programming: litigation, public education, and research. **Greg Lukianoff**, FIRE’s President and CEO, said, “America needs a new nonpartisan defender of free speech that will advocate unapologetically for this fundamental human right in both the court of law and the court of public opinion. FIRE has a proven track record of defeating censorship on campus. We are excited to now bring that same tireless advocacy to fighting censorship off campus.” Its new campaign, Faces of Free Speech, will last throughout the remainder of 2022, reaching Americans through national cable television, digital, and billboard advertising. It will be seeking off-campus free speech legal case submissions, and Americans who believe their free speech rights were violated can submit a case at thefire.org/alarm. It also will be hiring additional staff in support of our current and expanded mission. FIRE currently has 15 open positions. Principled free speech advocates can apply at thefire.org/jobs. Lukianoff added that “Our defense of freedom of speech and inquiry on campus will remain central to what we do and will grow in the coming years, but we have come to realize that defending the First Amendment and a culture of free speech off-campus is essential to protecting those values on-campus, just as much as fighting for those values on-campus is essential for preserving them off-campus. We need to remind older Americans that freedom of speech is still a value worth fighting for, and we need to teach younger Americans that everything from scientific progress to artistic expression, to social justice, peace, and living authentic lives requires the staunch protection of freedom of speech for all.”



It was a victory for freelance writers and the Institute for Justice on June 9 when the Virginia Supreme Court ruled that the city of Charlottesville cannot tax these writers like businesses. Novelist and nonfiction writer **Corban Addison**, who lives in the city, was forced to pay thousands of dollars in unpaid business license taxes, and with IJ, sued the city, arguing that these taxes cover infrastructure and other costs of bricks-and-mortar business, but makes no

sense for freelance writers. Charlottesville’s code doesn’t even include authors on its list of taxable occupations. There was victory first in state court, but that was appealed. Now, thanks to the High Court, Corban will receive a refund for the taxes he never should have been made to pay. **IJ President Scott Bullock** called the free speech victory “a win for writers, other freelance creatives, and taxpayers across Virginia.”



Issuing a report on “12 People Canceled by the Left After Expressing Conservative Views,” the Heritage Foundation said cancel culture runs rampant in today’s America. A 10-year-old tweet that mysteriously “resurfaces,” a past campaign donation, or even the slightest critique of any of the left’s sacred tenets seems to be enough to draw the attention of an angry mob – or even get someone fired. With more and more people being “canceled” by the Left, it’s important to remember those folks who’ve lost their livelihoods to cancel culture. Here are the 12 victims of cancel culture who were targeted for voicing a conservative view: 1) John Gibson, the former president of American gaming studio Tripwire Interactive, became a victim of the petulant mob when he lost his job for tweeting in support of Texas’ new pro-life legislation. 2) Nathan Silvester was a police officer working in Bellevue, Idaho, who was fired after he posted a TikTok mocking NBA star LeBron James for his statements following the death of Ma’Khia Bryant, a 16-year-old black girl, who was fatally shot by a white police officer in southeast Columbus, Ohio. 3) Scott Cawthon was the creator of the hugely successful “Five Nights at Freddy’s” video game series who was canceled in June after fans decided to search Open Secrets, a website that lists political donations, for information regarding campaign contributions. 4) David Flynn, the popular head football coach at Dedham High School in Dedham, Massachusetts, lost his job after sending an email to school officials expressing concern that his daughter’s world geography and history classes contained curriculum and materials that were unrelated to the topics and were inherently political. 5) Gina Carano was fired from her leading role on Disney and Lucasfilm’s “The Mandalorian” after the actress posted a story on her Instagram comparing the current political climate to Nazi Germany. 6) Kieran Bhattacharya was a student at the University of Virginia School of Medicine who was banned from campus after he questioned a speaker’s definition of microaggressions during a panel discussion. 7) Ryan Anderson is the author of the bestselling book “When Harry Became Sally,” which details the rise in transgender and LGBT ideology in the U.S. that was removed from Amazon’s digital marketplace after the company claimed it framed “LGBTQ+ identity as a mental illness.” 8) Kate Hartson was the editorial director of the Center Street imprint, a conservative publishing entity under the larger Hachette Book Group umbrella. She was known for buying the rights to publish books by controversial figures associated with former president Donald Trump, including his son Donald Trump Jr. and Corey Lewandowski. 9) Austin Tong was a student at Fordham University in New York who

came under fire for a series of social media posts he made that went against leftist orthodoxy, as reported by the Fordham Observer. 10) Peter Vlaming was a French teacher at West Point High School in Virginia who was fired for not using a transgender student's preferred pronouns. 11) Timothy Gordon was a teacher at Garces Memorial High School, a private, Catholic school in Bakersfield, California, who was fired from his job after he made comments critical of the Black Lives Matter movement, specifically calling it a terrorist organization. 12) Adrianna San Marco was a student at Syracuse University in New York who lost her job writing for her local newspaper after she wrote an op-ed piece for another conservative outlet denying the existence of institutional racism and that police unfairly targeted black people, as reported by Fox News.

A SCAM TO BEWARE. 18th Judicial Circuit State

Attorney Phil Archer, in his June Monthly Brief, warns people to beware "summer slim down scams." With warm weather approaching, Archer writes, many Americans are eager to slim down, and scammers, as always, are attempting to make the biggest loss in our wallets. He points out that according to the Federal



Trade Commission, bogus diet products and programs accounted for nearly 30 percent of all complaints in the category of health care scams. He writes: "Some scammers create websites that look like legitimate magazines and news outlets but fill them with phony articles claiming celebrities have achieved amazing results from various diet pills or herbal supplements. Others utilize social media, posting bogus stories or quietly paying 'influencers' to promote unproven products. Watch out for 'Free Trial Offers' with hidden charges, costly subscription plans, and money-back guarantees that the FTC warns will be almost impossible to collect. The U.S. Food and Drug Administration has discovered that numerous weight-loss products contain drugs such as sibutramine, that was taken off the market because it can significantly increase blood pressure and raise the risk of heart attack and stroke. Even those marketed as 'natural' or 'herbal' can contain ingredients that are toxic in large doses."

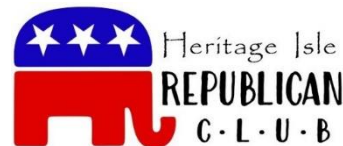

Kayte Campbell, the Brevard County School Board District 5 member who is running for re-election, told the Heritage

Isle Republican Club on June 2 that in light of current events regarding school shootings, there are safety protocols in place to keep them from happening here again, but she added that she could not divulge all of the security methods in place. Campbell pointed out that while August 23 is primary election day in Florida, for non-partisan school board races, it IS the actual election day, so people have to start paying attention now. She also said that Brevard County kept schools



open during COVID and is now back to normal.... Another speaker at our meeting, **Sandra Sullivan**, a Republican candidate in our District 4 for the Brevard County Commission, to succeed term-limited **Curt Smith**. Sullivan said she has been attending County Commission meetings and speaking at hearings for the past four years, and is committed to fiscal responsibility, government transparency, no tax increases, less government, and a capitalist free market. Associate Editor Niall Stange, writing on seven other Republican presidential contenders in 2024 in "The Hill":

"**Former President Trump** is still the dominant figure in the Republican Party but his stranglehold is loosening. Trump-backed candidates have had a mixed record in GOP primaries so far this cycle, with high-profile losses in Georgia, Nebraska and a key South Carolina district undercutting many other wins. The work of the House Select Committee on Jan. 6 also places Trump's role in the insurrection squarely in the spotlight. To be sure, Trump leads early 2024 polls by a wide margin. But there is no guarantee that the ever-unpredictable Trump will enter the race. And there is a growing consensus among Republican insiders that, if he does so, he will face a serious challenge. So, if the 2024 GOP nominee ends up being someone other than Trump, whom might it be? **Florida Governor Ron DeSantis** is Trump's most serious rival at this early stage. The Florida governor has a multilayered appeal. Conservatives loved his pushback against mask and vaccine mandates during the pandemic. He has embraced the culture wars with vigor, including his advocacy of legislation that liberal critics dubbed the 'Don't Say Gay' bill.... **Former Vice President Mike Pence** is in the spotlight, whether it's welcome or otherwise. Though praised by many beyond the GOP, there could be a problem in a presidential primary. Pence's main calling card in such a race would be his closeness to Trump while in office – but the most fervent Trump supporters won't



easily forget what they see as a betrayal on January 6....**Former United Nations Ambassador Nikki Haley**. No-one in Republican politics doubts that Haley, who was twice elected as South Carolina's governor before becoming U.S. ambassador to the United Nations during the Trump administration, has her mind set on higher office. Haley has long been seen as a rising star...**Texas Senator Ted Cruz** ended up in second place to Trump in the 2016 nominating process. Cruz is a down-the-line conservative, and his pugnacious political persona enthralls his supporters. But he also has a habit of rubbing people the wrong way. Cruz's speech at the 2016 Republican National Convention, in which he conspicuously failed to endorse Trump, still sticks in the throats of many of the former president's supporters.... **Former Secretary of State Mike Pompeo's** presidential ambitions seem crystal clear. Within a couple of months of President Biden assuming office, Pompeo was visiting Iowa and helping fundraise for a Republican in New Hampshire, traditionally the two first-to-vote states in the primary process. Pompeo's time as secretary of State and, prior to that, as CIA director, gives him plenty of experience to highlight if the political conversation turns to foreign affairs or national security.... **South Carolina Senator Tim Scott**. If Republicans want a nominee who can unite the pro-Trump and Trump-skeptical wings of their party, and perhaps broaden its appeal among the electorate at large, Scott could be a real contender. Conservatives like Scott's record and up-from-his-bootstraps personal story, even political opponents often like him personally, and he is the sole Black Republican senator.... **South Dakota Governor Kristi Noem** took office in January 2019 but only really came to national attention when she railed against COVID-related lockdowns, insisting that 'more freedom, not more government is the answer.' If Noem decided to seek the White House, she would be one of the most ostentatiously Trumpian candidates in the field. Noem would plainly be a risk, especially given her relatively scant experience on the national stage. And South Dakota, far from the epicenters of media and money, is not the easiest state from which to launch a presidential campaign."

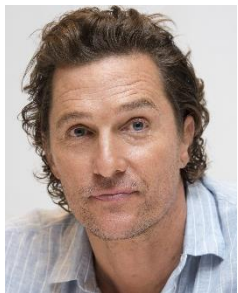


Radio host **Bill Mick**, writing on politicizing tragedies helps no one, in "Florida Today":

"There is a time for politics. In the wake of a tragedy, when emotions are running high, is not it. Elected officials are quick to turn a tragedy into political discourse even before the facts of the situation at hand are known. While the recent shootings in

Buffalo, New York, and Uvalde, Texas, are the basis for the recent rhetoric, it's also true of natural disasters like floods, tornadoes and hurricanes. **President George W. Bush** was criticized for not going to New Orleans soon enough after Katrina. Yet, just what can an elected official do at ground zero of such an event? Provide comfort, reassurance, or promises of financial aid and assistance? Can those things not be done remotely and potentially even more effectively? I

would say so. In Uvalde, **Governor Greg Abbott** was holding a press conference relaying the latest, if inaccurate, information on the tragedy there. He was confronted by gubernatorial opponent Beto O'Rourke with a completely inappropriate tirade over gun policy in the state. Families were grieving and seeking information on what had happened and why their loved ones died. My point is that the situation in the immediacy of the tragedy is not one for political posturing or even clamoring for or against gun rights. In those critical hours after any tragedy, the government officials on the ground should be the ones providing the information. It will be sketchy at first and will come out in bits and pieces as responders work to put the entire picture together. This will often take days, not hours. Local officials are best equipped to gather and then provide the available information. Elected officials from outside the region are not those people. There is no need for any politician to go to an area impacted by any disaster. The higher the office, the less their presence is needed or desired. If their agency or government is able to provide resources or financial assistance, it can be done from their offices, homes or elsewhere via modern communication systems.... We are a divided nation and politicians would love the credit for finding solutions, even if it's not their role. Fast political action is rarely wise and is often disastrous. Florida has the sad distinction of standing as an example. After the shooting at Marjory Stoneman Douglas High School in Parkland, the Florida Legislature crafted the Stoneman-Douglas School Safety Act in just three short weeks that remained in the legislative session. The support was near unanimous and then-**Governor Rick Scott** signed it without hesitation. It was, politically, the prudent thing to do. But was it the right thing to do? Hardly. The bill placed unfunded mandates on our school districts and sheriffs' offices, infringed on the rights of adult Floridians and those infringements, in spite of promises to the contrary, have not been rectified. They also did nothing to stop such an act from occurring again.... There is a time for politics, but it's not, nor should it ever be, immediate. Laws and budgets are in place for the immediate action in the wake of any emergency. They are sufficient for that first response. Anything above and beyond that should wait for the facts to be known, the cause(s) to be determined and the necessary action debated with an eye toward real solutions, not political advantage."



Actor **Matthew McConaughey**, writing on gun responsibility following the mass killing of children in his home town of Uvalde, Texas, in the "Austin American-Statesman":

"I believe that responsible, law-abiding Americans have a Second Amendment right, enshrined by our founders, to bear

arms. I also believe we have a cultural obligation to take steps toward slowing down the senseless killing of our children. It's time we talk about gun responsibility. There is a difference between control and responsibility. The first is a mandate that can infringe on our right; the second is a duty that will preserve it. There is no constitutional barrier to gun

responsibility. Keeping firearms out of the hands of dangerous people is not only the responsible thing to do, it is the best way to protect the Second Amendment. We can do both. Depraved acts of violence, with guns as the weapon of choice, are ripping apart families, tearing at people's faith, and shredding the fabric of our society. We have an epidemic of indiscriminate mass shootings, of parents burying their children, of inaction, and buck-passing. Saving the unnecessary loss of lives is not a partisan issue. The need for mental health care, school safety, the prevalence of sensationalized media coverage, and the decaying state of American values are all long-term societal factors that must be addressed, but right now, we don't have the luxury of time. We need to focus on corrections and countermeasures that can also and immediately reduce the gun violence tragedies that have become too common in our country.... I believe: 1) All gun purchases should require a background check. Eighty-eight percent of Americans support this, including a lot of responsible gun owning Texans....2) Unless you are in the military, you should be 21 years old to purchase an assault rifle. I'm not talking about 12-gauge shotguns or lever-action hunting rifles. I'm talking about the weapon of choice for mass murders, AR-15s. The killer in my hometown of Uvalde purchased two AR-15s for his eighteenth birthday, just days before he killed 19 students and two teachers....3) Red Flag Laws should be the law of the land. These measures, which are already in effect in 19 states and Washington, D.C., empower loved ones or law enforcement to petition courts to temporarily prevent individuals who may be a threat to themselves or others from purchasing or accessing firearms. 4) We need to institute a national waiting period for assault rifles. Individuals often purchase weapons in a fit of rage, harming themselves or others. Studies show that mandatory waiting periods reduced homicides by 17 percent.... Integrating gun safety training, safe storage proposals, and bolstering school safety are also beneficial, but are not government-only solutions. Companies, private organizations, and responsible gun owners have a big role to play. I want to be clear. I am not under the illusion that these policies will solve all of our problems, but if responsible solutions can stop some of these tragedies from striking another community without destroying the Second Amendment, they're worth it. This is not a choice between guns or no guns. It's the responsible choice. It's the reasonable choice.... To find common ground on this issue, both sides are going to have to answer the call and reach for the higher ground of our collective responsibility. Business as usual isn't working.... For ourselves, our children, and our fellow Americans – we have a duty to be responsible gun owners. Please do yours and protect the Second Amendment through gun responsibility. It's time for real leaders to step up and do what's right."
