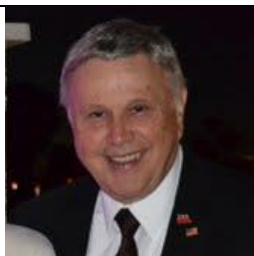

### KENOSHA JURY ACQUITS TEENAGER KYLE RITTENHOUSE OF ALL CHARGES

#### FROM THE EDITOR'S DESK: MY TWO CENTS By Stuart Gorin



Just when I thought the “woke” local newspaper “Florida Yesterday” couldn’t possibly turn more Left, it surprised me again. Writing a hatchet piece on Brevard County Oath Keepers, it reported that the “far-right extremist group urges members to obey the Constitution, as they understand it, even if that interpretation goes against that of U.S. lawmakers and judges.” Where did they get that crazy idea? From the “reliable” Southern Poverty Law Center, of course.

But Oath Keepers is a non-partisan association of current and formerly serving military, police, and first responders, who pledge to fulfill the oath all military and police take to “defend the Constitution against all enemies, foreign and domestic.”

Another of the newspaper’s claims against the group is that they participated in the “violent and deadly assault” on the U.S. Capitol on January 6, saying, “This was not dissent. It was disorder. It posed an existential crisis and a test of whether our democracy could survive.”

To the relief of 18-year-old **Kyle Rittenhouse** – who was facing a possible life in prison sentence – as well as the many supporters who donated to his defense funds, and the legal experts who spoke of his innocence, a jury deliberating in Kenosha, Wisconsin, for nearly four days unanimously came to the decision on November 19 that he was not guilty on all charges – agreeing he had a reasonable belief that his life was in danger and that he acted in self-defense.



Rittenhouse, who lives in Antioch, Illinois, had been facing five counts of fatally shooting two protesters on August 25, 2020, and wounding a third. He was then 17 and explained on the witness stand at his nearly two-week long trial that he had fired his weapon in

self-defense. He was in Kenosha, he said, to help bring calm to the city following demonstrations against police, who had shot a black man, and that led to rioters looting and burning multiple businesses in Kenosha.

As the verdict was announced, Rittenhouse, overwhelmed with emotion, burst into tears and collapsed. After collecting himself, he embraced the defense counsel who represented him.

as he choked through the words about it being his “honor and pleasure” to present the winning trophy to the team, city, and state he recklessly slandered prior to the summer All-Star Game. The “woke” commissioner cost the area millions of dollars by moving that game from Atlanta to Denver, Colorado, because the leftist mob was upset about Georgia enacting an election integrity law.

In his trial, the prosecution sought to portray Rittenhouse as a “wannabe soldier” who went to Kenosha looking for an opportunity to use violence, while the defense argued that he only came to protect property and acted in self-defense after being attacked by the three men he ultimately shot.

Rittenhouse testified that Joseph Rosenbaum, the first man he shot and killed, chased him while a bystander shouted, “get him and kill him.” According to Rittenhouse, Rosenbaum grabbed the barrel of his gun, at which point Rittenhouse shot him four times. Witnesses who testified in the trial described Rosenbaum as “hyperaggressive” and said that he dared others to shoot him and threatened to kill Rittenhouse earlier that night. A videographer testified Rosenbaum lunged for the rifle just before he was shot, and a pathologist said his injuries appeared to indicate his hand was over the barrel.

Anthony Huber, the other protester killed, had hit Rittenhouse in the head with a skateboard, and Gaige Grosskreutz, who was shot in the arm by Rittenhouse but survived, revealed under cross-examination that he pointed his own gun at Rittenhouse first.

Bystander and drone video captured most of the frenzied chain of events. Prosecutors portrayed Rittenhouse as a “wannabe soldier” who had gone looking for trouble that night and was responsible for creating a dangerous situation in the first place by pointing his rifle at demonstrators. However, Rittenhouse testified: “I didn’t do anything wrong. I defended myself.”

Multiple pieces of video evidence showed Rittenhouse being chased and beaten by rioters the night he fired his weapon. Yet, the prosecution argued that the teenager had provoked those he ultimately shot. **Judge Bruce Schroeder** thanked the jury and said they had been wonderful to work with. He said the charges were dismissed, and that Rittenhouse had been released from his bond.

The prosecution had always faced an uphill battle in the case. Under Wisconsin law, the defense must only cite some evidence for self-defense, putting the burden of proof on prosecutors to negate that claim beyond a reasonable doubt.

Prosecutors Thomas Binger and James Kraus received rebukes from the judge and a motion for mistrial by the defense when they tried to introduce a video of Rittenhouse saying a few weeks before the riots in Kenosha that he wished he had his gun to shoot some people he thought were shoplifting. The judge had ruled that video wasn’t relevant to the specific circumstances of the case and had barred its use. The defense and judge also criticized a line of questioning by the prosecution that appeared to impugn Rittenhouse’s right not to testify.

Following the jury’s announcement, former **Assistant U.S. Attorney Andy McCarthy** called it “a just verdict,” and law school professor **Jonathan Turley** said, “Desperate prosecutors rushed charges against Rittenhouse and cut corners in the trial.” **Media Research Center President Brent Bozell** said the liberal liars with the media continue to paint Rittenhouse as “racist and evil despite any evidence, and “The attacks on truthful reporting have escalated as the liberal bias in the media is being exposed more than ever before.”

## REPUBLICANS VICTORIOUS IN OFF-YEAR STATE AND LOCAL ELECTIONS

In America’s 2021 Off-year Elections on November 2, the big “Red Wave” Republican victories stretched from sea to shining sea.



Virginia, the soon-to-be-formerly “blue state,” set the pace early, electing Conservative Republicans to replace Democrats as Governor, Lieutenant Governor, and Attorney General. Businessman **Glenn Youngkin** defeated former Democrat Governor Terry McAuliffe by three percentage

points in a state where an incumbent cannot serve a second consecutive term.

Youngkin focused his campaign on supporting parents opposed to local school boards' treatment of students, while McAuliffe unsuccessfully tried to nationalize the gubernatorial race by bringing political figures to the state to campaign on his behalf. McAuliffe also made a late-stage stumble by suggesting during a debate that parents should not play a role in shaping school curriculums.



Former Virginia state legislator and military officer **Winsome Sears** won the Lieutenant Governor's race as the first African-American woman so elected, and Cuban-American attorney **Jason Miyares** was successful in the Attorney General

contest. Ironically, the "woke" Democrats accused Republicans of playing the race card.

In a "Red Scare" moment, New Jersey -- the only other state to hold an off-year gubernatorial election -- saw incumbent Democrat Governor Phil Murphy narrowly defeat Republican businessman and former member of the State General Assembly **Jack Ciattarelli**, who came close to pulling a stunning upset.

But not all was lost in the Garden State. Republican political newcomer and commercial truck driver **Edward Durr** was victorious in South Jersey's 3<sup>rd</sup> Legislative District, defeating Democrat State Senate President Steve Sweeney.

Discussing the Virginia and New Jersey election results, political consultant **Karl Rove** suggested that perhaps the problem for Democrats was that Republicans and independents were energized much more "by the belief that President Biden is mishandling inflation, spending, Covid, immigration, Afghanistan and other issues." Fox Business News host **Charles Payne** called it "a rebuttal of the Socialist wave." And conservative political commentator **Ben Shapiro** ironically offered "condolences to Virginia on becoming radically racist again -- by electing a black female lieutenant governor and a Cuban-American attorney general, rejecting racial essentialism in schools, and replacing a Democrat governor (Ralph Northam) who wore an actual KKK outfit."

In Ohio's 15<sup>th</sup> Congressional District, where **Representative Steve Stivers** resigned to take over as head of the state's Chamber of Commerce, the special election to replace him on November 2 resulted in victory for another Republican, former coal lobbyist **Mike Carey**.

The only races that occurred in Florida were local non-partisan ones, where the candidates were not allowed to state their party affiliation -- but that did not stop supporters from "spreading the word" to eligible voters.

The election in Cape Canaveral saw City Council member **Wes Morrison**, a Republican, defeat three other challengers to become the city's next mayor, and **Don Willis** won a seat on the City Council.

Other Republicans who were successful on November 2 were **David Panicola**, for a seat on the Indian Harbor Beach City Council; **Gary Ingram**, for a seat on the Melbourne Village Town Council; and **Hurrol Brinker**, as a Barefoot Bay Recreation District Trustee.

A number of candidates for local positions had no opposition and were automatically elected prior to November 2. Republicans on this list were: **Julie McKnight** and **Doug Wright**, to seats on the Indian River County Council; **Mary Hofmeister** to the Malabar Town Council; **Tabitha Niemann** as Melbourne Village Mayor; **Sherri Quarrie** as Melbourne Beach Commissioner at Large; **Paul Bonville** and **Frank Falcone** to Palm Shores Town Council seats; and **Ted Hartselle** and **Duane Daski** to Rockledge City Council seats.

In Texas, Republicans **John Lujan**, a former fire fighter, flipped the House District 118 seat in a special election on November 3, and **Andrew Yeager**, a sales director, won an open seat on the Southlake School Board.

In New York's heavily blue state, Republicans **Joann Ariola** was elected New York City District 32 Councilwoman, and prosecutor **Ray Tierney** was victorious in the race for Suffolk County District Attorney.

In the "Left Coast" state of Washington, Republicans **Nate Nehring** and **Sam Low** won council seats in Snohomish County.

In Minneapolis, the birthplace of the "Defund the Police" movement, and in Oak Park, Illinois, voters rejected ballot initiatives in favor of that movement.

In 25 states, there were a total of 463 school board seats on the ballots. One of the most satisfying results was in Braintree, Massachusetts, where former teacher and military veteran **Matthew Lynch** was elected to a seat despite having been forced to resign his teaching position and smeared as a "domestic terrorist" after photos appeared on line of him at the U.S. Capitol Building on January 6.

### LET ME BE FRANK By Space Coast Tusk Designer Frank Montelione



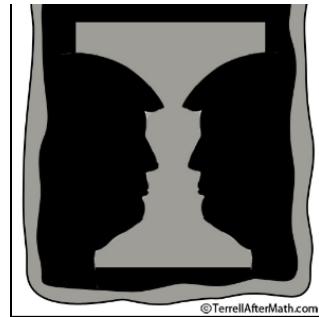
It has been almost a year that the Biden Administration has taken office. He promised an inclusive administration that represented all Americans.

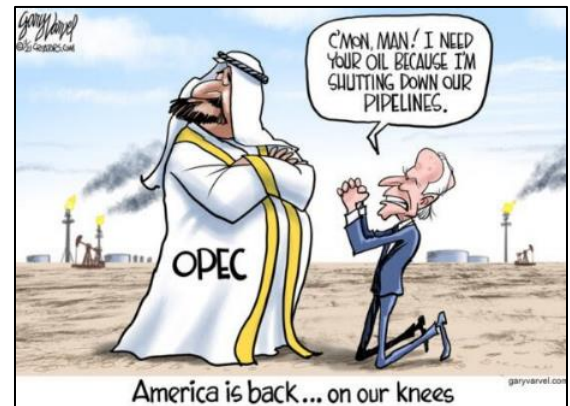

**Nick Adams** -- an author, news commentator, founder of FLAG (Foundation for Liberty and American Greatness), and legal immigrant from Australia –

was the enthusiastic guest speaker at our Brevard Federated Republican Women meeting on November 3.

Adams shared his inspirational message and how America is "the beacon of hope for so many around the world," saying, "If you don't love America and respect the flag and anthem...LEAVE."

He said he chose to come to the United States "because it is the greatest country in the world," adding, "We need to know



how lucky we are to call this home." The United States affords the most freedom and the most opportunity to everyone wishing to pursue their own happiness and prosperity, Adams said, and the United States is about equal opportunity for all – it's about "e Pluribus Unum," not political correctness. "It's about equity – our innate idea of being just and fair. This idea is unique in the world," he said.

We are proud to stand alongside businesses and provide some sanity and options to treat their employees as the individuals they are instead of succumbing to a one-size-fits-all federal mandate.” **Senate President Wilton Simpson** said, “We will not allow the Biden Administration to make political pawns of the very people who put their lives on the line to keep our economy running while everyone else was safe at home, and we certainly will never cede the responsibility of parenting to the school system or bureaucrats in the federal government.” The measures create a framework for employees to make the best decision for their health and affirming the rights of parents to make health care decisions for their children; create a public records exemption for information, including personal medical information and religious information, contained in files created during an investigation of an employer who refuses to provide individual exemptions from COVID-19 vaccination requirements; directs the Executive Office of the Governor to review options for Florida to take responsibility over our own workers’ occupational safety and health issues in light of the misuse of OSHA by the Biden Administration; and repeals the authority of the state Surgeon General to mandate vaccinations.

**FLORIDA GOVERNOR RON DESANTIS.** On November 1, exactly 365 days before the 2022 mid-term election, **Florida’s Republican Governor Ron DeSantis** officially announced his re-election campaign. Highlighting the accomplishments of his first term in office, he said he has “delivered on all fronts: Florida’s economy is strong, we’ve boosted teacher pay, made historic investments in Everglades restoration and water quality, signed strong election integrity legislation, provided unparalleled support for law enforcement and appointed strong constitutionalists to our state courts.” DeSantis added that he also “protected

individual Floridians and small businesses by keeping Florida open and stood up for students and parents by ensuring schools provided in-person instruction and by championing the rights of parents.” And, he said, “We’ve also taken on Big Tech censorship, banned sanctuary cities, ensured that municipalities cannot defund law enforcement and stood up to the Biden regime.” In his management of the pandemic at the state level, the Governor earned a reputation for confronting and defending against federal encroachment. He prohibited mask and vaccine mandates in public institutions, specifically in Florida school systems, despite resistance and retaliation from the Biden administration. Amid intense backlash from media outlets over his exercise of authority to achieve conservative policy outcomes, DeSantis’ support among constituents has remained strong. An August poll conducted by BUSR/Susquehanna Polling and Research showed him leading Democratic challengers Charlie Crist and Nikki Fried by three points and ten points, respectively, in hypothetical gubernatorial matchups.

### **FLORIDAMAKESMORE MANUFACTURING**

**SUMMIT.** Participating in a virtual manufacturing summit organized by the FloridaMakesMore organization on October 26, **Florida District 14 State Senator Tom Wright** said there is a definite need for educated “worker bees” in the state, and “we have to help our educators to produce these people who can work in our facilities.” He also spoke of his efforts to help military veterans find employment, noting that those who have 180 days of service or less left to serve can continue to receive their pay and benefits from whichever branch of the service they are in, and “choose to come back home and be an apprentice in a company in their area.” One example, Wright said, involves commercial driving licenses. “Let’s say we have a veteran who has been driving a truck in the Army but doesn’t have a CDL. These men and women know how to drive these big rigs, so why don’t we let them run them while they get their CDLs,” he added. Other members of the panel were **Lockheed Martin Director of Government Relations Joe Mayer; Florida District 26 State Representative Elizabeth Fetterhoff; Associated Industries of Florida CEO Tom Feeny and FloridaTaxWatch President Tony Carvajal.** Their main topics were finding people with the skills for emerging technologies, developing resilient and sustainable supply chains, accelerating the adoption of the smart factory and industry 4.0 technologies, and attracting the next generation of manufacturers.



**MORE ON THE PHONY STEELE DOSSIER.** Federal authorities on November 4 arrested Russia analyst Igor Danchenko, the primary researcher behind the Steele Dossier, a collection of unsubstantiated opposition research linking the 2016 Trump campaign to the Kremlin. John Durham, the special counsel tapped by the Trump administration to audit the Russia investigation for malfeasance, brought the indictment. It was determined in the months following the

2016 election that many of the claims made by former British intelligence agent Christopher Steele, who hired Danchenko, were either unverified or erroneous. The dossier created the collusion allegation that Trump “accepted a regular flow of intelligence from the Kremlin, including on his Democratic and other political rivals.” Later, Steele was accused of peddling a hoax of Russian election interference to undermine Trump’s campaign with the dossier, which was funded by the Clinton campaign through its law firm Perkins Coie. The firm also employed Clinton campaign lawyer and former federal prosecutor Michael Sussmann, who Durham also recently charged for allegedly making a false statement to the FBI concerning the Trump Organization’s use of a secret server to communicate with a Kremlin-connected Russian bank.

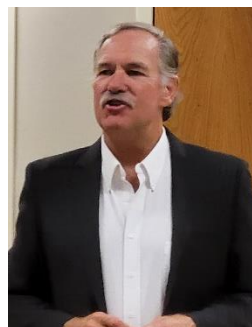


**RINOS AND INFRASTRUCTURE.** No thanks to 13 RINOs in the House of Representatives, Democrats were able to pass Joe Biden’s \$1.2 trillion infrastructure bill on November 5. While the measure does fund improvements for the country’s roads, bridges, railroads, airports, water systems

and ports, public transit, school buses and ferries, charging stations, as well as the Electrical Grid and the Internet, the majority of the funding is for non-infrastructure items, such as investments in the Green New Deal, climate change, social programs, and projects to create more programs to increase the size of the federal government. Because several progressives in the Democrat Party were opposed, the votes by the RINOs gave the bill the necessary backing to pass. These Republicans-In-Name-Only were Don Young of Alaska; Adam Kinzinger of Illinois; Fred Upton of Michigan; Don Bacon of Nebraska; Chris Smith and Jeff Van Drew of New Jersey; Andrew Garbarino, John Katko, Nicole Malliotakis and Tom Reed of New York; Anthony Gonzalez of Ohio; Brian Fitzpatrick of Pennsylvania; and David McKinley of West Virginia. In August, the bill passed in the Senate, but in the House, Speaker Nancy Pelosi did not have enough votes to pass it until the RINOs joined her ranks.

**NEW MILLENNIUM CONSERVATIVE CLUB.** Retired

**U.S. Navy Seal Lieutenant Dan Wilson,** addressing the New Millennium Conservative Club in Suntree, Florida, on November 15, said that while America today is divided between the Right and the Left, he is confident that We the People “still have a hand in the game and can help determine our own future.” Organizations like New Millennium are needed to step up to the plate and make a difference, he said, because they “have a heart for the people.” Wilson pointed out that America was “a planned event for the world at the right time and the right place,” but today, the media is trying to separate and divide us. There is always something, he said, but racial differences are not the issue. He



pointed out that President Abraham Lincoln said “a house divided will fall,” and we cannot let that happen – “not on our watch.” Speaking of his long career of service, Wilson said he enlisted in the U.S. Navy at age 17 without even graduating from high school, but while in the service he did earn his diploma and college graduate credits. He served in the Navy for 22 years, first onboard a ship in South East Asia during the Vietnam War, then as a Corpsman with the Marines, a member of Seal Team-5, and a commission with the Medical Services Corps. After 22 years, Wilson retired as the head of Navy Medicine’s Military Construction Planning and Programming Division, but then served 19 more years as the contracted Program Manager for Design, Development and Deployment of the Defense Department’s Health Facilities Management Software Programs. **LEADERSHIP INSTITUTE.** At Wednesday Wake-Up Breakfast Club meeting of the Leadership Institute in Virginia on November 3, joined on zoom by

donors throughout the U.S., **Florida 19<sup>th</sup> District Congressman Byron Donalds** expressed criticism of the Left’s Critical Race Theory, and said that “black children are not oppressed, and white children are not oppressors.” Donalds, who worked in the economics field after graduating from college, did not have an interest in politics, and only cared about the economy, said that politics did find him and he got into the Tea Party movement. He said the danger that exists today in academia is the “devaluation of individualism and humanity.” His message to fellow Republicans, Donalds said, is “It is now time to lead with principles and policies.” Explaining how to have a winning political campaign is to get out and talk to people, he said, adding that “candidates who only spend their campaign funds on TV ads wind up losing.” The Democrats “cannot save the midterm elections in 2022, he said, adding “that ship has sailed.” Donalds praised the work accomplished by the Leadership Institute, saying what everyone there accomplishes is “so powerful for the Conservative movement.” **Leadership Institute President and Founder Morton Blackwell** spoke briefly at the meeting, noting the many hours and days that LI campaign trainers worked on **Virginia Governor-elect Glenn Youngkin**’s successful off-year election the previous day.



**ACT! FOR AMERICA SPACE COAST CHAPTER.** Retired **U.S. Army Colonel and former CIA Operations Officer Bill Prince** gave a presentation

titled “Critical Race Theory (CRT) in the U.S. Military” to the Space Coast Chapter of Act! For America on November 3. According to Prince, CRT divides the world into “white





oppressors” and “non-white victims.” He emphasized that if allowed to fully infect our military, CRT would have a “devastating impact on troop morale and unit cohesion.” A graduate of the U.S. Military Academy at West Point, Prince said what is occurring at the school now “would not have happened in my day.” He showed the group a recent disturbing photo of Black female cadets there – not at attention but raising the black power salute. Prince said the use of CRT was first proposed by the late leftist Professor Derrick Bell of Harvard University. Prince advised that when President Trump was in the White House, he signed an executive order banning CRT in the federal government and the military, but that order was rescinded when Joe Biden assumed the office. Prince said, “We need to support candidates who are against CRT.” The proposed “Combating Racist Training in the Military Act” has more than 100 co-sponsors, but not a single one of them is a Democrat. Prince noted that Chairman of the Joint Chiefs of Staff Mark Milley is on record as saying he “wants to understand white rage.” Regarding the disastrous troop pullout from Afghanistan, where American citizens left behind are still trapped by the Taliban, Prince said there are only two scenarios, both of which should require Milley and Secretary of Defense Lloyd Austin to resign their positions. The first, Prince said, would have been if the two men had failed to stress to Biden the importance of keeping the troops there to protect removal of all the American civilians first. The second scenario, he said, would have been if they so advised Biden, and he refused to listen to them; then they should have resigned in protest. Prince, who also is a former head of the Act! **Tony Verzi**, the ACT! chapter’s vice president, said in his monthly “Frauds, Crooks, Criminals and Illegals” column that the pharmaceutical giant Merck is set to get \$712 per treatment for its new COVID 19 anti-viral pill from taxpayers. 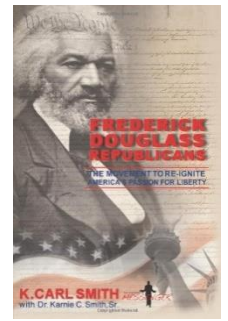
**REPUBLICAN LIBERTY CAUCUS OF CENTRAL EAST FLORIDA.**

The founder and CEO of the Alabama-based Frederick

Douglass Republican Engagement Strategy, **K. Carl Smith**, told the



Republican Liberty Caucus of Central East Florida meeting in Melbourne on November 1 that “we have a messaging problem, not a message problem.” He explained that the problem is “knowing how to react to liberals calling us racist.” One thing he urged the members to do is “not call yourself Conservative, but just be one,” and refer to yourselves as “Frederick Douglass Republicans.”



Smith, who wrote the book “Frederick Douglass Republicans: The Movement To Re-ignite America’s Passion For Liberty,” pointed out that Douglass, who was born a slave in 1818, taught himself how to read and write, as a free man wrote three autobiographies and a novel, and served as an adviser to five Republican U.S. Presidents. Douglass’ life was so inspiring, Smith said, that he was “more important to liberty and the Constitution than what the Founders accomplished.” Comparing Douglass to the Communist founder Karl Marx, Smith said both men were born in the same year, but while Douglass was a human rights thinker and a reformer who believed in liberty, personal responsibility and God over party and government, Marx was a political theorist and revolutionary who believed in government dependence, slavery, and no God. The bridge that connects conservatives to all Americans, Smith said, “has nothing to do with skin color.” Discussing the Critical Race Theory that is infecting our country today, he pointed out, “divides America by skin color; evolved from Marxist ideology; calls whites “racist with no redeeming qualities;” and teaches against God, America and Conservatives.” Smith said his message with the Frederick Douglass Republican Movement “is not to tell people how to vote, but to enlighten and educate them about their vote – to help people understand that voter apathy is the number one killer of liberty.” For additional information, visit the website: [www.kcarlinc.com](http://www.kcarlinc.com).

**RONALD REAGAN CLUBS. Florida District 32 State Representative Anthony Sabatini,**

who is running next year for a U.S. Congressional seat, told members of the Ronald Reagan Clubs meeting in Melbourne on October 27 that proposed legislation he supports at both the state and federal levels includes ending vaccine mandates, stopping “woke” capitalism, cracking down on big tech, preventing election fraud, ending illegal immigration, protecting the Second Amendment, banning trans men from competing in girls’ sports, creating term limits for every politician, and naming U.S. Highway 27 in Florida “The President Donald J. 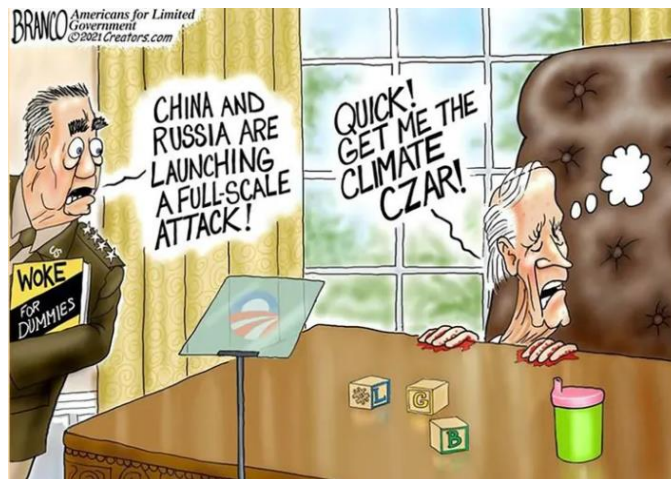

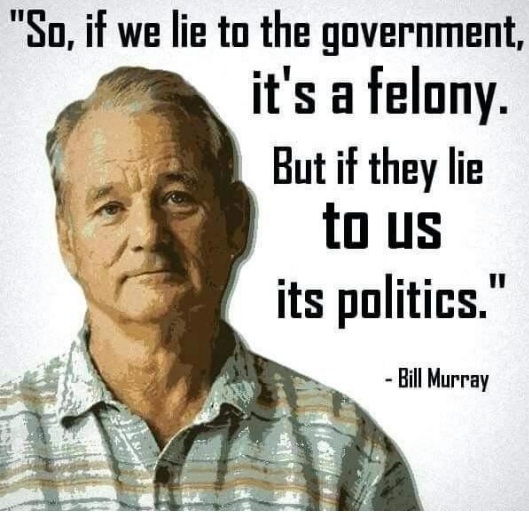

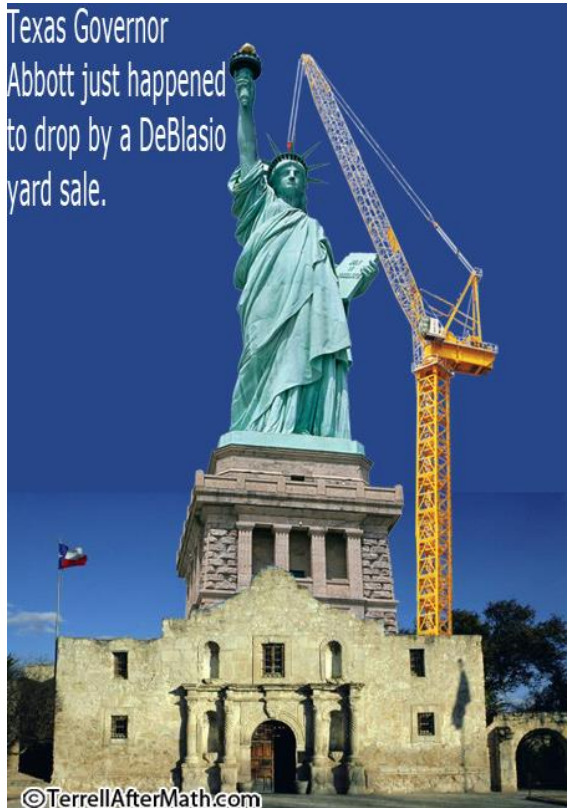
