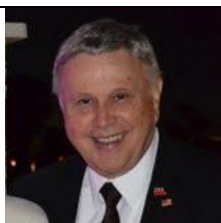

A small group of RINOs consisting of members and former members of the Brevard Republican Executive Committee (BREC) – supported by Tallahassee's Republican Party of Florida (RPOF) – tried to destroy the effectiveness of BREC at the end of this year by "voting" to replace hard working Republicans with their own cronies.

It was all accomplished at a November 24 meeting that they declared was "valid" by RPOF standards – even though only seven RINOs actually voted, ignoring the more than 150 other people in the room who were unaware of what had occurred until they were told about the vote after the fact. This "Unmagnificent Seven" group "elected" John Dittmore to be the new BREC chair. Absurdly, the Republican Party of Florida claimed jurisdiction and "validated" the action.

In response, BREC held another meeting on December 6, and a quorum of the membership elected Acting Chair Dave Fosdick to serve full time in the position. Since former Brevard State Committeeman Randy Fine – who is part of the cabal – resigned because he is now a U.S. Congressman in another Florida district, BREC elected Marc Arrigo to the position. Rich Nink was elected Vice Chair, and Wayne Twiddy remains as Secretary. And the meeting attendees UNANIMOUSLY voted to reject the cabal's November "vote." Fosdick noted sadly that the Brevard Republican

Executive Committee is “a REC divided,” and overall, the organization is “in stasis” until RPOF reviews and takes action on the dozens of grievances that have been submitted regarding the fraudulent November election.

Leading to the division, following the December meeting, RPOF Chairman Evan Power reportedly claimed that “They’re not allowed to just call an extra meeting whenever they want. We told them not to hold that meeting.”

As a BREC member for just four years, Fosdick points out that many members have been involved for decades, and they have an invested interest in its existence and are quite angry with what has happened. The “uprising” is just gaining

momentum, and some members have discussed taking legal action.

If any rational person were to take a look in detail of the substance of the fraudulent election that occurred on November 24, he said, “they would notice a skillfully put together narrative. It was a long, carefully woven together piece of work which incorporated falsehoods with certain facts which might make it appear real to a casual reader. But the narrative crumbles when you ask the majority of people present that evening if they witnessed what was described. It is disappointing that the RPOF hasn’t yet reviewed the substance of what actually happened.”

Fosdick added that the “transparently elected” leadership is making plans to hit the ground running in the New Year. It is important that we start strong as it is a mid-term election year.

At one time BREC was an organization of pride, devoted to supporting and electing conservative Republicans to public office, providing citizens with important voting information, supporting charitable events, and holding successful dinner programs to have people hear from high ranking elected officials. It has been an honor to personally be an elected BREC precinct committeeman.

BREC’s problems began when the RPOF – urged by the cabal – removed long-time Chairman Rick Lacey from his position, alleging that he “violated rules outlined in the party’s official procedures” – a move he vigorously denies.

Now, unfortunately, BREC is just a shell of its former self, having been sabotaged by a vicious combination of RINOs (Republicans In Name Only) who were elected as state committee people and party officials of the RPOF in Tallahassee.

TRUMP DECEMBER 17 SPEECH

President Donald Trump addressed the nation in a nationally televised speech from the White House on December 17 on the achievements in his second administration's first 11 months, noting that he inherited a mess from the Biden Administration, and is “fixing it”.



A highlight of the remarks was his announcement that nearly 1.5 million U.S. military service members would be receiving a \$1,776 “warrior dividend” coming from tariff revenue, basing the amount on the 1776 birth of America.

He also said in the 20-minute speech that crime was at “record highs” and that the country had “the worst trade deals ever made” under his predecessor. He also blamed immigrants

without legal status and Democratic politicians for affordability issues.

Following are excerpts of his remarks:
(Begin Excerpts)

When I took office...Our border was open, and because of this, our country was being invaded by an army of 25 million people, many who came from prisons and jails, mental institutions and insane asylums. They were drug dealers, gang members and even 11,888 murderers, more than 50% of whom killed more than one person.

This is what the Biden administration allowed to happen to our country, and it can never be allowed to happen again. We had men playing in women's sports; transgender for everybody; crime at record levels; law enforcement, and words such as that, just absolutely forbidden. We had the worst trade deals ever made, and our country was laughed at from all over the world, but they're not laughing anymore.

Over the past 11 months, we have brought more positive change to Washington than any administration in American history. There has never been anything like it, and I think most would agree, I was elected in a landslide, winning the popular vote and all seven swing states and everything else with a mandate to take on a sick and corrupt system that really just took the wealth from people and crushed the dreams of the American people....

For the past seven months, zero illegal aliens have been allowed into our country, a feat which everyone said was absolutely impossible.

Do you remember when Joe Biden said that he needed Congress to pass legislation to help close the border? He was always blaming Congress and everyone else. As it turned out, we didn't need legislation. We just needed a new president.

We inherited the worst border anywhere in the world, and we quickly turned it into the strongest border in the history of our country. In other words, in a few short months, we went from worst to best.

We're deporting criminals, restoring safety to our most dangerous cities. Just take a look at Washington, D.C. It's at levels of safety that we've never seen before, and they decimated the bloodthirsty foreign drug cartels. We did that all by ourselves, with our people, and we're so proud of it, because they were poisoning and destroying our population.

Drugs brought in by ocean and by sea are now down 94%. We have broken the grip of sinister woke radicals in our schools, and control over those schools is back now in the hands of our great and loving states where education belongs....

You will see in your wallets and bank accounts in the new year, after years of record setting, falling incomes, our policies are boosting take home pay at a historic pace. Under Biden, real wages plummeted by \$3,000; under Trump, the typical factory worker has seen a wage increase of \$1,300 for construction workers, it's \$1,800; for miners, we're bringing

back clean, beautiful coal it's \$3,300 and for the first time in years, wages are rising much faster than inflation....

Next year, you will also see the results of the largest tax cuts in American history that were really accomplished through our great, big, beautiful bill, perhaps the most sweeping legislation ever passed in Congress, we wrapped 12 different bills up into one beautiful bill that includes no tax on tips, no tax on overtime, and no tax on Social Security for our great seniors.

Under these cuts, many families will be saving between \$11,000 and \$12,000 a year, and next spring is projected to be the largest tax refund season of all time, because of tariffs, along with the just passed one big, beautiful bill.

Tonight, I am also proud to announce that more than 1,450,000, think of this 1,450,000 military service members will receive a special we call "warrior dividend" before Christmas, a "warrior dividend" in honor of our nation's founding in 1776. We are sending every soldier \$1,776. Think of that, and the checks are already on the way....

In addition, I'm doing what no politician of either party has ever done, standing up to the special interest to dramatically reduce the price of prescription drugs. I negotiated directly with the drug companies and foreign nations, which were taken advantage of our country for many decades, to slash prices on drugs and pharmaceuticals by as much as 400, 500 and even 600%....

The current "Unaffordable" Care Act was created to make insurance companies rich. It was bad health care at much to higher cost. And you see that now in the steep increase in premiums being demanded by the Democrats, and they are demanding those increases, and it's their fault. It is not the Republicans' who are at fault. It's the It's Democrats' fault. It's the Unaffordable Care Act" and everybody knew it....

On day one, I declared a national energy emergency. Gasoline is now under \$2.50 a gallon in much of the country. In some states, it, by the way, just hit \$1.99 a gallon and within the next 12 months, we will have opened 1,600 new electrical generating plants, a record, and it's a record that won't be beaten by practically, I would say, by anybody, or certainly not very soon, prices on electricity and everything else will fall dramatically.

The Democrat inflation disaster, again, the worst in the history of our country, also rob millions of Americans of home ownership, and indeed the American Dream, the yearly cost of a typical new mortgage increased by \$15,000 under Democrat rule....

We have never been invaded. This is the worst thing that frankly, in my opinion, the worst thing that the Biden administration did to our country is the invasion at the border. The last administration and their allies in Congress brought in millions and millions of migrants and gave them taxpayer funded housing, while your rent and housing costs

skyrocketed. Over 60% of growth in the rental market came from foreign migrants.

At the same time, illegal aliens stole American jobs and flooded emergency rooms, getting free healthcare and education paid for by you, the American taxpayer. They also increased the cost of law enforcement by numbers so high that they are not even to be mentioned....

Our nation is strong. America is respected, and our country is back stronger than ever before.

We are poised for an economic boom the likes of which the world has never seen. Soon, we will host the World Cup and the Olympics, both of which I got, but most importantly, we will celebrate the 250th anniversary of the Declaration of Independence.

There could be no more fitting tribute to this epic milestone than to complete the comeback of America that began just one year ago, when the world looks at us next year, let them see a nation that is loyal to its citizens, faithful to its workers, confident to its identity, certain to its destiny and the envy of the entire globe, we are respected again, like we have never been respected before.

SOUNDS FROM THE TRUMP-ET

--President Trump signed an executive order on December 18 directing Attorney General Pam Bondi to expedite the reclassification of cannabis, to allow medical research to check the potential benefits of medical marijuana, which under existing classification is prohibited.

--Following the tragic shooting of two National Guard members in Washington last month, President Trump has ordered that every member patrolling the nation's capital now be fully armed. This crucial decision protects our deployed troops and aligns with the Trump administration's commitment to Law and Order missions. Many Guard troops are now conducting joint patrols alongside local police.

He also said that as part of a crime crackdown effort in New Orleans, in a couple of weeks he will be deploying National Guard troops in that city.

MAYFIELD MINUTE

--Florida Governor Ron DeSantis released his 2026-27 proposed "Floridian's First" budget proposal totaling \$117 billion, which is \$2.2 billion more than the current year budget. The recommendation emphasizes fiscal responsibility, record reserves, and major investments in education, law enforcement, infrastructure, and environmental restoration.

"This budget is entitled Floridians First because that is the focus of it," DeSantis said. "It is putting our people first and making sure we are good stewards but also making sure the needs that we have are being addressed."

Some of the highlights include:

- Education: \$1.56 billion for teacher salary increases; \$1.7 billion for early childhood education
- **Law Enforcement:** \$25 million for \$5,000 recruitment bonuses to attract new officers; \$13.5 million for state law enforcement officer salary increases
- **Military:** \$91 million for National Guard; \$62 million for State Guard

- **Health Care:** \$278 million for cancer research initiatives; \$159 million for behavioral health services
- **Environment:** \$1.4 billion to ongoing environmental restoration projects; \$208 million to strengthen Florida's coastline including beach restoration
- **Conservation:** \$200 million for the Rural and Family Lands Program; \$115 million for the Florida Forever Program; \$70 million for infrastructure improvements to Florida's state parks
- **Transportation:** \$29 billion for FDOT and transportation projects
- **Affordable Housing:** \$170 million for the State Housing Initiatives Partnership program; \$72.9 million for the State Apartment Incentive Loan program; \$50 million for the Hometown Heroes down payment assistance program
- **Fiscal Responsibility:** \$1.09 billion to increase total reserves to \$16.75 billion; \$118 million for the Budget Stabilization Fund

The Florida Senate and House of Representatives will take these recommendations into consideration as we prepare Florida's budget for Fiscal Year 2026-2027 during the upcoming legislative session.

Attorney General James Uthmeier announced the launch of Florida's Retail Theft Investigative Special Task Force to aggressively combat organized retail theft in Florida, saying, "Shoppers suffer when retail thefts drive up prices. This partnership between law enforcement and the Florida Retail Federation will help keep prices down and put criminals behind bars."

The Retail Theft Investigative Special Task Force equips local law enforcement with statewide tools and resources, removes jurisdictional barriers, and enables prosecutors to ensure repeat offenders will be prosecuted to the fullest extent of the law. The primary goal of the task force will be to ensure swift action against organized retail theft rings.

Port Canaveral has officially surpassed PortMiami as the world's busiest cruise port. With more than 8.6 million passengers in 2025, the highest number in Port Canaveral's history, the port has overtaken PortMiami by 100,000 passengers.

The 2025 passenger numbers are a significant 13% increase from 2024, when Port Canaveral welcomed 7.6 million passengers. In comparison, PortMiami grew only by 4.02% from 2024 to 2025.

Port Canaveral is currently homeporting 18 ships across seven cruise lines, with more than 1,000 sailings scheduled annually. The port's five-year development plan includes a \$912 million investment in expansions of two existing terminals, a seventh cruise terminal, and technological advancements to ensure smooth processing for guest departures and arrivals.

Newsweek magazine named Florida Tech the top online college in Florida and 10th best in the nation. Twenty-one Florida colleges were among the 250 institutions on Newsweek's Best Online Colleges 2026 list. University of South Florida was the second highest Florida college at No. 35. The University of California, Davis was No. 1.

For the 2026 rankings, Newsweek conducted a survey of more than 10,000 students enrolled in online courses to earn an academic degree or gain knowledge for jobs or hobbies. The schools were ranked based on organization, support, price, reputation, success, and practical relevance.

The U.S. Department of the Air Force gave SpaceX approval to build a launch and landing pad for its Starship spacecraft at Cape Canaveral Space Force Station's Space Launch Complex 37.

After months of input from the community, the Air Force's decision is the official "green light" SpaceX needed to bring its Starship to Brevard County from Texas. To address community concerns, the Department of the Air Force says it will implement mitigation measures, including habitat restoration, to account for environmental impacts.



AN UPDATE FROM MY OFFICE

The past several weeks have been productive and encouraging as we continue preparations for the upcoming Florida Legislative Session.

The last two interim committee weeks went very well and provided a strong start to what will be a busy and important year ahead for Florida and for the Space Coast.

Committee weeks are when much of the real work begins. This is where legislation is first heard, debated, and refined, and where legislators have the opportunity to hear directly from stakeholders, agencies, and the public. I am pleased to report that we are already off to a solid start. I have presented several bills in their first committee of reference, an important early step in the legislative process. One notable example was Senate Bill 356: Utility Terrain Vehicles, which I presented before the Senate Committee on Transportation on December 9. 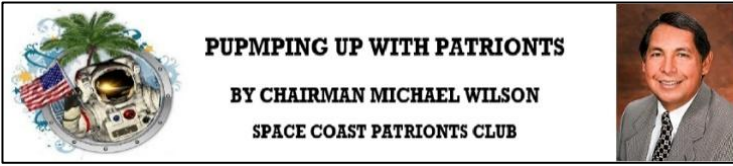


This inaugural party was a resounding success and a memorable way to close out the year. Thank you to everyone who attended and contributed to making it such a joyful occasion!

THIS AND THAT

KENNEDY CENTER. The Kennedy Center Board of Trustees voted unanimously on December 18 to rename the institution "The Donald J. Trump and the John F. Kennedy Memorial Center for the Performing Arts." Roma Daravi, the vice president of public relations at the center, said, "The unanimous vote recognizes that the current chairman saved the institution from financial ruin and physical destruction. TENNESSEE ELECTION. In a special congressional election in Tennessee on December 2 to fill the seat of retired Republican Congressman Mark Green, his party's voters elected as the replacement Matt Van Epps, a West Point graduate and combat veteran who worked in Governor Bill Lee's administration. By close to nine percentage points, Van Epps defeated the Democrat candidate, State Representative Aftyn Behn, who came under fire for past comments in which she said she "hated Nashville," bragged about "bullying" immigration officers, and voted against "the largest tax cut in state history."

U.S. SENATE CONFIRMATIONS. Meeting late on December 18, the U.S. Senate voted en banc 53-43 to approve 97 more of President Trump's nominees for a variety of government positions. This included six U.S. Ambassadorships – Media Research Center founder Brent Bozell of Virginia to South Africa; Florida businessman Benjamin Leon, Jr. to Spain; career diplomat Brent Christensen of Virginia to Bangladesh; California real estate investor Melissa Navarro to Latvia; businessman Bernardo Navarro of Puerto Rico to Peru; and Virginia attorney Darryl Nirenberg to Romania. There are still hundreds more nominees awaiting Senate confirmation.

On December 17, by a 67-30 vote, the Senate confirmed Jared Isaacman as NASA's new Administrator, and he will oversee work across human exploration, space science, aeronautics, and technological development. This will include the Artemis program to return astronauts to the Moon and prepare for future missions to Mars. Secretary of Transportation Sean Duffy had been fulfilling dual duties as NASA awaited a permanent administrator.

U.S. SUPREME COURT. The High Court on December 4 overturned a lower court's ruling by a 6-3 vote and will allow Texas' new redistricting maps to remain in place for the 2026 midterms, which was a win for President Trump and for Texas Republicans, who could gain up to five additional seats in the House of Representatives. Texas Governor Greg Abbott had appealed the lower court decision to toss out the maps.

GOVERNMENT UNIONS AND RINOS. According to the "Conservative Underground News" website, government employee unions – which President Trump opposes – are "the Democrat Party's ATM." The President issued an executive order cracking down on them at federal agencies involving national security missions, but when the House of Representatives voted on his bill called the Protect America's Workforce Act, thirteen so-called Republicans joined with every Democrat to oppose it by a 220-200 vote. The RINOs included Jeff Van Drew, Tom Kean, and Chris Smith of New Jersey; Nicole Malliotakis, Nick LaLota, and Mike Lawler of New York; Brian Fitzpatrick, Rob Bresnahan, and Ryan Mackenzie of Pennsylvania; Don Bacon of Nebraska; Zach Nunn of Iowa; Pete Stauber of Minnesota; and Mike Turner of Ohio. Most of them have been endorsed and funded by the unions they are now protecting. These government unions sit on both sides of the bargaining table because they spend millions electing the politicians who are supposed to negotiate against them. The website said it's "the ultimate scam," but if it can pass the Senate, Trump can then veto the bill.

HUNTER BIDEN. Waterbury, Connecticut Judge Patrick Carroll on December 15 disbarred Hunter Biden for violating the state's attorney conduct rules – following complaints made about federal gun and tax charges for which he was convicted before being pardoned last year by his father, former President Joe Biden. In an agreement with the state office that disciplines lawyers, Hunter Biden consented to being disbarred and admitted to attorney misconduct, but he did not admit to any criminal wrongdoing. He was also disbarred in Washington, D.C., in May. In the Delaware case, the conviction stems from prosecutors stating that Hunter Biden lied on a federal form when purchasing a gun in 2018 that he was not illegally using or addicted to drugs.

After Boston Mayor Michelle Wu vowed to resist the Justice Department's efforts to

secure cooperation from local governments for federal immigration enforcement, Judicial Watch sued her for details of a Mariachi Band Press Conference in August, during which she positioned Boston as a defiant "sanctuary" jurisdiction in opposition to federal law. The lawsuit was filed in the Suffolk County Superior Court after Wu failed to respond to public records requests. Boston residents deserve to know why the mayor's office refuses transparency about this event and why city hall is stonewalling lawful public records requests. U.S.

Immigration and Customs Enforcement (ICE) reported that in September 2025 it and federal partners arrested more than 1,400 illegal aliens in Massachusetts – including murderers, rapists, drug traffickers, child sex predators and members of violent transnational criminal gangs. Acting ICE Director Todd M. Lyons said, "Every illegal alien we arrested during the operation was breaking U.S. immigration law, and hundreds were violent criminals who should never have been allowed to roam freely in our communities." Also, in October, Judicial Watch sued the Office of the Mayor of Evanston, IL, for records related to obstruction of federal immigration enforcement, and in January, Chicago Mayor Brandon Johnson's office was sued for records regarding his vow to resist the Trump administration's mass deportation and other immigration law enforcement activities.

CANAVERAL PORT AUTHORITY.

Carol Craig, founder and chief executive officer of Craig Technologies and Craig Technologies Aerospace Solutions, was sworn into the Canaveral Port Authority Board of Commissioners on December 10 following the death of longtime commissioner Wayne Justice. Florida

Governor Ron DeSantis appointed Craig, a U.S. Navy veteran who previously served as a Naval Flight Officer, to serve the remainder of Justice's term until after the next election in November 2026.

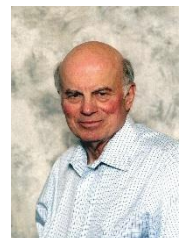
PIPE BOMBS. It has been nearly five years since the notorious January 6 pipe bombs were placed – but not detonated – at the Republican National Committee and Democrat National Committee headquarters in the wake of the 2020 presidential election. The Biden Administration FBI was never able to determine who placed them, but now the Trump Administration FBI has arrested 30-year-old Brian Cole of Woodbridge, Virginia, an employee of a bail bondsman, in connection with the crime. Authorities have linked him to "anarchist" writings and activities. Cole confessed to the action, causing law enforcement agencies now to revisit security protocols. The incident underscores significant vulnerabilities in the protection of political institutions from domestic threats.

Richard Viguerie, the 92-year-old creator of direct mail marketing to help build the conservative movement, told the Leadership Institute's Wake Up Wednesday Breakfast Meeting on December 3 that the

ongoing political battle is between liberals -- the would-be aristocrats who would control every aspect of our lives -- and conservatives -- who represent the interests and values of most Americans. Viguerie's creation 60 years ago was to bypass media outlets to directly reach conservative voters, break the power of large donors and institutions and instead empower



millions of small-dollar donors to fund the movement. Noting the “lack of leadership that the Left has,” he said there is a spiritual civil war with the left and urged conservatives to combat it and “be the leader that you can.” Read, and also study, he said. His marketing and fundraising helped build the conservative movement, which then elected Ronald Reagan as the first conservative president of the modern era. Viguerie believes that government spending should be controlled, taxes kept low, and excessive federal regulation and bureaucracy reined in, a skepticism applied to all government programs. Today, he is chairman of American Target Advertising and of



FedUp PAC, an independent expenditure political action committee, as well as publisher of ConservativeHQ.com and the author of several books.... **Leadership President and Founder Morton Blackwell** said the organization’s program of training conservative leaders across America will

begin 2026 the same way it ends 2025. In New Orleans this month, LI trained 54 Youth Leadership School conservative students. Training then starts again on January 6 at the Virginia headquarters, which will be followed by a Youth Leadership School beginning January 8 in Cape Canaveral, Florida, with more programs scheduled.

SAVING PUPPIES. The temperature hit 105 degrees in Clarkston, Washington, when construction worker Sebastian Bushey, on his way home, came across eight stray puppies in the heat. He rescued all of them and took them to the Lewis-Clark Animal Shelter to help them find new homes. Bushey recorded the rescue and placed it on social media, where it received more than 2.8 million views, and raised more than \$1,500 for the shelter. He also said he hopes the person who abandoned the puppies can be located and arrested.



AUDACITY AND IDIOCY

This month’s “winners” are:

--California’s soft-on-crime approach that prioritizes criminals over innocent victims, for allowing suspected drunk driver Anthony Alva-Palafox to post bail -- \$100,000 – and walk away free after veering his car onto an Anaheim sidewalk and striking eight Anaheim High School track team athletes, several of whom were still hospitalized.

--Minnesota resident Michael Wicker, for using false military certificates and military medals over a five-year period to fraudulently obtain more than \$140,000 in veteran’s benefits from the U.S. government. He claimed decorated Marine Corps service, including combat injuries and prisoner of war status in Iraq – despite never having served. He has now been convicted on federal charges and faces prison time.

--Posting a video to social media explaining immigrants’ rights to refuse to speak or comply with ICE agents, New York City Socialist Democrat Mayor-elect Zohran Mamdani, for saying the city “will always welcome immigrants, and I will fight each and every day to protect, support, and celebrate our immigrant brothers and sisters.” Reacting to the announcement, New York Democrat Governor Kathy Hochul said the immigrants’ rights are being “trampled on,” and she had “no problem” with Mamdani’s video, so illegal immigrants can “stand up” to federal immigration authorities.

--Absecon, New Jersey twin brothers Ricardo and Emilio Roman-Flores, for threatening to gun down ICE officers and plotting to “tar-and-feather and hang” Department of Homeland Security Assistant for Public Affairs Tricia McLaughlin. DHS and a police SWAT team arrested the pair, and they face federal charges of unlawful possession of an assault weapon, possession of prohibited weapons, conspiracy, terroristic threats, criminal coercion and cyber harassment.

--In Maryland, Montgomery County School Officials, for defending lessons taught at Bethesda’s Westland Middle School that included videos from LGBT educational provider Pop’n’Olly teaching 11 and 12-year-olds that “a person’s gender is who they feel that they are.” The students were quizzed on transgender terminology and forced to discuss with their classmates, “how do people know if they are a ‘girl’ or ‘boy?’” Since the school did not label the lessons in advance as “sex education,” parents had no ability to opt their children out of the program.

--National Institutes of Health contractor Joseph Olmert, for admitting in an undercover O’Keefe Media Group video, that he ripped down and discarded federal portraits of President Donald Trump, Vice President JD Vance, and other officials at the agency’s Maryland headquarters. He described his actions without remorse, as if vandalizing government property over political hatred were just another day at work funded by American taxpayers. Following public exposure, he was terminated from his position. Taxpayers who fund federal health research expect professionalism and neutrality, not partisan drama.

--Officials at California’s San Diego Unified School District, for pushing a far-left political agenda and misleading families with its Equity & Belonging hub, a section on its website that includes material saying there are “nine genders” and “28 youth sexual orientations.” It also offers a woke curriculum for students starting in the third grade.

And while still on probation, Reimer said, court officer Santander Parmer was so biased, he even confessed he was working to supplant the pastor’s beliefs with government ideologies.

Once they created that situation, he acted out. He did not act as a normal person would,” Haynes said, noting that Virgil was not a big drinker, but was lured by advertising into accepting drinks. Adding that security personnel on the ship also made mistakes, he said, “The first domino that fell is that they physically restrained him with five people physically on top of him, which resulted in mechanical asphyxiation.” In reply, Royal Caribbean said, “We were saddened by the passing of one of our guests, worked with authorities on their investigation, and will refrain from commenting any further on pending litigation.”

So here’s the real question: how many more Yusuf-style acquittals are waiting in the wings, just one ‘circumstantial’ ruling away from turning a conviction into a cocktail party? Stay tuned. The appeal’s coming. But don’t hold your breath.” -0-

Staff writer **Katherine Mosack** at One America News, on children dying of the COVID vaccine:

“The U.S. Food and Drug Administration (FDA) Chief Medical Officer Vinay Prasad revealed data findings that ‘At least 10 children have died after and because of receiving COVID-19 vaccination,’ he wrote in an [email](#) sent to staff. ‘For the first time, the U.S. FDA will acknowledge that COVID-19 vaccines have killed American children,’ Prasad said. ‘Healthy young children who faced tremendously low risk of death were coerced, at the behest of the Biden administration, via school and work mandates, to receive a vaccine that could result in death. He emphasized that the number he referenced is ‘certainly an underestimate due to underreporting and inherent bias,’ arguing that the studies performed on the COVID vaccinations and booster shots ‘often fail to look at the balance in younger people’.... ‘Why did it take until 2025 to perform this analysis, and take necessary further actions?’ Prasad implored in his email. ‘Deaths were reported between 2021 and 2024 and ignored for years.’ The FDA official believed the reasons for covering up deaths from the new vaccine to be ‘cultural and systemic,’ drawing attention to the difference between the current and previous administrations’ handling of health and safety protocols. ‘The U.S. government’s coercive and unethical covid-19 vaccine mandates in young people may have been harmful,’ he asserted. ‘In contrast, there is no doubt that an elderly, un-immune American benefitted from Doses 1 and 2 in 2020.’ Prasad added, ‘The people who might have benefitted most from vaccination were those too old to be affected by workplace mandates – another Biden administration blunder’.... Parents around the community were frustrated and angry at the district’s decision and how one complaint ruined a longtime tradition. ‘So tired of this woke culture, where one parent can call in and complain, and ruin it for the entire district,’ one parent wrote on Facebook. Another called it absolutely sickening and wrong. ‘It is CHRISTmas. The impromptu concert drew at least 100 parents and students. Children sang holiday songs while families enjoyed hot cocoa, treats, and a visit from Santa. Community members also donated food and drinks to support the event. ‘It’s not a religious statement or a political statement,’ she said. ‘It literally is about this child’s first concert, and whose last concert is in elementary.’ How sad there was no room for Jesus in the inn or a grade school Christmas pageant.”
