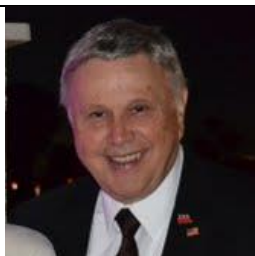

Speaking and joking October 17 in New York at the 79th annual Alfred E. Smith Memorial Foundation Dinner – a charity fundraiser named for the first Catholic presidential nominee of a major political party – former President Donald Trump received several standing ovations. Declining to attend the event, Vice President Kamala Harris was the first presidential candidate no-show in 40 years.

Ohio Senator J.D. Vance, the Republican vice presidential candidate, and Minnesota Governor Tim Walz, the Democrat one, held their only debate in New York on October 1, moderated by CBS News' Norah O'Donnell and Margaret Brennan.



The debate covered foreign policy, reproductive rights, threats to democracy, immigration, housing, and more. While the two candidates were more-or-less cordial to one another, they both expressed continuous criticism of the other party's top of the ticket – Vance of Democrat Kamala Harris and Walz of Republican former President Donald Trump.

--During Florida's 13 days of Early Voting October 21-November 2, turnout at Brevard County's 10 locations has been extremely heavy, with long lines of residents waiting to cast their ballots. We will report on the election results in the November newsletter.

On the subject of Iran's recent missile strike against Israel, Walz expressed support for "our Israeli partners," but added that steady leadership matters, but that those closest to Trump "understand how dangerous he is when the world is this dangerous." Vance responded that Trump actually delivered stability in the world by establishing effective deterrence, and that Iran "has received over \$100 billion in unfrozen assets thanks to the Kamala Harris administration." He added that "It is up to Israel what they think they need to do to keep their country safe. And we should support our allies wherever they are when they're fighting the bad guys."

Regarding immigration and the crisis at the U.S.-Mexico border, Vance, who was asked about his pledge to carry out the largest mass deportation plan in American history, said that first, "we have to stop the bleeding. We have a historic immigration crisis because Kamala Harris started it, and said that she wanted to undo all of Donald Trump's border policies. He said that 94 executive orders "suspending deportation, decriminalizing illegal aliens, massively increasing the asylum fraud that exists in our system, that has opened the floodgates. And what it's meant is that a lot of fentanyl is coming into our country."

The first thing we do, Vance said, "is start with the criminal migrants. About a million of those people have committed some form of crime in addition to crossing the border illegally. I think you start with deportations on those folks, and then I think you make it harder for illegal aliens to undercut the wages of American workers." He added, "We have 320,000 children that the Department of Homeland Security has effectively lost. Some of them have been sex trafficked, some of them hopefully are at homes with their families, some of them have been used as drug trafficking mules. The real family separation policy in this country is, unfortunately, Kamala Harris' wide open southern border."

Walz responded that when Harris was California's Attorney General, she was "the only person who prosecuted transnational gangs for human trafficking and drug interventions. He said that 1,500 new border agents were needed, but that Trump, as president, said "no."

Asked about a discrepancy over saying he was in Hong Kong during the deadly 1989 Tiananmen Square protest – with news reports saying he did not go there until later in the year – Walz said he "misspoke on this," and is "a knucklehead at times," but added that he thought Trump "should have come on one of those trips."

On the subject of reproductive rights, Walz claimed that the Republicans want to have a "registry of pregnancies" to make it more difficult to obtain access to infertility treatments, but Vance said there is no such plan for a federal pregnancy monitoring agency.

On the gun violence epidemic, asked if parents should be held responsible for youthful shooters' actions, Vance said he trusts local enforcement and local authorities to make those decisions. For example, he said, "if a kid steals a gun, that's going to be different than if a parent hands over a gun knowing that their kid is potentially dangerous.... And while we're on that topic, we know that thanks to Kamala Harris' open border, we've seen a massive influx in the number of illegal guns run by the Mexican drug cartel. So that number, the amount of illegal guns in our country is higher today than it was three and a half years ago.... We have to increase security in our schools. We have to make the doors lock better. We have to make the doors stronger. We've got to make the windows stronger. And of course, we've got to increase school resource officers because the idea that we can magically wave a wand and take guns out of the hands of bad guys, it just doesn't fit with recent experience."

Walz said that Harris, as an Attorney General, worked on this issue, and no one is trying to scaremonger and say that we're taking your guns. But I ask all of you out there, do you want your school's hardened to look like a fort? He added, "Sometimes it just is the guns. And there are things that you can do about it. But I do think that this is a healthy conversation. I think there's a capacity to find solutions on this that work, protect Second Amendment, protect our children. That's our priority."

Turning to the high cost of housing and rent as the top contributor to inflation, and asked if Harris' promise of a \$25,000 down payment assistance for first time homebuyers and a \$10,000 tax credit and a promise to build three million new homes would just drive up prices higher, Walz said that people with usable housing end up with stable jobs, and in the long run, end up saving our money.

Vance said we want to blame Kamala Harris "for letting in millions of illegal aliens into this country, which does drive up costs. Twenty-five million illegal aliens competing with Americans for scarce homes is one of the most significant drivers of home prices in the country."

Asked about the high cost of health care and the coverage of pre-existing conditions, Vance said, "of course," and added, that when Trump was President, he had a record to be proud of, prescription drugs fell in 2018 for the first time in a very long time. Under Kamala Harris's leadership, prescription drugs are up about 7%. Under Donald Trump's entire four years, they were up about one and a half percent."

Walz said he comes from "a major healthcare state, home of the Mayo Clinic, home to Medical Alley, 3M, Medtronic, all of those. We understand healthcare. It's why we're ranked first on affordability and accessibility and quality of health care."

In closing remarks at the end of the debate, Walz said the support of Democracy matters, and while people don't all agree on everything, they are truly optimistic. They believe in a positive future of this country, and one where our politics can be better than it is. Again talking about Trump, he said that "His first inaugural address talked about American carnage and then he spent four years trying to maybe do that. Senator Vance tonight made it clear he will stand with Donald Trump's agenda. He will continue to push down that road. Excuse me. Kamala Harris gives us a different option.... she is bringing us a new way forward. She's bringing us a politics of joy. She's bringing real solutions for the middle class. And she's centering you at the heart of that, all the while asking everyone.... I humbly ask for your vote on November 5 for Kamala Harris."

Vance said in his closing remarks that he believes "we are a rich and prosperous enough country where every American, whether they're rich or poor, ought to be able to turn on their heat in the middle of a cold winter night. That's gotten more difficult thanks to Kamala Harris's energy policies. I believe that whether you're rich or poor, you ought to be able to afford a nice meal for your family. That's gotten harder because of Kamala Harris's policies." He added that she's been the Vice President for three and a half years, and her policies have made these problems worse. "We need change. We need a new direction. We need a President who has already done this once before and did it well," he said. "Please vote for Donald Trump. And whether you vote for me or vote for Tim Walz, I just want to say I'm so proud to be doing this, and I'm rooting for you."

They're Illegal and They Vote

We hear the shouts of "Stolen Election" whenever the 2020 Presidential Elections are spoken about. I have my own opinion on that, but I will say that this upcoming election needs to be very carefully scrutinized. I once saw a photo of people holding signs that said: "We're Illegal and We Vote!". Arrogant statement, but is it true?



Fasten your seat belts. Yes, it is very likely that there will be many "undocumented citizens" voting. The facts are shocking but true. Fifty states and many territories all have their own election

laws. Of those, 17 states issued drivers licenses to illegal aliens.

As of April 2024, 35 states required voters to present identification in order to vote at the polls on Election Day. Of these states, 24 required voters to present identification containing a photograph, and 11 accepted other forms of identification. The remaining 15 states did not require voters to present identification in order to vote at the polls on Election Day. (Ballotpedia)

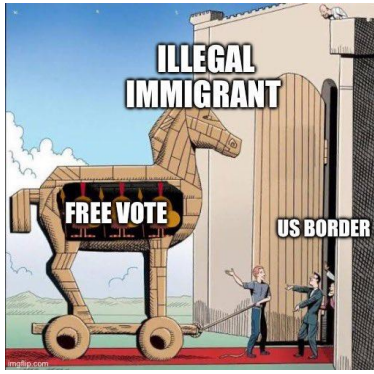
The requirements needed to register to vote: In most cases, you will need either a driver's license or a state ID to register. If you do not have either of these, you may be able to provide other types of documentation, including a bank statement or utility bill. But the required documents you need to register vary by state.

According to the National Conference of State Legislators, "Nineteen states and the District of Columbia have enacted laws to allow unauthorized immigrants to obtain driver's licenses. These states— California, Colorado, Connecticut, Delaware, Hawaii, Illinois, Maryland, Massachusetts, Minnesota, Nevada, New Jersey, New Mexico, New York, Oregon, Rhode Island, Utah, Vermont, Virginia and Washington — issue a license if an applicant provides certain documentation, such as a foreign birth certificate, foreign passport, or consular card and evidence of current residency in the state".

Many states have passed laws allowing non-citizens to vote in municipal or state elections. They believe that laws will stem the epidemic of illegal voting. However, considering that

these same people who will register to vote have already broken the law by being here, I doubt they will care about state voter registration laws.



Consider that 17 states have issued id's or drivers licenses to illegal aliens and in all those states that is all that is required to register to vote. On top of that these same states often only require these same people to state their name and address, sign a poll book, and in some cases that is suspended if the lines are more than 45 minutes long. In these same states if an applicant attests that they are a U.S. citizen, that is considered valid on its face and the person is registered to vote.

Remember Motor Voter? The National Voter Registration Act ([NVRA](#)) of 1993 ordered states to register voters at the Department of Motor Vehicles (DMV) and agencies where Americans apply for public benefits — and those offices are required by federal law to hand over the registration forms along with the application papers.

There was an attempt to tighten up federal registrations by enacting The Safeguard American Voter Eligibility (SAVE). While it initially passed the House, on September 26, a budget was passed to keep the government open and running without the SAVE Act included.

Given the lax registration application scrutiny by state officials, there are cases that have been found of violations of state laws. For instance, in Virginia more than 11,000 aliens were listed on the voter rolls, in New Jersey at least 616 were found and in Arizona 200 were found.

It doesn't seem like there are that many violating the law, but these are the ones that were found. When it comes to close elections, illegal voting makes a difference, and the consequences will shape our future. Given the lack of confirmation of citizenship, these numbers are undoubtedly underestimated. And who do we rely on to enforce these laws? The Biden/Harris Justice Department.

This is the same administration that routinely ignores the law. According to [The Heritage Foundation](#), "Its 'catch and release' program violates 8 USC 1225's requirement of mandatory detention for illegal aliens. Its 'mass parole' program for Cubans, Haitians, Nicaraguans and Venezuelans violates 8 CFR § 212.5's requirement of parole being used only on a case-by-case basis. Its deportation protocols focusing only on arresting illegal aliens deemed to pose a threat to public safety or national security, or who recently crossed over the border illegally violates 8 USC 1227's deportable alien's criteria."

One option is cross-checking registered voters with the U.S. Citizenship and Immigration Services' Systematic Alien

Verification for Entitlements ([SAVE](#)) database, which verifies immigration status.

- Alabama: The state since 2023 has identified 3,251 noncitizens registered to vote, though it said it's possible that some are now naturalized and eligible to vote.
- Georgia: A 2022 review in the state, which has a process for checking citizenship, found that election officials had flagged and prevented about 1,600 registration applications by potential noncitizens over the past 25 years.
- Ohio: This year, Ohio identified 138 noncitizens "who appear to have cast a ballot" by cross-referencing state and federal databases, including jury pool data.
- Virginia: Gov. Glenn Youngkin removed 6,303 noncitizens from the state's voter rolls over the past two years, based on data collected by the Department of Motor Vehicles and shared with the state Department of Elections. (Christian Science Monitor)

Add to this those who died and still vote, those who hold drivers' licenses in multiple states, those who moved to other states and those who are registered in multiple states. As far as I know there is no database for national voter registrations lists.

There is concern regarding the 2024 Elections. Here in Georgia at many polling precincts there are Spanish interpreters to assist those who need it. But until we close the borders, install a Justice Department that will enforce our laws and enact nationwide ways to prove citizenship, we may lose our sovereign nation to the millions allowed to enter our country illegally.

On October 17th I voted early. I am in a suburb of Atlanta. In the past when voting here you had to fill out a form with all your information on it. This morning. That walked into the precinct and was told to have my id out and to proceed to a table. The poll worker took my driver's license, inserted it into a computer and gave me a ticket to insert into a voting machine. That was it. If an illegal alien manages to obtain a license, they can register online by sending a copy of their driver's license. When they arrive at the polling site the illegal hands their license to the poll worker and it is inserted into the computer to compare the address on the license and the registered address. The license does not say "I'm illegal and I'm here to vote". No matter the outcome of our election, the losing side will have a reason to suspect the legitimacy of the 2024 elections.

The number one tip the CFO's office suggests is, "Don't sign anything!" After storms, people may go door to door and offer repair services. Do not give these individuals cash or enter a contract with them, instead call your insurance company or the CFO's office at 1-877-693-5236 immediately.

They also advise that you obtain multiple estimates for repairs. A good estimator will include clearly defined, itemized costs and terms.

--SeaPort Manatee, a deep water port on Florida's Gulf Coast, experienced an estimated \$225 million in damage from Hurricane Milton, including the total destruction of 10 of the port's 13 warehouses.

From when the storm made landfall on October 9 through October 14, over 1,400 tanker trucks transported 12.1 million gallons of fuel for distribution from Port Canaveral to support ports experiencing temporary closures.

"Access to fuel supplies is a priority at Port Canaveral," said John Murray, the port's CEO.

"Before and after Hurricane Milton, our entire port team worked long hours alongside our fuel terminal operators — Seaport Canaveral and TransMontaigne — to keep gasoline, diesel, and jet fuel rolling out to Florida communities and airports. We're proud of our efforts and will continue to do our part to help with our state's recovery efforts."

--Northrop Grumman announced the addition of a 303,600 square foot office building at its Melbourne Orlando International Airport location. The building will be connected to a 50-foot-tall high bay that will serve as an "engineering-design hub" for advanced aircraft development.

"Project Daisy" will be developed on 38 acres on NASA Boulevard's northside near Northrop Grumman's current facility. The site will include 1,220 parking spaces with room for an additional 678 spaces.

"MLB is very enthusiastic in supporting the aerospace industry's needs and we strive to provide the ideal environment for development," said Greg Donovan, MLB

Airport Executive Director. "We know that programs such as Project Daisy are highly competitive and require all the best ingredients in order to be successful. The airport authority's investment into infrastructure such as runways, air traffic control tower, and other operational improvements has eclipsed \$200M in the past ten years, so landing this project is a great return on that investment."

It was another great BFRW luncheon on October 2. Our guest speaker was **Bob White**, Chairman of the

Republican Liberty Caucus of Florida, who has a long history of advocating for limited government, free enterprise, personal liberty and responsibility, and spoke on "Restoring the Republic."

White said that while candidate contributions are at \$1,000, Florida allows unlimited PAC contributions, and that these undermine our elections and legislative processes. He explained that unlimited contributions give PACs disproportionate influence at the expense of the people and democracy.



He believes that Congress now has far more power than our Founders ever envisioned when they drafted our Constitution. He also believes that our Republic will not be restored by Washington, DC politicians and bureaucrats; it can only be restored from the bottom up, one state at a time, and that Florida is ground zero in this epic battle.

Urging us to hold as our top priority keeping Republican legislators accountable, White said the Republican Liberty Caucus has a candidate endorsement process which identifies candidates dedicated to the principles of personal liberty, limited government and individual freedom. He also said that

the RLC's legislative scorecard is an important tool we can use in deciding which candidates to support.

Our speaker for the month was **Senator Tom Wright**. He explained the 6 Constitutional Amendments on the November ballot and how sometimes the wording can be confusing, even misleading in items placed on the ballot. Amendment 2 preserves traditional hunting and fishing as a right, Vote Yes. Amendment 3

As far as the nation goes, not so much.” I’m sure most of us will agree with that. Wright reminded us of the many benefits available to our honored veterans and provided booklets to inform them of all the things that are available to them that they may not know about. Scott Mahurin, volunteer from Florida Preborn Rescue, spoke on the need to defeat Amendment 4 and how destructive it would be if it passed. Our state could become known as the abortion capital of the U.S. if this bill actually passed into law.

Most of this bill is negated by the 403.412 Environmental Protection Act (9)(a) which states that “a local government regulation, ordinance, code, rule, comprehensive plan, charter or any other provision of law may not recognize or grant any legal rights to a plant, animal, a body of water, or any other part of the natural environment that is not a person or political subdivision as defined in s. 1.10(8) or grant such person or political subdivision any specific rights relating to the natural environment not otherwise authorized in the general law or specifically granted in the State Constitution.”

This bill was given to the public as a cure to make sure we have clean drinking water and clean up the lagoon water that people have been polluting for literally 50 years. This bill does not do that at all, but it most certainly will raise your taxes and feed attorneys!

Regarding Amendment 4 on the Florida ballot – abortion – it is not what it seems. It is extreme, and it does not define viability of healthcare provider or patient health. It also eliminates parental consent.

Chase Tramont, Florida State Representative for District 30, was the guest speaker for the meeting. He proudly proclaimed his endorsement of Delaney, and acknowledged that in Florida, we have a supermajority in the House, the Senate, and the Executive branch. Every statewide office is filled by a Republican. Our state officials are working with the feds regarding illegal voting. We have had a flood of illegals into our state, and there will be no amnesty.

Regarding the impact Florida can have on our federal elections, Tramont believes we can serve as an example of clean voter rolls and grassroots efforts. SUPREME COURT OF THE UNITED STATES

On October 7, the U.S. Supreme Court began its new nine-month term that is including cases on such issues as the legality of a U.S. regulation reining in homemade “ghost

guns;” a bid by gun maker Smith and Wesson and firearms wholesaler Interstate Arms to void Mexico’s lawsuit accusing them of aiding the illegal trafficking of firearms to Mexican drug cartels; the legality of a Republican-backed ban in Tennessee on gender-affirming medical care for transgender minors; whether a Texas law that requires pornographic websites to verify the age of users in an effort to restrict access to minors violates the U.S. Constitution’s First Amendment safeguard against government infringement of speech; whether the Nuclear Regulatory Commission has the authority to license nuclear waste storage facilities following a judicial ruling that upended decades of practice by declaring it does not; the U.S. Food and Drug Administration’s defense of the agency’s rejection of applications by two companies to sell flavored vape products that it has determined pose health risks for young consumers; Nvidia’s bid to scuttle a securities fraud lawsuit accusing the artificial intelligence chipmaker of misleading investors about how much of its sales went to the volatile cryptocurrency industry; a bid by Meta’s Facebook to scuttle a private securities fraud lawsuit accusing the social media platform of misleading investors about the misuse of its user data by the company and third parties; and a bid by Oklahoma death row inmate Richard Glossip, convicted in a 1997 murder-for-hire, for a new trial based on his claim that prosecutors wrongly withheld certain evidence favorable to his defense.

U.S. BORDER PATROL. The “New York Post” reports that the U.S. Border Patrol has suffered massive turnover and plummeting morale under the Biden-Harris administration, and that multiple agents speaking anonymously have said that if Kamala Harris wins the presidential election, there will be another mass exodus of agents. Since October 2020, more than 4,000 employees have resigned. One agent said, “Under this administration, they’ve done everything they could to make our job as inefficient as possible. They can’t outwardly tell us not to do our job, but when you’re watching criminals come in and get released it sucks.”

VIETNAM PURPLE HEART.

A military veteran Marine from North Carolina, who was wounded in the Vietnam War and received a Purple Heart, has given it to former President Donald Trump in reaction to the first attempt on his life. The soldier, who was only identified as Dwight, said in his letter to

Trump that was read at a campaign rally in the Tar Heel state, said “My wife and I both let out a sigh of relief and shed a few tears as we watched you get back up at the Butler event. It would be an honor if you could accept this small gift I got in Vietnam.” Present at that event, Dwight was called up on stage, and Trump told him in response that “I got lucky, and maybe it wasn’t so lucky. It could be something else, right? There may be



something else up there.” He went on to say that receiving Dwight’s Purple Heart was his “great honor.”

TULSI GABBARD. Independent politician Tulsi Gabbard, a former Democrat who previously served as a U.S. Representative for Hawaii’s 2nd congressional district from 2013 to 2021, joined former President Donald Trump at a rally in North Carolina, and announced she is switching to the Republican Party. Then accompanying Robert F. Kennedy, Jr., who also supports Trump, in Nebraska, Gabbard



criticized the Biden-Harris administration, emphasizing specific information concerning disaster relief funds, and discussed all the advantages and benefits of another Trump presidency. The Federal Emergency Management Agency’s reaction to the hurricane clearly “failed,” Gabbard asserted. AMERICA’S VETDOGS. The Smithtown, New York-based organization that provides service dogs for veterans and first responders – America’s VetDogs – was selected as the 2024 Community Service Award honoree by the Congressional Medal of Honor Society, the Congressionally-chartered organization of living Medal of Honor recipients. The award recognizes a community-based nonprofit organization for its exceptional impact in support of the nation’s military service members and families. The service dogs are specially trained to help people with disabilities by performing tasks that assist them with the activities of daily living. Applicants for trained dogs receive them at no cost but must be dedicated to meet the dogs’ physical and emotional needs and cover their daily feeding and grooming, including annual veterinary examinations and vet care as needed for unexpected health issues.



At the end of last month, the Institute For Justice secured a resounding victory for free speech in a long-running case at the

U.S. Court of Appeals for the 5th Circuit. It was the case of retired Texas veterinarian Dr. Ron Hines, who used the internet to give advice, often free, to pet owners across the U.S. and around the world. But in 2012, the Texas State Board of Veterinary Medical Examiners reprimanded Hines and suspended his license, saying it was illegal for a vet to give advice online without first physically examining an animal. IJ then challenged the ruling on Hines’ behalf, but an earlier 5th Circuit panel ruled in 2015 that his advice was regulated by occupational licensure and not protected by the First Amendment. But after a landmark 2018 U.S. Supreme Court decision rejected the professional speech doctrine that excluded occupational speech from the First Amendment, IJ went back to the 5th Circuit successfully. **Institute for Justice President Scott Bullock** said this victory “is a vindication of a decade of relentless, skilled, and determined legal advocacy by IJ to develop legal protection for the right to speak for a living.”



Attorney and Home School Legal Defense Association Senior Counsel **Will Estrada**, who was home schooled himself, told the Leadership Institute’s Wednesday Wake Up Breakfast meeting on October 2 that parental rights have been fundamental in children’s education in the United States for more than 100 years. There have been numerous U.S. Supreme Court cases upholding this right since the case of Meyer (a teacher) v. Nebraska in 1923, he said, and regarding home



schooling, Federal Law 20 USC 7886, passed in 2015, protects that freedom. Today, Estrada said, 27 states have passed parental rights laws, and about 5 percent of school-aged children in the United States are home schooled. They just want to be left alone, he added. Estrada said there are numerous

examples of the belief in parental rights dating back to the Biblical days of Jewish scripture, of the New Testament, of Quran law, of the Greek philosophers, and of English common law. All of them, he said, stressed the importance of family throughout history. For more information on home schooling, visit the website: www.hslda.org. On October 10, LI hosted 46 events in 29 states on a single day with students from 44 campus groups across the country. The ambassadors of LI's Riley Gaines Center ensured that Real Women's Day X/X was recognized on college campuses, celebrating and acknowledging women. There was leftist outrage, of course, but LI stood for basic truths, common sense, and women.

AUDACITY AND IDOICY

October's "winners" are:

--The Biden-Harris Administration's U.S. Department of Justice, for filing a lawsuit against the state of Alabama for purging the names of 3,251 people determined to be illegal aliens from its voter rolls and Virginia where a federal judge appointed by Biden has ordered Virginia to put more than 1,600 people back on the state's voter rolls after they were recently removed under a state program that the Justice Department and advocates say illegally took them off too close to the election., demanding that they be returned to the rolls and allowed to cast ballots in the November presidential election. The Justice Department argument says the states are in violation of the National Voter Registration Act, which demands that any changes to voter registration lists be done 90 days before a federal election, and Alabama and Virginia's action occurred with less than 90 days left. So, concerning non-citizens voting in the United States, what does the current administration think about the U.S. Constitution, the 15th Amendment, the 19th Amendment, the 24th Amendment, and the 26th Amendment?



--Mark Memmott, the director of standards and practices for CBS News (is that the Communist Broadcasting System?), for ordering the staff to stop referring to Jerusalem as the capital city of Israel – in other words, to deny reality – because “the status of Jerusalem goes to the heart of the Israeli-Palestinian conflict,” and while the U.S. Embassy is there, “its status is disputed.”

--Woke, leftist city officials in Stockton, California, supported by an equally woke and leftist lower court, for firing Fire Chief Ron Hittle after 24 years of service because he attended a leadership conference hosted at a church. Hittle attended the Willow Creek Church's Global Leadership Summit, a world-

class conference with speakers from a variety of religious and non-religious backgrounds. Stockton officials claimed that he was at “a religious event while on duty” as justification. First Liberty Institute said Stockton “showed extreme anti-religious bias and broke the law when it fired Chief Hittle,” and it is asking the U.S. Supreme Court “to reverse the lower court's decision and uphold the clear meaning of Title VII to protect all Americans in the workplace.”

--Former Nevada legislator and suspended justice of the peace Michele Fiore, for fundraising more than \$70,000 to establish a memorial for two fallen Las Vegas police officers killed in the line of duty, but using the money instead for her plastic surgery and rent, plus her daughter's wedding. A jury convicted Fiore of federal wire fraud, and her sentence is set for next January.

--A University of Kansas professor – not named by the school but identified by students as Philip Lowcock, the director of international student-athlete support, for stating on a social media clip that men who will not vote for Kamala Harris for president because she is a woman, should be lined up and shot. He was on administrative leave as the school investigated the matter, and several days later, it was reported that he is no longer employed there.

--National Grid, a company that has a \$50 million U.S. government contract for integrating more clean energy into the grid, for firing a contract employee – disabled Iraqi War veteran Scott Hayes – who had defended himself by shooting in self-defense an anti-Israel attacker who had charged through traffic and tackled him in Newton, Massachusetts. Ironically, Massachusetts authorities charged Hayes – not his attacker – with assault and battery with a dangerous weapon.

YOU CAN'T MAKE THIS UP

--After White House Press Secretary Karine Jean-Pierre abruptly ended a press briefing and left the room – following a question asked about claims that the Biden administration mismanaged funds being sent to Lebanon – instead of being fired for her behavior, actually received a promotion. In addition to her press secretary duties, Jean-Pierre is now also a senior advisor to the president. Gushing over the action, a White House official stated, “Her promotion shows the faith that Biden has in her, as well as his commitment to having diverse and inter-generational voices guiding him in his decisions.”



--Just how secure are mail-in election ballots? It seems every election season brings fresh controversy. In Sierra Madre, California, Jay Senese was doing routine yard work and saw something unusual in the storm drain outside his house. He pulled out trash and junk mail – and mixed in with the mail were nearly a dozen mail-in ballots addressed to residents of nearby Arcadia, California. Conservatives have long been sounding the alarm over the mishandling of ballots – and stories like these just add fuel to the fire.

--The atheist non-profit Freedom From Religion Foundation has maliciously demanded that the Internal Revenue Service strip away the tax-exempt status of the Billy Graham Evangelistic Association, claiming that by comparing the policy stances of the major party presidential candidates, it has participated in "illegal political campaigning." The FFRF letter sent to the IRS served no purpose other than a desire to financially cripple the Christian ministry.

--America First Legal is representing Patrick Hogarty, the former dean of students at Campus Middle School in Greenwood Village Colorado's Cherry Creek School District, who was fired for expressing pride in the United States during a mandatory Diversity, Equity and Inclusion training session. Responding to a question about his identity as a white U.S. citizen, Hogarty stated that the U.S. is "the greatest country in the world." But the district's equity director accused him of using "racist overtones," and eliminated his position for "budgetary reasons." In the lawsuit, America First Legal argues that the district's actions were politically motivated, and that he was targeted for not aligning with its DEI ideology, which frames America as a systematically racist nation.

--After unsuccessfully asking people for a ride, an Oklahoma man named Kody Adams allegedly stole an emergency truck at a Stillwater gas station – and then ditched it where he wanted to go. That happened to be the Pawnee County Court House – where he was facing charges for a different stolen vehicle. He was apprehended for the second charge as well.

--Harold Daggett, the president of the International

Longshoremen's Association (ILA), whose strike affected 36 ports along the U.S. East and Gulf Coasts, says his organization can "cripple" the U.S. economy and has accused the U.S. Maritime Alliance of "exploiting ILA labor to generate wealth." This from someone that "Politico" says last year "took home \$901,000 from the union."

--John Kerry, the Biden-Harris administration aide and former U.S. Secretary of State, spoke to the World Economic Forum, where instead of extolling the benefits of democratic liberty versus dictatorships and oligarchs, he actually called the U.S. Constitution's First Amendment a "major block" to keeping people from believing the "wrong" things. The hostile global elitist added, "So what we need is to win the ground, win the right to govern, by hopefully winning enough votes that you're free to be able to implement change."

Fox News writer **Aubrie Spady**, on a judge ruling the Biden administration violated environmental law in halting border wall construction:

A federal judge ruled in favor of a southern border rancher who had argued that the Biden administration had violated environmental law in its 'haste to reverse its predecessor's border policies' in 2021. An Arizona rancher, Steven Smith, was part of the lawsuit, Massachusetts Coalition for Immigration Reform et al. v. U.S. Department of Homeland Security, challenging the Biden administration. The suit claimed that the Department of Homeland Security (DHS) had failed to conduct a mandatory review required by the National Environmental Policy Act (NEPA) before halting border wall construction, a key Trump-era project. Under NEPA, a federal agency must conduct an Environmental Assessment to determine whether a federal action has the potential to cause significant effects on the human environment, according to the Environmental Protection



Agency. After a two-day bench trial, Judge Trevor McFadden of the U.S. District Court for the District of Columbia issued a ruling that Smith 'suffered concrete and particularized injuries' as a result of DHS not meeting the requirements of NEPA. The Trump-appointed judge also concluded that the actions taken by DHS, such as ending the 'Remain in Mexico' policy, resulted in indirect effects relating to population growth. Smith testified that migrant activity on his ranch had 'dramatically increased' after President Biden was elected, and that he had begun seeing illegal immigrants on his property multiple times a month and finding trash on a daily basis. Smith claimed that the trash left by the migrants has had negative impacts on the environment, as well as on his own cattle, which were eating the litter. The rancher also testified that water for cattle and other wildlife was a very scarce resource and that migrants were taking it from a trough on his land.... While this may aid thirsty trespassers, it causes Smith to lose thousands and thousands of gallons of water, which can take days and days and days to regain. The judge ruled that Smith, a Cochise County resident, 'suffered tangible harms' caused by the migrant crisis and is entitled to relief after illegal immigrants 'trespassed onto his land, stole his water, and trashed his property.' At trial, Smith proved as a matter of fact that his harms traced to migrants who reacted predictably to DHS's decisions, the ruling reads."



Journalist Bob Unruh, writing on WorldNetDaily that Vice President Kamala Harris did not even write her own book:

"Kamala Harris, writing a book she called 'Smart on Crime: A Career Prosecutor's Plan to Make Us Safer' some 15 years ago with co-author Joan O'C. Hamilton used other

people's work as her own, according to a new report. It is activist Christopher Rufo who has published details on his Substack column explaining she was found to have lifted from other sources, without attribution, a number of sections of the project. Rufo cited famous Austrian 'plagiarism hunter' Stefan Weber in his report on about a dozen fragments that were plagiarized. 'The Daily Mail' reported, 'Weber's report shows that Harris copied verbatim content from Goodwill Industries, her partner on her Back on Track crime program, into the text of her book.' And, the publication asserted, the report shows that Harris lifted an entire section of text from an Associated Press story published in April 2008 about low graduation rates. 'They not only lifted material from sources without proper attribution, but in at least one case, relied on a low-quality source, which potentially undermined the accuracy of their conclusion,' Rufo wrote. The news triggered a response from former President Donald Trump's campaign and running mate Senator J.D. Vance. He wrote, 'Lmao Kamala didn't even write her own book!'.... Plagiarism is a serious charge for a political candidate. After all, one of Joe Biden's earlier presidential bids was derailed by allegations of plagiarism. The Daily Mail reported that another section of the book quotes sections from a John Jay College of Criminal Justice press release nearly verbatim without attribution. The

report explains Biden's 1987 campaign was brought to a halt after he 'appeared to be copying phrases and mannerisms from a British Labour Party politician,' the report said. That followed accusations Biden plagiarized during law school. 'Rufo said that Harris and her publisher should retract the plagiarized passages from her book and issue a correction,' the Daily Mail reported.



American Security Council Foundation Senior Analyst Laurence F. Sanford, writing on Hezbollah in his "Peace Through Strength" publication:

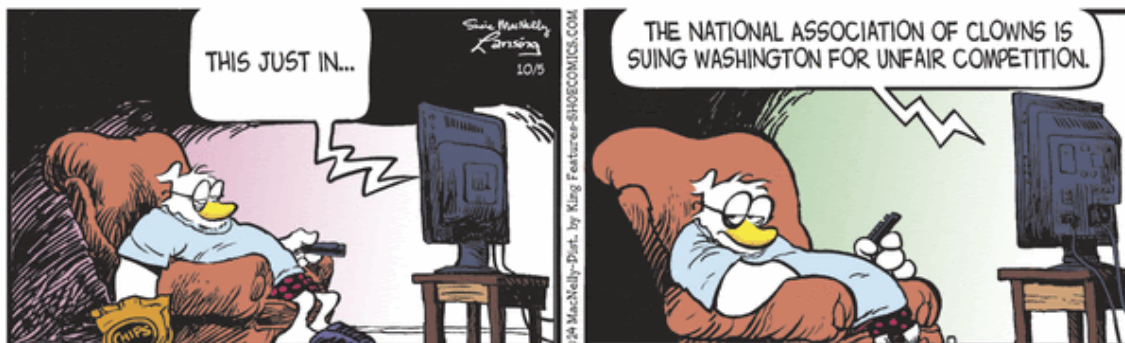
A few more minutes pass and the union boss orders a third round of drinks for everyone except the Republican.

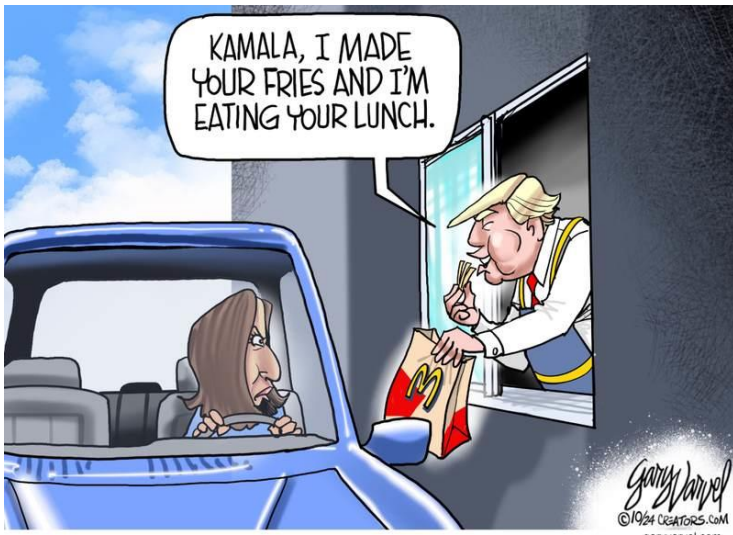
Just as before, this STILL doesn't seem to faze the Republican, who continues smiling and again yells out, "Thank you!!!"

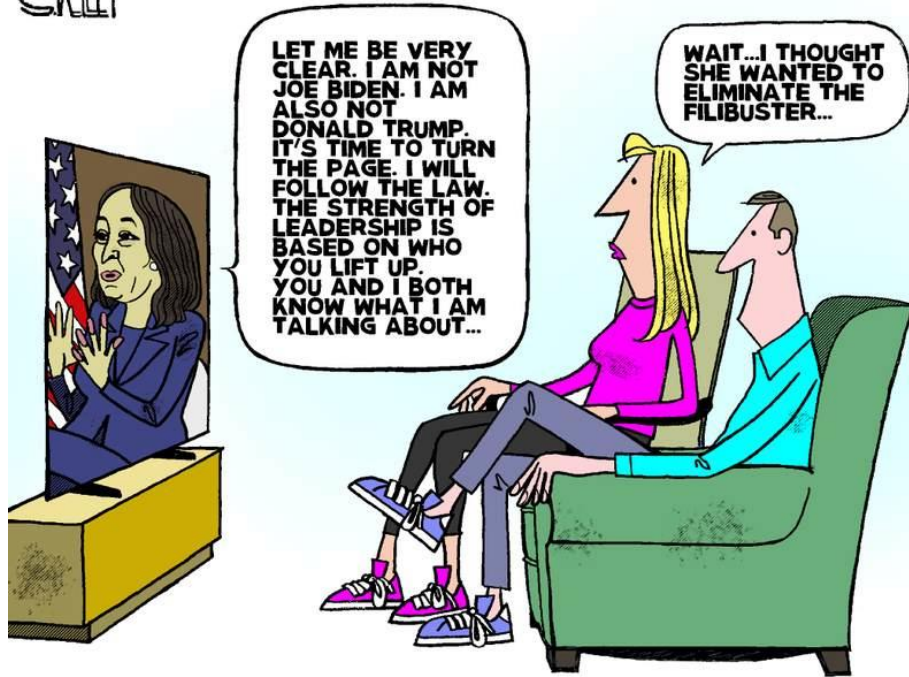

"Nope," replies the bartender. "He owns the place."

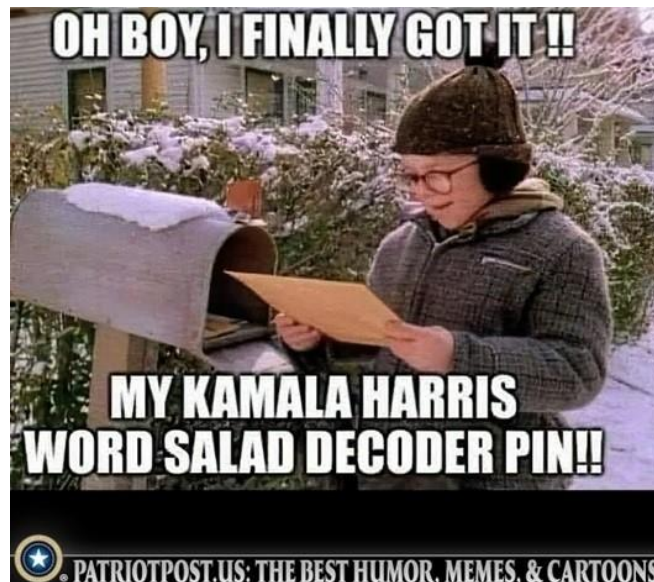

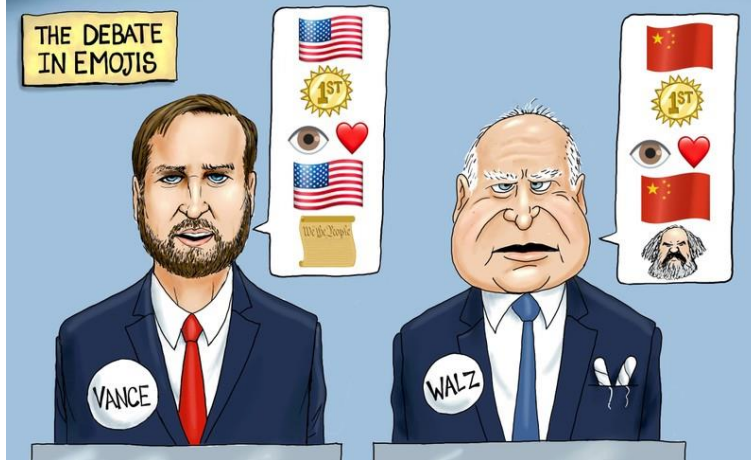

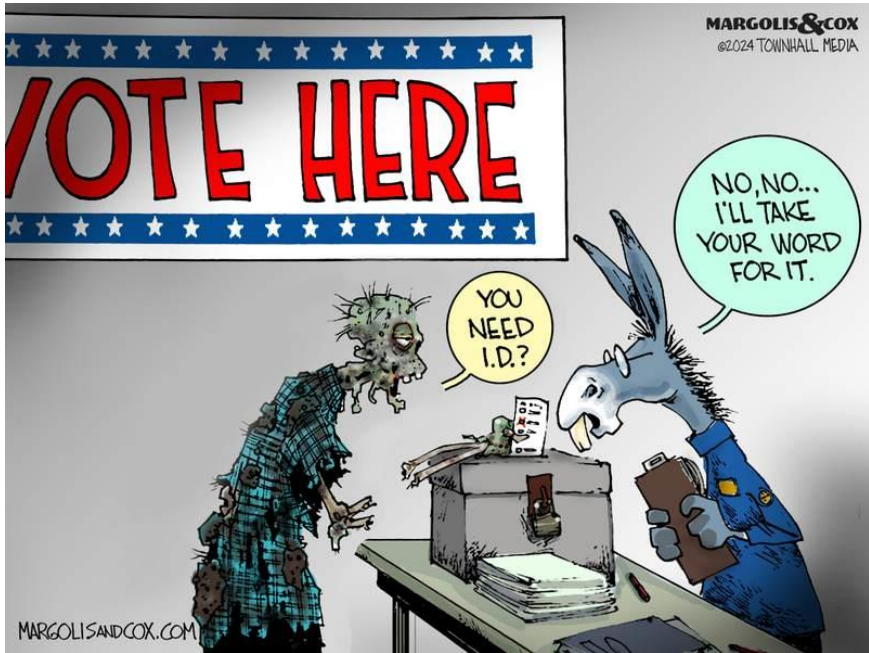
